Principal activities

The company is the parent of a group of companies of which the principal activities are that of construction and operation of solar plants and the generation of solar power.

Statement of directors' responsibilities



1. Accounting policies

1.1 Basis of preparation of financial statements

The financial statements have been prepared on a going concern basis, under the historical cost convention and in accordance with the Financial Reporting Standard for Smaller Entities (effective January 2015) and applicable accounting standards in the United Kingdom. The principal accounting policies, which have been applied consistently throughout the year, are set out below.

1.2 Going concern

The financial statements have been prepared on the going concern basis. The directors have prepared forecasts and reviewed capital requirements for twelve months from the date of approving these financial statements, which indicate the business can continue to trade for at least twelve months.

1.3 Investments

Investments held as fixed assets are shown at cost less provision for impairment.

1.4 Deferred taxation

Deferred tax is recognised in respect of all timing differences that have originated but not reversed at the balance sheet date where transactions or events that result in an obligation to pay more tax in the future or a right to pay less tax in the future have occurred at the balance sheet date. A net deferred tax asset is recognised as recoverable and therefore recognised only when, on the basis of all available evidence, it can be regarded as more likely than not that there will be suitable taxable profits from which the future reversal of the underlying timing differences can be deducted.

Deferred tax is measured at the average tax rates that are expected to apply in the periods in which timing differences are expected to reverse, based on tax rates and laws that have been enacted or substantively enacted by the balance sheet date. Deferred tax is measured on an undiscounted basis.

1.5 Financial instruments

Financial liabilities and equity instruments are classified according to the substance of the contractual arrangements entered into. An equity instrument is any contract that evidences a residual interest in the assets of the entity after deducting all of its financial liabilities.

Where the contractual obligations of the financial instruments (including share capital) are equivalent to a similar debt instrument, those financial instruments are classed as financial liabilities. Financial liabilities are presented as such in the balance sheet. Finance costs and gains or losses relating to financial liabilities are included in the profit and loss account. Finance costs are calculated so as to produce a constant rate of return on the outstanding liability.

Where the contractual terms of share capital do not have any terms meeting the definition of a financial liability then this is classed as an equity instrument. Dividends and distributions relating to equity instruments are debited direct to equity.

1.6 Debtors

Debtors are stated after all known bad debts have been written off and specific provision has been made against all debts considered doubtful of collection.

11. Related party transactions

During the year ended 30 June 2016, the company was charged £nil (2015 - £104,738) and £64,259 (2015 - £1,389,864) in respect of management fees and rechargeable expenses respectively by Lightsource Renewable Energy Holdings Limited, a related party due to its significant influence over the entity. At the year/period end an amount of £nil (2015 - £nil) was outstanding.

During the year/period, the company met expenditure of £412,413 (2015 - £4,623,715) and received revenue of £nil (2015 - £382,478) on behalf of its wholly owned subsidiary, WSE Hullavington Limited. The company also received interest of £259,722. At the year/period end an amount of £5,770,499 (2015 - £5,851,662) was outstanding which is included within debtors.

During the year/period, the company received a loan from Fern Trading Limited. The company was charged £nil (2015 - £66,000) and £nil (2015 - £9,210) in respect of arrangement fees and commitment fees. The company was also charged interest of £84,323 (2015 - £612,220). At the year/period end a total of £nil (2015 - £8,202,379) was outstanding which is included within creditors.

During the year/period, the company received a loan from Viners Energy Limited. Viners Energy Limited met expenditure of £3,252 (2015 - £nil) on behalf of the company. The company was also charged interest of £357,951 (2015 - £nil). At the year/period end, a total of £8,132,181 (2015 - £nil) was outstanding which is included within creditors.

12. Ultimate parent undertaking and controlling party

During the year 100% of the shareholding in WSE Hullavington Holdings Limited (formerly Lightsource SPV 43 Limited) was purchased by Elios Energy Limited, and subsequently sold to Viners Energy Limited.

The immediate parent undertaking is Viners Energy Limited. The ultimate parent undertaking and controlling party is Fern Trading Limited, a company incorporated in England and Wales.
