

# REPORT OF THE TRUSTEES FOR THE YEAR ENDED 31 MARCH 2020



The trustees who are also directors of the charity for the purposes of the Companies Act, present their report and the financial statements for the year ended 31 March 2020 which are also prepared to meet the requirements for a directors' report and accounts for Companies Act purposes.

The financial statements comply with the Charities Act 2011, the Companies Act 2006, the Memorandum and Articles of Association, and in accordance with the Statement of Recommended Practice: Accounting and Reporting by Charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) issued in October 2019 and the Financial Reporting Standard applicable in the United Kingdom and Republic of Ireland (FRS 102) and UK Generally Accepted Practice as it applies from 1 January 2019.

For the purposes of this report and accounts, references to "Shubbak" refer to this charity.

#### Chair's report

Shubbak 2019 was a major milestone in the festival's history. Our festival significantly increased in size, reach and programme. Over 150 artists were presented in over 60 events, reaching an audience of over 56,000 people. In addition, we significantly developed our programme of networking, contextual and professional development opportunities through our Professional Programme.

Our media campaign attracted over 110 pieces of coverage. Our audience was more diverse than ever, with an increasing segment of 20% of Arab audiences. Satisfaction levels were very high with 93% rating the festival as excellent or good.

Shubbak was awarded the UNESCO Sharjah Prize of Arab Culture in May 2019.

On an organisational level we developed our staff team further and worked with a number of freelance consultants.

During the last month of the accounting year the Covid-19 pandemic and subsequent government restrictions on social distancing, travel and working conditions resulted in a number of cancellations and postponements of plans and activities, which will affect the charity in the following year.

#### Our purpose and activities

The purpose (object) of the charity is:

• To advance the education of the public in Arab culture and other aspects of Arabic arts, culture and heritage through public performances and discussions

The trustees confirm that they have complied with the duty in section 17 of the Charities Act 2011 to have due regard to the public benefit guidance published by the Commission. In shaping our objectives for the year and in planning our activities, the trustees have considered the Charity Commission's guidance on public benefit, including the guidance on public benefit and fee charging. Shubbak works in partnership with arts institutions across London, and in setting the level of fees, charges and concessions, the trustees give careful consideration to the accessibility to events for those on low incomes. We also ensured a wide range of free events were held in order to have the broadest level of access possible.

The vision that shapes our annual activities is the promotion and fostering of knowledge and the appreciation of the arts, in particular those produced by artists in or from the Arab world through the provision of events for the education and recreation of the public in the fields of visual arts, literature, music, drama and dance.

The strategies employed to achieve the charity's aims and objectives are:

- to stage a large-scale two-week festival that offers London, UK and international audiences the chance to discover and enjoy some of the most exciting voices and practitioners of contemporary Arab culture, in partnership with leading cultural organisations in London, the UK and the Arab region.
- to increase understanding of contemporary Arab issues through culture, and encourage discussion, international partnerships and exchange of ideas.
- to celebrate the contribution of the Arab community in London and engage with them as creators and audiences.
- to recognise the enduring relationship between London and the Arab world.

Putting these strategies into action we have one major area of activity every two years, this is the Shubbak festival. Our programme of activities also focuses on audience development and accessibility, bringing the arts to the widest possible community in London and in the UK, in line with our current business plan.

#### **Achievements and performance**

The 2019 Festival Artistic Programme consisted of:

#### **PERFORMANCE**

We presented **Mohamed Toukabri's** *The Upside Down Man* at Purcell Room. Mohamed then re-joined Shubbak in the 2<sup>nd</sup> week as one of the artists of the Young Artists Gathering programme.

*X-Adra* by **Ramzy Choucair** at Battersea Arts centre was an unflinching verbatim piece with 6 former prisoners in Syria's notorious Adra prison.

Ali Chahrour's May He Rise and Smell the Fragrance at Lilian Baylis Theatre was uniquely positioned between performance, ritual and concert.

Halka by Groupe Acrobatique de Tanger was a wonderful success with audiences in Poole, Salford and in London. The seemingly never-ending series of cartwheels, balancing, human towers and backflips come fast and furious, interspersed by lovely and cheeky moments of infectious humour.

Chronicles of Majnun Layla was our main theatre / literature commission. Amer Hiehel and his musical collaborators Rihab Azar and Kareem Samara created a simple, but intense rendering of Qassim Haddad's masterwork.

Mette Loulou von Kohl and Dima Matta shared a night to present two aspects of new queer writing from New York and Beirut.

Yara Boustany brought the family-friendly *Évolvō* and *One Day & One Night in Beirut* to The Gate as well as touring to Liverpool and Salford.

Hanane Hajj Ali showed her personal project *Jogging*, which she has performed more than 100 times in Lebanon and explores seminal moments in Lebanon's history and their direct impact of women's lives.

Under A Low Sky by Wael Ali was our commission with our Creative Europe-funded network partners Performances Beyond Two Shores.

**Enkidu Khaled's** hybrid workshop / performance *Working Method* drew its inspiration from a shattering moment in his autobiography in Baghdad.

Six **Playreadings** were a successful addition to the performance programme and offered a coherent snapshot of current playwriting creativity, ranging from narrative drama, to documentary theatre, surrealist theatre.

Youness Atbane adapted his seminal work *The Second Copy 2045* for the surroundings of the Albukhary Foundation Gallery of the Islamic World in the British Museum.

Post-festival we co-presented the commission of **Tanya El Khoury's** *The Search of Power* with Fierce Festival in Birmingham.

#### **VISUAL ARTS**

#### Brick-lab: Geographical Child's Play

The Saudi design duo Abdulrahman & Turki Gazzaz created a playful structure, nicely positioned between sculpture, furniture and play equipment. The work visited Art at the Lake in Milton Keynes, British Museum, British Library and National Theatre.

Aicha El Beloui - Movements: Aicha El Beloui created an imaginative map of the migration routes between Morocco and London. We created three versions: The exhibition version travelled to British Library, National Theatre and British Museum; a site-specific installation remained for a few days in Milton Road in North Kensington and 1000 copies of a free paper hand-out, which we distributed to audiences, community groups and partners.

**Mehdi Annassi:** At 30m wide and 9m high, this is Shubbak's largest commission to-date. Spanning the underneath of the Westway flyover and opposite a new community centre, Mehdi conceived a striking image in strong, saturated colours.

**Hela Ammar – Becoming:** Spread across 12 locations across Shepherd's Bush market, *Belonging* showed portraits and sound from nine women, interviewed by the artists and telling experiences of recent arrivals in London. The images were subtly inserted into the fabric of the market, pasted on shutters of boarded up shops, unto the side-door of one of the stalls or onto an electricity box.

Hicham Berrada: This was young France-based Moroccan artist's first institutional show in the UK at Hayward Gallery Project Space.

**Belonging, Sideways:** We invited emerging Algerian curator Toufik Douioub to present a group show of five Algerian artists.

Nasser Al Salem - Amma Baad: A beautiful, minimal and conceptually rich exhibition by one of Saudi Arabia's emerging talents, curated by Maya El Khalil at Delfina Foundation.

Raw Queens – Fatima Mazmouz & Meriem Bennani: Curated by Yasmina Naji at Mosaic Rooms, this two-artist show offered a surprising, irreverent and humorous take on issues of feminism and folkloristic readings of identity in Morocco.

Syria and Yemen: Making Art Today: The British Museum-curated symposium and film screenings focussed on the two countries whose current experience of war make it so difficult to understand where and how cultural production takes place.

#### MUSIC:

Kahareb: Sama', Shkoon, Nuri, Anahita Shamsaei, Saliah Bryan: Kahareb was billed as the festival opening party with a range of the newest generation of Arab electronica and DJ.

Cosmic Analog Ensemble and Ernesto Chahoud: A capacity audience turned up at Camden Assembly for a night of progressive music from Lebanon.

Luminiscencia – Amir El Saffar Ensemble: Amir El Saffar brought together a virtuosic group of four musicians plus the flamenco dancer Vanessa Aibar to create a 60 minute suite of continuous, intensely played and mesmerising music.

#### The Trace of the Butterfly - A Tribute to Rim Banna

Tania Saleh, Faraj Suleiman, Bu Kolthoum, Sabrine Jenhani: Billed as a special tribute concert to the late Palestinian singer, songwriter and composer, the concert brought together a group of key musicians whose work has been influenced by Rim Banna.

Mo Khansa & Kabareh Cheikhats: This double bill brought radical, genre-bending performance from Lebanon and Morocco for the first time to London.

#### LITERATURE AND SPOKEN WORD

#### Tongue Fu: Amerah Saleh, Claudine Toutoungi, Farah Chamma, Samira Saleh

Tongue Fu broadened our literature strand to include more live and performative events. Three UK-based artists (Amerah Saleh, Farah Chamma, Claudine Toutoungi) shared the stage with Brussels-based Samira Saleh.

Shubbak @ British Library: We offered a tightly curated day with multiple panels: The first session *The Endless Wave – New Feminist Writing* presented powerful narratives of Saudi author Badriah al Beshr and Egyptian writer Deena Mohamed. Malu Halasa spoke about her *novel Mother of All Pigs* and gave insight into the complexities of identity and researching autobiographical material. *Bold Voices – New Queer Writing* brought together Dima Mikhael Matta, Joseph Kai and Khaled Alesmael. Dima Wannous spoke about her novel *The Frightened Ones*, also exploring biographical details and the need to tackle topics head-on which had been taboo prior to the Syrian revolution. Bakhtiyar Ali introduced his oeuvre and position as a Iraqi Kurdish author and the power of translation. The final session *Telling The Past* explored different approaches to writing historical novels with Inaaam Kachachi, Ruqaya Izzedien, Hammour Ziada and Rabai al-Madhoun

#### FILM

This year all films were presented in the Barbican cinemas with eight screenings and one panel discussion across four days. Curated by Elhum Shakerifar along themes of generational conflicts and differences, the films included:

- Sofia by Meryem Benim'Barek-Aloïsi (Morocco)
- Panoptic by Rana Eid (Lebanon)
- Of Sheep And Men by Karim Sayyad (Algeria)
- The Man Behind The Microphone by Claire Belhassine (Tunisia)
- The Blessed by Sofia Djama (Algeria)
- Erased...Ascent Of The Invisible by Ghassan Halwani (Lebanon)
- The Reports On Sarah And Salem by Muayad Alayan (Palestine)
- Arab-British Shorts with films by Saeed Taki Farouky, Ashtar Al Kirsan, Amrou Al Kadhi, Lara Zeidan and Basil Khalil

The season was further enhanced by the month-long screening on MUBI of Claire Belhassine's *The Man Behind The Microphone* and a free music play list, curated by Rana Eid and playing throughout the foyer and café of the Barbican cinemas.

SHUBBAK @ NATIONAL THEATRE RIVER STAGE: The weekend on the River Stage was this year's free and accessible outdoor offer. We present in total 19 programming slots, including 7 music concerts, 3 DJ sessions, 1 comedy hour with 4 comedians, 3 spoken word slots and 2 community groups, plus three interactive arts installations. Our main commission for the event was Dia Batal's 'Articles' a thoughtful, yet engaging installation of calligraphic words and letters, based on the universal declaration of human rights. Amira Kheir and Hadi Zeidan shared the stage, as they did at the Institut du Cultures D'Islam in Paris the previous week as part of our Paris / London exchange. Newcomers Ebsiljaz and Noor Palette were presented as new talent alongside Juliana Yazbeck.

#### THE PROFESSIONAL PROGRAMME

We significantly expanded our professional programme this year. This consisted of:

- Young Artists Gathering 6 artists funded through our Creative Europe partnership to spend a week at the festival
- Professional visits, which enabled us to bring a number of professional artists and managers from the Arab region to witness and engage with the festival
- Four round-table talks
- Informal support for international professional visitors.

#### **Promoters Visits:**

We had a strong showing of international promoters at the festival, with some coming for several days, others to see specific works or performances. Programmers included representatives from Institut du Monde Arab (Paris), NYU Abu Dhabi, Theater Graz (Austria), AsiaNow (Korea), Theatre de la Ville (Paris), Bozar (Brussels), Arabesques Festival (Montpellier) as well as national programmers.

#### **COMMUNITY Participation & Engagement**

Participation & Engagement ranged from international residencies to locally-driven weekly workshops:

#### Mehdi Annassi's Collaborative Mural

Mehdi guided eight local artists from North Kensington in the creation of a large-scale neighbourhood mural on St. Mark's Road. The first residency period in Autumn 2018 comprised of successfully delivering workshops to 44 young people involved and/or interested in street art and comics. They were across London and spanned Central, East, and West. The week also involved Moroccan oral history archival research, interviews with Moroccan community leaders, and meetings with some of London's most successful street artists and comics publishers.

#### 10 to 10 by Hassan Al-Mousaoy

Between February - June 2019, Hassan delivered photography workshops to ninety-four recently arrived children and young people (ages 15 - 19) from migrant, refugee, and asylum-seeking backgrounds. We partnered with British Red Cross - Hammersmith, Young Roots Barnet, and Barnet Refugee Services in delivering a set of six sessions each culminating in a group exhibition in the Attic of the Bush Theatre. The twenty-six collaborators who took part in the final exhibition were predominantly male from Sudan, Iraq, Syria, Afghanistan, Eritrea, Ethiopia & various other non-Arab countries.

#### Movements by Aicha El Beloui

For the first part of her residency with us, Aicha delivered illustration workshops to 33 young people across Central, East, and West London. She created lasting bonds with North Kensington charities including Making Communities Work and Grow, SK Youth Families, Al Hasaniya Moroccan Women's Centre, and FerArts.

#### **Festival Workshops**

We had a number of one-off workshops led by performers and visual artists, inc: Hanane Hajj Ali with students and emerging theatre artists, Aicha El Beloui in a family workshop at the Museum of London, Yara Boustany's creative storytelling through movement for ages 5+, a Family Day at the Mosaic Rooms led by storyteller Elias Matar and visual artist Dia Batal and circus workshops at the Roundhouse, London; Manchester and Poole.

#### **ASSISTED TICKET SCHEME:**

Over 500 free tickets from our Assisted Ticket Scheme were offered to refugee and migrant-support charities, West-London based community groups, festival volunteers, and recently arrived individuals from low-income backgrounds. All of the attendees were first-timers to Shubbak. They included members of the Shepherd's Bush Families Project, Barnet Refugee Services, Refugee Action Kingston, Young Roots Barnet, Supporting Kensington Youth & Families, Al Hasaniya Moroccan Women's Centre, FerArts, Salusbury World, Scheherazade Initiatives, British Red Cross – Hammersmith, Single Homeless Project

Post-festival we delivered a series of short residencies and workshops for young people and community groups in West London with a number of international artists. We also initiated Young Shubbak, a new group of 18-24 year olds, who have been supported in gaining curatorial and arts management skills.

#### **TOURING**

In line with our business plan we significantly increased our national presence and some parts of Shubbak's programme toured across the country. Touring included performances and events at Dance East, Ipswich; Pavilion Dance, Bournemouth; Lowry, Salford; Lighthouse Poole; Liverpool Arab Arts Festival, Bradford Literature Festival and Cambridge Junction.

#### Visits to international partners

Throughout 2019 Shubbak continued to research our programme internationally and visited key events including Kunstenfestivaldesarts, Brussels; Napoli Teatro Festival; Col'jam Dance Festival, Casablanca; 21,39 Art Week, Jeddah, NYU AbuDhabi; Qatar Public Art Forum.

#### UK partners

Shubbak expanded its network of partners in the UK and worked on its festival programme with Bradford Literature Festival, Crying Out Loud, Literature Across Frontiers, Outburst Festival (Belfast), Ahbab Festival (Cambridge), Oxford University, The Lowry, Lighthouse Poole, Pavilion Dance (Bournemouth), Dance East (Ipswich), Africa Speaks (London), Encounters Film Festival (Bristol), Milton Keynes Art in the Park, National Theatre (London), Liverpool Arab Arts Festival.

In London partnerships included Hayward Gallery, British Museum, Delfina Foundation, The Gate Theatre, Bush Theatre, Sadler's Wells, Southbank Centre, Barbican Centre, British Library, Richmix, Camden Assembly and many others.

#### **TEAM AND MANAGEMENT**

We had an expert team to deliver this year's festival. Axel Satge and Yasmeen El Khoudary joined as producers in March and April, with Vyv Abla joining at the end of May, and Nadine Lotayef for a month from mid-June.

Projects were delegated across the team with clear reporting mechanism. The team was highly motivated and worked extremely well with each other.

The executive director Daniel Gorman left the organisation in August 2019, and was succeeded by Fares Moussa.

We had a total of 33 volunteers working with us. Volunteers were mainly drawn from students and young professionals, mostly from Arab or dual backgrounds.

Shubbak continued to have its office in the Arab British Centre.

#### **Financial Viability**

2019 saw a significant increase in our budgets and we achieved a significant number of new funders. These include:

- Operational Alliance and festival funding from British Council
- Bagri Foundation
- Qatar Foundation International
- Drosos
- Amal (A Said Foundation initiative)
- Paul Hamlyn Foundation

The trustees have set up a designated fund to meet any exceptional costs or circumstances. The trustees aim to increase this fund by £2,500 per year. The fund balance at 31 March 2020 was £17,500.

#### **Governing Document**

The charity is also known by the name of Shubbak and is a company limited by guarantee having been incorporated on 27 February 2012; and registered as a charity on 7 January 2013. It is governed by its Memorandum and Articles of Association which established the objects and powers of the charitable company. In the event that the charity is dissolved, each member will contribute up to £1 towards the cost of dissolution and the liabilities incurred by the Charity.

#### Recruitment and appointment of trustees

As set out in the Articles of Association, the member(s) may propose and appoint any willing person to act as a trustee for the Charity. When considering a nominated trustee, the charity will take into account the skills of existing trustees, of the proposed trustee and the skills required by the charity. The trustees are also the directors of the company. The number of trustees should be a least three and not more than twelve.

Each trustee must retire from office at the third Annual General Meeting following the commencement of their term of office. Retiring trustees may be reappointed, but a trustee who has served two consecutive terms of office must take a break from office and may not be appointed until the earlier of

- the anniversary of the commencement of their break from office; and
- the Annual General Meeting following the Annual General Meeting at which their break from office commenced.

If the retirement of a trustee causes the number of trustees to fall below three, the retiring trustee shall remain in office until a new appointment is made.

#### Trustee induction and training

New trustees will be made familiar with the objectives, business plan and financial status of the charity. Trustees will also be given a copy of the relevant guidance material from the Charity Commission.

#### **Risk Management**

An annual risk review is undertaken by the trustees. The Trustees examine the major strategic, business and operational risks which the charity faces and will put in place systems to mitigate these risks.

#### Financial Review

The annual accounts show total income received for the year, excluding donated services, of £756,466 (2019: £252,872).

Expenditure for the year, excluding donated services, amounted to £678,053 (2019: £199,610) and was primarily spent on developing the 2019 festival and community engagement projects which focused on achieving our charitable objective.

#### **Reserves Policy**

The Trustees have reviewed the charity's needs for reserves in line with the guidance issued by the Charity Commission.

Shubbak's policy is to hold reserves that enable the organisation to:

- ensure there is sufficient money to continue our core activities during a period of unforeseen difficulty including potential closure;
- undertake special projects which significantly develop the organisation's sustainability;
- undertake special and exceptional artistic projects and one-off activities, which significantly enhance Shubbak's position, as proposed by the artistic director.

The Trustees have examined the requirement for designated funds to cover the remaining committed operational activities from income for three months. Based on current financial forecasts (budget revision 8 June 2020), this requirement is £48,000.

Decisions about any expenditure of the designated fund have to be taken by the trustees at a board meeting. The Chief Executive Officer and the Artistic Director will need to present a proposal to the board for any expenditure.

This policy will be reviewed by the Trustees on an annual basis as part of the charity's budgeting processes.

#### Plans for the future

Shubbak is working towards another festival in 2021. This will be our 10th Anniversary. We are working on developing further partnerships both in the UK and the Arab World. Simultaneously, we are looking to further broaden our support, and as such are in discussion about Shubbak with both potential individual patrons and institutional funders.

The board is assessing the risks of the Covid-19 pandemic and the likely effect on audiences through social distancing measures, implications from anticipated reduction in resources from our funders, restrictions in international travel, and sustainability of our partner venues and organisations.

We continue to strengthen our links with the community, our patrons and customers through on-going meetings and involvement in Shubbak programming.

# NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 31 MARCH 2020

#### 1 Accounting policies

#### 1.1 Basis of preparation

The Financial Statements have been prepared in accordance with the Statement of Recommended Practice: Accounting and Reporting by Charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) issued in October 2019 and the Financial Reporting Standard applicable in the United Kingdom and Republic of Ireland (FRS 102) and the Charities Act 2011 and UK Generally Accepted Practice as it applies from 1 January 2019 and the Companies Act 2006.

The financial statements have been prepared under the historical cost convention with items recognised at cost or transaction value unless otherwise stated.

#### 1.2 Fund accounting

Unrestricted income funds represent those resources which may be used towards meeting any of the charitable objects of Shubbak at the discretion of the trustees.

Designated funds comprise unrestricted funds that have been set aside by the trustees for particular purposes. The aim and use of each designated fund is set out in the notes to the financial statements.

Restricted funds are resources which are to be applied to specific purposes imposed by the funder/donor

#### 1.3 Income recognition

Items of income are recognised and included in the accounts when all of the following criteria are met:

- The charity is legally entitled to the funds;
- any performance conditions attached to the item(s) of income have been met or are fully within the control of the charity:
- there is sufficient certainty that receipt of the income is considered probable; and
- the amount can be measured reliably.

#### 1.4 Expenditure recognition

Resources expended are included in the Statement of Financial Activities on an accruals basis, inclusive of any VAT which cannot be recovered. Expenditure directly attributable to any specific activities has been included in these cost activities. Where costs are attributable to more than one activity they have been apportioned across categories on a basis consistent with the use of these resources.

#### 2 Staff costs

The company had an average of 3 employees during the year ended 31 March 2020 (2019: 3 employees).

#### 3 Trustees' remuneration and expenses

During the year, a trustee, Josephine Glanville, was paid £100 for chairing a discussion as part of the company's literature programme furing the festival. This task was carried out in her freelance capacity as a writer and journalist. No other trustees received any remuneration during the two years ended 31 March 2020. No trustees were reimbursed for expenses during the two years ended 31 March 2020.
