- We refreshed our web portal and added more training courses, the site still allows people to register their very own website with access to premium services for free

We have consulted with our 'online' community and a number of local community groups. Each group has had a significant impact on the direction of our projects, ensuring we only develop new projects against actual need. Our annual consultation with our online community enables us to set objectives and targets for the year ahead. This is an online questionnaire asking our beneficiaries to offer feedback on the services they accessed and on what they would like going forward.

We got feedback from 112 of our stakeholders in mid-2021, this set our focus on areas that our stakeholders showed the most interest in, namely the provision of online based webinars for more advanced WordPress subjects.


