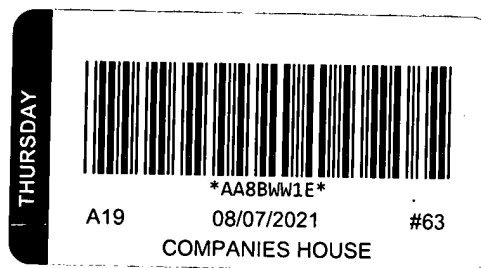



For the period ended 31 December 2020 the Company was entitled to exemption from audit under s. 480 of the Companies Act relating to dormant companies.


**Directors' responsibilities:**
