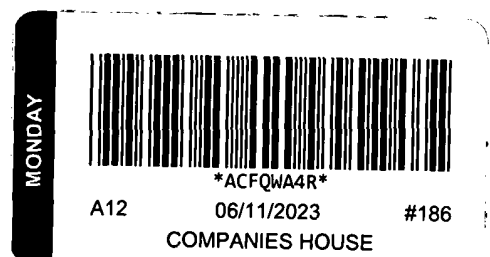

REPORT OF THE DIRECTORS **FOR THE YEAR ENDED 31ST MARCH 2023**

The directors present their report with the financial statements of the company for the year ended 31st March 2023.

REVIEW OF BUSINESS

Throughout 2022/23 Marble Arch Partnership continued to provide services to members, with the BID welcoming many new businesses following the completion of Marble Arch Place.

Promoting the district was stepped up in 2022 with the launch of our first Culture Trail, showcasing the area's heritage, public art and architectural assets. This was followed early in 2023 by the Marble Arch Loyalty Scheme, featuring offers from our members for people who live and work in Marble Arch. These were complemented by the BID's regular food tours, online eating out guide and annual Christmas lights the length of Edgware Road.

As the whole nation celebrated Her Majesty The Queen's Platinum Jubilee in summer 2022, the BID partnered with the National Portrait Gallery and English Heritage to project portraits of Her Majesty onto Marble Arch, while joining forces with local schools and communities in street parties.

The BID's popular community programme brought together over 230 volunteers who gave almost 700 hours of their time and skills to diverse community projects, working on environmental activities, engaging with young and older people, and giving fresh coats of paint to schools and children's centres.

Our Street Team remain one of the BID's greatest assets, providing a visible presence and reassurance to our members, visitors and also local residents. Patrolling the district six days a week, the Street Team tackle organised begging, support members with reports of shoplifting and distraction thefts, assist emergency services and perform welfare checks and referrals for rough sleepers.

The BID issued 45 real-time security bulletins to members, alerting them to planned protests, marches and disruptions. Three community safety events were held, including two cycle security marking days open to the public, plus four specialist security-themed sessions for members on human trafficking, phone snatches, violence against women and girls, and emerging legislation on Protect Duty (Martyn's Law).

Following our night audit last year identifying parts of the district needing additional lighting, we successfully lobbied Westminster Council and Transport for London to upgrade lighting levels and open up the LU compound on Chapel Street, and to install new lighting on Norfolk Crescent.

Our training series grew in popularity, with new titles added. Over 100 people from 35 member companies attended the BID's training courses in 2022/23.

The BID levy collection rate for 2022/23 was 95% at 31 March 2023. Unpaid BID levy covering the period 1 April 2016 to 31 March 2023 is in the sum of £184,033. Of this total £127,527 is considered unlikely to be collected as it mostly relates to businesses entering administration. It has therefore been included as a bad debt provision.

In instances where backdated levy arises from businesses occupying newly rated properties and the effective date falls in previous accounting years, the backdated levy is accounted for in the year in which levy bills are issued.

STATEMENT OF DIRECTORS' RESPONSIBILITIES

STATEMENT AS TO DISCLOSURE OF INFORMATION TO AUDITORS



REPORT OF THE INDEPENDENT AUDITORS TO THE MEMBERS OF
MARBLE ARCH PARTNERSHIP LIMITED

Opinion

We have audited the financial statements of Marble Arch Partnership Limited (the 'company') for the year ended 31st March 2023 which comprise the Income Statement, Balance Sheet and Notes to the Financial Statements, including a summary of significant accounting policies. The financial reporting framework that has been applied in their preparation is applicable law and United Kingdom Accounting Standards, including Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland' (United Kingdom Generally Accepted Accounting Practice).

In our opinion the financial statements:

- give a true and fair view of the state of the company's affairs as at 31st March 2023 and of its surplus for the year then ended;
- have been properly prepared in accordance with United Kingdom Generally Accepted Accounting Practice; and
- have been prepared in accordance with the requirements of the Companies Act 2006.

Basis for opinion

We conducted our audit in accordance with International Standards on Auditing (UK) (ISAs (UK)) and applicable law. Our responsibilities under those standards are further described in the Auditors' responsibilities for the audit of the financial statements section of our report. We are independent of the company in accordance with the ethical requirements that are relevant to our audit of the financial statements in the UK, including the FRC's Ethical Standard, and we have fulfilled our other ethical responsibilities in accordance with these requirements. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

Matters on which we are required to report by exception

In the light of the knowledge and understanding of the company and its environment obtained in the course of the audit, we have not identified material misstatements in the Report of the Directors.

We have nothing to report in respect of the following matters where the Companies Act 2006 requires us to report to you if, in our opinion:

- adequate accounting records have not been kept, or returns adequate for our audit have not been received from branches not visited by us; or
- the financial statements are not in agreement with the accounting records and returns; or
- certain disclosures of directors' remuneration specified by law are not made; or

In preparing the financial statements, the directors are responsible for assessing the company's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless the directors either intend to liquidate the company or to cease operations, or have no realistic alternative but to do so.

Auditors' responsibilities for the audit of the financial statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue a Report of the Auditors that includes our opinion. Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with ISAs (UK) will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these financial statements.

The extent to which our procedures are capable of detecting irregularities, including fraud is detailed below:

Discussions were held with and enquiries made of, management and those charged with governance with a view to identifying those laws and regulations that could be expected to have a material impact on the financial statements. During the engagement team briefing the outcomes of these enquiries were discussed, as well as consideration as to where and how fraud may occur in the entity.

It was agreed the laws and regulations considered to have a direct effect on the financial statements include Financial Reporting Standards, company law and UK tax legislation. It is considered that there are no laws and regulations for which non-compliance may be fundamental to the operating aspects of the business.

Audit procedures undertaken in response to the potential risks relating to irregularities (which include fraud and non-compliance with laws and regulations) comprised of: inquiries of management and those charged with governance as to whether the entity complies with such laws and regulations; enquiries with the same concerning any actual or potential litigation or claims; inspection of relevant legal correspondence; review of board minutes; testing the appropriateness of entries in the nominal ledger, including journal entries; reviewing transactions around the end of the reporting period; and the performance of analytical procedures to identify unexpected movements in account balances which may be indicative of fraud.

No instances of material non-compliance were identified. However, the likelihood of detecting irregularities, including fraud, is limited by the inherent difficulty in detecting irregularities, the effectiveness of the entity's controls, and the nature, timing and extent of the audit procedures performed. Irregularities that result from fraud might be inherently more difficult to detect than irregularities that result from error. As explained above, there is an unavoidable risk that material misstatements may not be detected, even though the audit has been planned and performed in accordance with the relevant auditing standards.



1. STATUTORY INFORMATION

Marble Arch Partnership Limited is a private company, limited by guarantee, registered in England and Wales. The company's registered number and registered office address can be found on the Company Information page.

2. ACCOUNTING POLICIES

Basis of preparing the financial statements

These financial statements have been prepared in accordance with Financial Reporting Standard 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland" including the provisions of Section 1A "Small Entities" and the Companies Act 2006. The financial statements have been prepared under the historical cost convention.

Turnover

Turnover represents BID levy raised together with other related income, excluding value added tax.

Turnover in respect of the BID levy is recognised once the levy bill has been raised and is payable by the rate payer.

Tangible fixed assets

Depreciation is provided at the following annual rates in order to write off each asset over its estimated useful life.

Short leasehold	- over period of lease
Improvements to property	- over period of lease
Fixtures and fittings	- 33.33% straight line
Computer equipment	- 33.33% straight line

Tangible fixed assets are measured at cost less accumulated depreciation and any accumulated impairment losses.

The assets' residual values, useful lives and depreciation methods are reviewed, and adjusted prospectively if appropriate, or if there is an indication of a significant change since the last reporting date.

Financial instruments

The company only enters into basic financial instruments transactions that result in the recognition of financial assets and liabilities like trade debtors, trade creditors, other debtors and other creditors.

The basic financial instruments are initially recognised at transaction price and subsequently carried at amortised cost.

Pension costs and other post-retirement benefits

The company operates a defined contribution pension scheme. Contributions payable to the company's pension scheme are charged to profit or loss in the period to which they relate.

The average number of employees during the year was 3 (2022 - 3).
