Structure, governance and management

The organisation is a charitable company limited by guarantee, incorporated on 29th August 2012 and registered as a charity on 18th February 2013

The charitable company was established under a Memorandum of Association which sets out the objects and powers of the company and is governed under its Articles of Association

In the event of the company being wound up members are required to contribute an amount not exceeding £1

The directors of the company are also charity trustees for the purposes of charity law

Under the provisions of the Articles any person who is willing to act as a Trustee, and who would not be disqualified from acting under the provisions of the Articles, may be appointed to be a Trustee by a decision of the Trustees

A protocol is under development to assist with the induction and training of new Trustees

The charitable company is supported in its objectives by The Institute for Cultural Research (registered charity number 313295) Claire Maxwell-Hudson, Gill Whitworth, Tahir Shah and Safia Shah are members of the Governing Council of The Institute for Cultural Research

Objectives and activities

The aims of the charitable company, as set out in the Articles of Association are -

- the advancement of education for the public benefit and in particular (but not limited to) the study of and dissemination of knowledge about Sufi culture, Sufi heritage and Sufi literature
- and the promotion of the arts, culture and heritage for the public benefit with particular (but not limited to) reference to classical and contemporary Sufi arts, literature and culture

In pursuance of these aims and as an initial step, the Trustees have set up a website for the charity in which the works of Idries Shah and works by other contemporary and classical Sufi authors will be available to the general public

To date, over twenty works by Idnes Shah have been made available to read for free online in English via this site.

The Idries Shah Foundation has begun a programme of translations of the works of Idries Shah and other Sufi authors into five languages. Spanish, Arabic, Persian, Urdu and Pushtu

It is working to develop sister websites in each of these languages in which translations of Sufi works will be freely available

It is hoped that these materials, which originated in the Middle East, will be a force for moderation and clear-thinking and a counter to fanaticism, particularly in the Islamic world

The Idries Shah Foundation is also beginning work on a series of books aimed at children based on Sufi teaching stories, designed to impart life and learning skills and clear-thinking

It is envisaged that a website aimed at children, schools and young people will also be developed for the promotion of these materials

The trustees confirm that they have referred to the guidance contained in the Charity Commission's general guidance on public benefit when reviewing the charities aims and objectives and when planning future activities

The charity was registered with the Charity Commission as of 18 February 2013 and had not undertaken any charitable activities in the period to 31 March 2013

1 Accounting policies

1.1 Basis of preparation
