We concluded a large intergenerational heritage project, working with young people in Southwark to record interviews with older people about their memories of the 1980s. We collected 24 Oral histories from older residents & the young people wrote and shot a short film "I am Michael" based on the events leading up to the 1985 Brixton riots. The project has promoted intergenerational cooperation, raised awareness of the issues facing the community & trained the young people in film making skills. The film was premiered at Peckhamplex cinema in February & distributed via social media, gathering over 15,000 views.

Working with DAISI in Devon, we recorded a short film about Soundwaves, a music project aimed at disadvantaged young people. The film will promote the work of DAISI.

We made a short film with the TNG youth centre in Lewisham, on the subject of knife crime, supported by BBC Children in Need. This work was targeted at young people at risk of gang violence, raises awareness of the issue of knife crime, provided diversionary activities during the school holiday & trained the young people in film making skills.

We have been running a young peoples' film making group in Alnwick, Northumberland, to devise and create a film on the subject of Anti Social Behaviour. The finished film has been used as a resource to stimulate discussion about ASB, and the young people have been trained in film making.

We have begun an intergenerational heritage film project in Newcastle and Northumberland recording oral histories about the social impact of deindustrialisation in the 1980s. The project is funded by the Heritage Lottery fund &is delivered in partnership with Northern Stage and Museums Nothumberland.
