We made a short films with the TNG youth centre in Lewisham on the subject of peer pressure and gangs, supported by BBC Children in Need. This work was targeted at young people at risk of gang violence, raised awareness of issues around crime, provided diversionary activities during the school holiday & trained the young people in film making skills. We were about to enter the second year of a three year project, but had to pause due to coronavirus.

We concluded running a young peoples' film making group in Alnwick, Northumberland, to devise and create short films about mental health, supported by the national lottery community fund.

During Lockdown we received funding from CCSF to run a further group in Alnwick to explore young peoples' responses to coronavirus.

We began a project about the 50th Anniversary of Northern stage. The project was funded by the Heritage Lottery fund & delivered in partnership with Northern Stage and Newcastle University. The project was paused due to coronavirus.

We ran an online film festival, including a Q&A with the participants. We also brought together different groups of young people that we have worked with to talk about each others' films & life experiences.

During Black history month we recorded interviews with young people that we have worked with in the past, to talk about the films that they made (going back over 10 years of participants), and to show their films online.

After lockdown we consulted with the group to ask if they would like to do an online fil project. They did not, but they did participate in the online film festival.

We consulted with a group of young people in Alnwick to find out if they'd like to engage in a film project during lockdown, and then worked with them to shape the project to their needs.

The Northern Stage at 50 project has a steering group of participants to inform and shape the project.
