The effect of the proposed capital reduction will be to reduce the Company's issued share capital to one A ordinary share of £1 each and one B Ordinary Share of £1 each AND THAT the above capital reduction shall be accounted for by debiting the total of £419,998 from the Share Capital and crediting the same amount to Cash in the Company's balance sheet for immediate payment directly to the shareholders in the amounts specified in the above resolution
