#### **1. ACCOUNTING POLICIES**

##### **1.1. Basis of preparation of financial statements**

The full financial statements, from which these accounts have been extracted, have been prepared under the historical cost convention and in accordance with the German tax law.

##### **1.2. Cash flow**

The financial statements do not include a cash flow statement because the company, as a small reporting entity, is exempt from the requirement to prepare such a statement under the Financial Reporting Standard for Smaller Entities (effective April 2008).

##### **1.3. Turnover**

Turnover comprises the invoiced value of goods and services supplied by the company, exclusive of Value Added Tax.

##### **1.4. Foreign Currencies**

All figures are reported in Euros.

##### **1.5. Tangible fixed assets and depreciation**
