



The members have not required the Company to obtain an audit of its financial statements for the period in question in accordance with Section 476 of the Companies Act 2006.


These accounts have been prepared in accordance with the provisions applicable to companies subject to the small companies exemption.

1. PRINCIPAL ACCOUNTING POLICIES
