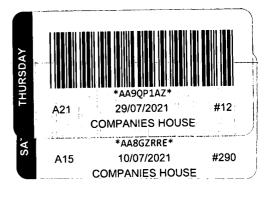

The Calon Cymru Network is a community interest company and consultancy formed for the purpose of sustainable rural regeneration projects along and beyond the Heart of Wales railway line corridor. Our mission is to foster regeneration in accordance with the principles of the Well-being of Future Generations (Wales) Act 2015 and the Environment (Wales) Act 2016. In the period 1 November 2019 – 30 October 2020, our activities were as follows:

Consultations:

We prepared responses to three Welsh and local Government Consultations

- National Development Framework for Wales (November 2019)
- Sustainable Farming and our Land (October 2020)
- Carmarthenshire County Council Local Development Plan (October 2020)

In all three, we highlighted the key issues and changes we felt necessary to move towards a low impact and affordable housing, sustainable land management practices, job creation and the regeneration of rural communities. Adaptation to climate change and measures at community level to confront and mitigate the climate emergency are also important elements in all our discussions.

Other representation/ strategic links

- We met with Carmarthen County Council to discuss and try and resolve some of the issues around reports and monitoring of OPD projects in the county
- We attended Rural Futures for Llandovery (September 2020)
- We organised a meeting with the Bevan Foundation to foster close cooperation between our two organisations

Advisory and consultancy work

• We developed a service to carry out monitoring of OPD projects on behalf of the County Councils.

Communications

- We circulated a newsletter to our members, supporters and wider communities on the Heart of Wales Railway line corridor (September 2019)
- We redesigned and rewrote our website (available in English and in Welsh)
- We prepared one press release, summarising our consultation responses
- We were active on social media (mainly Twitter)
