AND IT IS ORDERED THAT the costs of the petitioner be paid out of the assets of the company

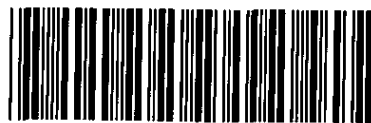
