We have also organised and held two panel meetings for the industry. We have begun to build a network of Associates in order to form partnerships for ongoing gender equality work.

2 In order to be leaders in thought, research and practice for women's equality in tourism, we have focused in the first instance on working with the tourism industry and offering training in gender equality. This has involved considerable networking and meetings. It has enabled Equality in Tourism to understand that shifting consciousness within the industry will be through very small steps.
