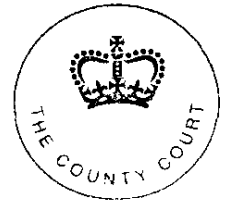

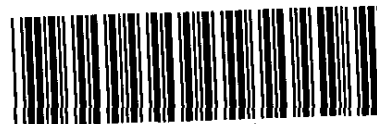


AND the Claimant undertaking to:

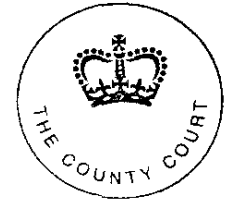
AND UPON the Solicitors for Claimant and the Registrar of Companies (the Defendant) both consenting to this Order
