1 Statutory information

2 Average number of employees

These accounts replace the original accounts for the year ending 31st December 2018.

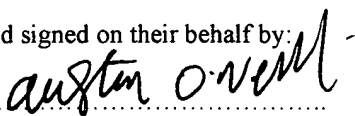
These accounts are now the statutory accounts.
