VAT basis

As the Company is not registered for VAT, any relevant receipts and payments would be shown net of VAT with a separate entry showing the amount of VAT paid.

Realisation of assets

Cash at bank

The cash at bank had an estimated to realise value of £12,500.75 as per the Declaration of Solvency and following the closure of the account, these funds were received in full.

Administrative, statutory and regulatory tasks

The Joint Liquidators have met a considerable number of statutory and regulatory obligations. Whilst many of these tasks have not had a direct benefit in enhancing realisations for the estate, they have assisted in the efficient and compliant progressing of the Liquidation, which has ensured that the Joint Liquidators and their staff have carried out their work to high professional standards.
