

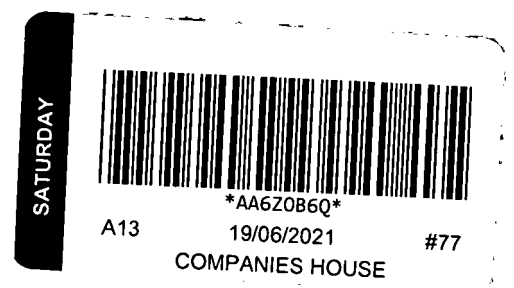



### 1 Statutory Information

Millbrook Park (Mill Hill) Management Company Limited is a private company, limited by guarantee, registered in England and Wales. The Company's registered number and registered office address can be found on the Company Information page.

### 2 Accounting Policies

#### Basis of Preparing the Financial Statements

These financial statements have been prepared in accordance with FRS 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland" ("FRS 102") and the requirements of the Companies Act 2006 as applicable to companies subject to the small companies regime. The disclosure requirements of section 1A of FRS 102 have been applied other than where additional disclosure is required to show a true and fair view.

The financial statements have been prepared under the historical cost convention. The principal accounting policies adopted are set out below.

### 3 Employees

The average monthly number of persons (including Directors) employed by the Company during the year was 3 (2020 - 2).

### 4 Limited by Guarantee

The Company is limited by guarantee and therefore has no share capital. In the event of the Company being wound up each member will undertake to contribute an amount not exceeding £1.
