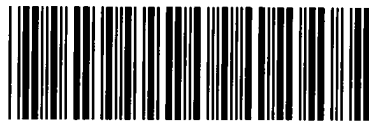

Opinion

We have audited the financial statements of Newincco 1243 Limited (the 'company') for the year ended 31 December 2018 which comprise the balance sheet, statement of changes in equity and notes to the financial statements, including a summary of significant accounting policies. The financial reporting framework that has been applied in their preparation is applicable law and United Kingdom Accounting Standards, including FRS 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland" (United Kingdom Generally Accepted Accounting Practice).

ACCOUNTING POLICIES for the year ended 31 December 2018

COMPANY INFORMATION

Newincco 1243 Limited is a private company, limited by shares, incorporated in England and Wales, registration number 08551829. The registered office is 24 Bruton Place, London, W1J 6NE.

BASIS OF PREPARATION

The financial statements have been prepared in accordance with the provisions of FRS 102 - 'The Financial Reporting Standard applicable in the United Kingdom and Republic of Ireland' ('FRS 102') and with the Companies Act 2006. There were no material departures from that standard. The financial statements have been prepared on the historical cost basis. The financial statements are prepared in sterling and rounded to the nearest £.

The financial statements present information about the company as an individual undertaking and not about its group, as the company has taken advantage of the exemption provided by section 400 of the Companies Act 2006 not to prepare consolidated financial statements as it and its subsidiary undertakings are included by full consolidation in the consolidated financial statements of its ultimate controlling party, London & Associated Properties PLC, a company incorporated in England.

During the current and preceding year the company received no income and incurred no expenditure and therefore no profit and loss account has been presented.

REDUCED DISCLOSURES

In accordance with FRS 102, the Company has taken advantage of the exemptions from the following disclosure requirements:

- Section 7 'Statement of Cash Flows' - Presentation of a Statement of Cash Flow and related notes and disclosures.
- Section 11 'Basic Financial Instruments' and Section 12 'Other Financial Instrument Issues' – Carrying amounts, interest income/expense and net gains/losses for each category of financial instrument; basis of determining fair values; details of collateral, loan defaults or breaches.
- Section 33 'Related party disclosures' – Compensation of the key management personnel.

GOING CONCERN

The directors have prepared and considered trading forecasts and cashflow projections for the period through to July 2020. The company is financed through intercompany loans with other entities within the London & Associated Properties PLC group and the directors have obtained confirmation from those entities that the necessary support will continue to be provided.

Loan balances within the London & Associated Properties PLC group of £28.2m were due for repayment in July 2019. The existing lenders for these loans have agreed to a 3 month extension to 1 October 2019. The company has exchanged on the part-disposal of one of the properties held as security for these facilities and completion is due imminently. Proceeds from the part-disposal will be used towards repayment of the loans of £28.2m. The group has received an offer to refinance the remaining loans, which is at an advanced stage of negotiation.

On that basis, the Directors confirm that they are satisfied that the company has adequate resources and backing to continue in business for the foreseeable future and the financial statements have therefore been prepared on a going concern basis.

DEFERRED TAXATION

Deferred tax is recognised in respect of all timing differences between the recognition of income and expenses in the financial statements and their inclusion in tax assessments.

Unrelieved tax losses and other deferred tax assets are recognised only to the extent that it is probable that they will be recovered against the reversal of deferred tax liabilities or other future taxable profits.

Deferred tax is measured using the tax rates and laws that have been enacted or substantively enacted by the reporting date and that are expected to apply to the reversal of the timing difference, except for revalued land and investment property where the tax rate that applies to the sale of the asset is used.

Deferred tax assets and liabilities are not discounted.

INVESTMENTS

Investments held as fixed assets comprise investments in subsidiaries. Investment in subsidiaries are accounted for at cost less accumulated impairment losses. Investments in subsidiaries are assessed for impairment at each reporting date. Any impairments losses or reversals of impairment losses are recognised immediately in profit or loss.

DIVIDENDS RECEIVABLE

Dividends are credited to the profit and loss account when the dividend is received.

FINANCIAL INSTRUMENTS

Basic financial instruments are recognised at amortised cost with changes recognised in profit and loss account.

Cash and cash equivalents

Cash and cash equivalents in the balance sheet comprise cash at banks and in hand and short term deposits with an original maturity date of three months or less.

Short-term debtors and creditors

Debtors and creditors with no stated interest rate and receivable or payable within one year are recorded at transaction price. Any losses arising from impairment are recognised in the profit and loss account in other operating expenses.
