- Each of the cases listed in Schedule A to D (attached to this order) be transferred to the High Court of Justice, Business and Property Courts in Birmingham, Company and Insolvency List, solely for the purpose only of making this Order. Immediately upon this Order taking effect the County Court Cases be transferred back to the relevant Court or Hearing Centre.
- DAVID SMITHSON (Outgoing Office-Holder) be removed from office with immediate effect in respect of each of the cases listed in Schedules A to D attached to this order ("block transfer cases") forthwith.
- 3. RICHARD PATRICK BREWER (Replacement Office-Holder) be appointed as replacement Office-Holder in respect of each of the block transfer cases listed Schedule A to D from the date of this Order.
- 4. David Smithson be removed and replaced in each of the cases contained in Schedules A to D from the date of this Order, without being required to (i) apply to the Secretary of State for release or discharge as appropriate pursuant to s174(4)(b) and s173(2)(b) of the Insolvency Act 1986 as the case may be, or (ii) file a receipts and payment account.
- 5. The creditors in each of the block transfer cases listed in Schedules B to D and the members of each of the companies listed in Schedule A be notified of this order by way of one composite notice ("the Advertisement") to be published in the Gazette within 14 days of receipt of the sealed Order.
- David Smithson be discharged from liability as office-holder 21 days after the publication of a notice in the Gazette as provided for by paragraph 4 of this Order.
- 7. Where the appointments referred to in this Order are joint appointments, any act required or authorised under any enactment to be done by joint appointees may be done by all or any one or more of the persons at the time holding office.
