

ORDER

UPON the application of Mark Holborow, Matthew Haw, and Graham Bushby by notice dated 7 October 2022

AND UPON READING the evidence filed

AND UPON the Applicant inviting the court to consider the application without a hearing and the court being satisfied that it is an appropriate case for a substantive order to be made on the application without a hearing

AND UPON Matthew Haw being an applicant in the application and it appearing that he ought be removed as a respondent

AND UPON it appearing that all of the proposed replacement office-holders ought be respondents to the application

IT IS ORDERED that:

- Such of the insolvency proceedings listed in the Schedule to this order which are not currently before
 the High Court of Justice, Business and Property Courts in Leeds, Insolvency and Companies List (ChD)
 be transferred to this court for the purposes only of the application and thereafter be transferred back
 to their respective courts.
- 2. Matthew Haw be removed as respondent to the application.
- 3. James Hawksworth and Glen Carter be added as respondents to the application.
- 4. Subject to paragraph 5 of this order, immediately upon this order taking effect:
 - (a) Mark Holborow be removed from office as administrator or liquidator, as the case may be, of the companies listed in the Schedule to this order; and
 - (b) James Hawksworth, Matthew Haw, Glen Carter, Matthew Wild and Terence Guy Jackson ('the Replacement Office-Holders') be appointed as replacement office-holders in respect of the cases listed in the Schedule for which they are identified as the proposed appointees.
- 5. This order shall not take effect in respect of any case which is listed in the Schedule but which is concluded and the case closed prior to this order being sealed by the court.
- 6. In any case where the Replacement Office-Holders are taking an office which will be jointly held by more than one person, any act required or authorised under any enactment to be done by the office-holder may be done by any one or more of the persons for the time being holding the office in question.
- 7. Provided that no application has been made pursuant to paragraph 15 of this order in respect of the administration case in question, pursuant to paragraph 98(2)(c) of Schedule B1 to the Insolvency Act 1986 Mark Holborow be discharged from liability in respect of any actions of his as administrator of the companies in administration listed in the Schedule 28 days after notice has been given in

accordance with paragraph 12 of this order save in respect of any claim notified to him on or prior to that date.

- 8. Save as provided for in paragraph 7 of this order any application for release shall be made to the Secretary of State pursuant to sections 173 or 174 of the Insolvency Act 1986 as appropriate.
- 9. Where any of the companies in administration listed in the Schedule move into creditors' voluntary liquidation pursuant to paragraph 83(6) of Schedule B1 to the Insolvency Act 1986 and Mark Holborow has been nominated as liquidator under paragraph 83(7)(a) of the said Schedule B1, the relevant Replacement Office-Holder will be treated as having been nominated in place of Mark Holborow and will be appointed liquidator in any case where Mark Holborow would have been so appointed but for this order.
- 10. Pursuant to rule 12.38(3) of the Insolvency (England and Wales) Rules 2016 the Applicants shall ensure that a sealed copy of this order is filed with the court having jurisdiction over each case.
- 11. Pursuant to rule 12.38(6) of the said rules the Replacement Office-Holders shall give written notice of their appointment to the Secretary of State and the Registrar of Companies in all cases.
- 12. Pursuant to rule 12.38(6) of the said rules the Replacement Office-Holders shall give written notice of this order to the creditors in all cases and also to the members in the case of members' voluntary liquidations as follows:
 - (a) in the next progress report; and
 - (b) by way of one composite advertisement in the London Gazette within 14 days of receipt of a sealed copy of this order from the court.

such notices to include an explanation of the effect of this order and express reference to the liberty to apply in paragraph 15 of this order.

- 13. The time by which the progress reports in each case are required to be delivered shall be unaffected by the change in office-holder unless the court otherwise orders in any individual case.
- 14. The parties have liberty to apply to amend the application and vary this order to include any appointments held by the First Applicant which have been inadvertently omitted from the application.
- 15. The creditors in all cases and the members in the case of the members' voluntary liquidations and have liberty to apply to set aside or vary this order within 28 days of notice being given in accordance with

paragraph 12 of this order. Unless the court orders otherwise such application shall not affect the block transfer of the cases pursuant to paragraph 3 of this order.

- 16. This order shall be served by the Applicants on the Respondents.
- 17. The costs of the application by paid by RSM UK Restructuring Advisory LLP.
