### Directors' and Trustees' report

The company is registered as a charity with the Charity Commission, registration number 1154432, and is limited by guarantee.

The object of the charity is to benefit disadvantaged children and young adults in Southern Africa. During the year, donations were received totalling £5,088 (2018: £550) and donations were awarded totalling £20,797 (2018: £10,000).

#### **Directors and Trustees**

The directors who served during the year were the trustees of the charity, Mr C A Wentzel and Dr B D Dobson.

#### Accounts

The directors present their report and accounts for the year to 30 June 2019.

### Trustees' responsibilities

They are also responsible for safeguarding the assets of the company and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.
