(A) immediately upon the restoration of the name of the Company to the Register issue:

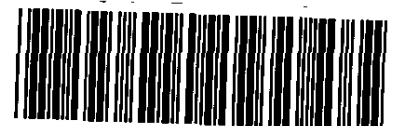
- (i) a Determination under Regulation 80 of The Income Tax (Pay As You Earn) Regulations 2003 seeking the recovery of unpaid Income Tax
- (ii) a Notice of Decision under Section 8(1) of The Social Security Contributions (Transfer of Functions etc.) Act 1999 seeking the recovery of National Insurance contributions

referred to in paragraphs 5 and 6 of the Witness Statement of Robert Coates dated the 11 August 2022 (the Witness Statement)

- (B) pursue the recovery of unpaid Income Tax from the Company or from its employees under Regulation 81 of The Income Tax (Pay As You Earn) Regulations 2003 referred to in paragraph 6 of the Witness Statement
- (C) pursue the recovery of unpaid National Insurance contributions from the Company or from its employees under Section 121C of The Social Security Administration Act 1992 referred to in paragraph 6 of the Witness Statement
- (D) in the absence of the recovery of unpaid Income Tax or unpaid National Insurance contributions insofar as the liability is the Company's, petition the Court for the Company's compulsory winding up, the petition to be presented within 3 calendar months of (a) the Regulation 80 determination becoming final or (b) the Company's restoration whichever is the later.
- (E) inform the Registrar of Companies of the title and Court reference number of the proposed Petition immediately after issue
- (F) inform the Registrar of Companies immediately on the outcome of the hearing of the said Petition
- (G) within 21 days of the making of any compulsory winding up Order in respect of the Company deliver an Office Copy of that Order to the Registrar of Companies
- (H) inform the Registrar immediately on the conclusion of its claims against the Company if by any other means

AND UPON the solicitors for the Claimants and the Registrar of Companies (the Defendant) both consenting to this Order

IT IS ORDERED THAT:

- (1) the name of the above-named TZZ Consultants Ltd be restored to the Register of Companies
- (2) if at the date of registration of this Order with the Registrar of Companies the name of the Company is not available the Registrar of Companies shall pursuant to

Section 1033(2)(a)(ii) and (b) of the Companies Act 2006 change the name of the Company to 08585060 Ltd

(3) an Office Copy of the Order be delivered to the Registrar of Companies and pursuant to the above-mentioned Act the Company is thereupon to be deemed to have continued in existence as if its name had not been struck off

(4) the Registrar of Companies do advertise notice of this Order in her official name in the "London Gazette"


(5) the hearing fixed for the 14 April 2023 at 2:00pm be vacated


