General information

Alderbury FC Limited is a private company limited by share capital, incorporated in England and Wales, with the registered number 08626158. Its registered office is 60 Montgomery Gardens, Salisbury, Wiltshire, SP2 7UQ. The company is responsible for the provision of playing facilities for Alderbury Football Club.

Average number of employees

The average monthly number of employees, including directors, during the year was 0 (2022 - 0).

Guarantees and other financial commitments

The company has obtained funding to construct new football pitches and a clubhouse costing £896,243. The outstanding financial commitment for the project as at 31 July 2023 was £nil. The company has been awarded capital grants of £65,000 by The English Sports Council and £498,203 by The Football Foundation, of which £538,630 has been received, included in creditors, and the balance will be claimed after the year end. However this funding has been secured in advance by the creation of charges on the company's leasehold land at Alderbury.

Directors' confirmations

The directors consider that the Company is entitled to exemption from audit under section 477 of the Companies Act 2006 and members have not required the Company to obtain an audit for the year in question in accordance with section 476 of the Companies Act 2006.
