

THIS AGREEMENT is made on 30th January 2015

BETWEEN:

(1) **ARCH HALL LIMITED**, a limited company incorporated and registered in England and Wales with company number 08662120 the registered office of which is at Chester House, 150-154 Cross Street, Sale, Cheshire, England, M33 4GF (the "**Borrower**"),

and

(2) **ARCH HALL BRIDGING LIMITED**, a company incorporated in England and Wales with company number 08662096 the registered office of which is at Chester House, 150-154 Cross Street, Sale, Cheshire, England, M33 4GF (the "**Lender**"),

WHEREAS:

(A) The Borrower has agreed to provide security on the terms of this debenture to the Lender for sums loaned to the Borrower from time to time

IT IS AGREED as follows

1 Definitions and Interpretations

1.1 In this agreement, unless the context otherwise requires, the following words and expressions shall have the following meanings

Charged Property	all the assets, property and undertaking for the time being subject to the security interests created by this debenture (and references to the Charged Property shall include references to any part of it)
Costs	all costs, charges, expenses and liabilities of any kind including, without limitation, costs and damages in connection with litigation, professional fees, disbursements and any value added tax charged on Costs
Deed of Priorities	Any deed of priorities made on or after the date hereof between the Borrower, the Lender and the Senior Lenders
Designated Account	any account nominated by the Lender as a designated account for the purposes of this debenture
Encumbrance	any mortgage, charge (whether fixed or floating, legal or equitable), pledge, lien, assignment by way of security or other security interest securing any obligation of any person, or any other agreement or arrangement having a similar effect
Environment	all of the air, water and land, including (without limitation) the air within buildings and other natural or man-made structures above or below ground, ground and surface water and surface and sub-surface soil
Environmental Law	all applicable statutes, treaties, regulations, directives or similar measures relating to the pollution or protection of the Environment that affects the Charged Property
Equipment	all present and future equipment, plant, machinery, tools, vehicles, furniture, fittings, installations and apparatus



and other tangible moveable property for the time being owned by the Borrower, including any part of it and all spare parts, replacements, modifications and additions

Excluded Property

any leasehold property held by the Borrower under a lease which precludes, either absolutely or conditionally (including requiring the consent of any third party), the Borrower from creating any charge over its leasehold interest in that property

Insurance Policies

the insurance policies referred to in clause 3 2

Intellectual Property

the Borrower's present and future patents, trademarks, service marks, trade names, designs, copyrights, inventions, topographical or similar rights, confidential information and know-how and any interest in any of these rights, whether or not registered, including all applications and rights to apply for registration and all fees, royalties and other rights derived from, or incidental to, these rights

Investments

all present and future stocks, shares, loan capital, securities, bonds and investments (whether or not marketable) for the time being owned (at law or in equity) by the Borrower, including all rights accruing or incidental to those investments from time to time

Properties

all freehold and leasehold properties (whether registered or unregistered) and all commonhold properties, now or in the future (and from time to time) owned by the Borrower, or in which the Borrower holds an interest and Property means any of them

Receiver

a receiver and/or manager of any or all of the Charged Property appointed under paragraph 6 of schedule 4



Secured Liabilities all present and future moneys, obligations and liabilities owed by the Borrower to the Lender, whether actual or contingent and whether owed jointly or severally, as principal or surety and/or in any other capacity (including, without limitation, those arising under clause 12 3 2) together with all interest (including, without limitation, default interest) accruing in respect of such moneys or liabilities

Security Period the period starting on the date of this debenture and ending on the date on which all the Secured Liabilities have been unconditionally and irrevocably paid and discharged in full and no further Secured Liabilities are capable of being outstanding

1 2 Interpretation

Unless the context otherwise requires, in this debenture

1 2 1 A reference to a statute or statutory provision includes a reference to any subordinate legislation made under that statute or statutory provision, to any modification, re-enactment or extension of that statute or statutory provision and to any former statute or statutory provision which it consolidated or re-enacted before the date of this debenture

1 2 2 A reference to one gender includes a reference to the other gender

1 2 3 Words in the singular include the plural and in the plural include the singular

1 2 4 A reference to a clause or schedule is to a clause of, or schedule to, this debenture and references to paragraphs are to paragraphs of the relevant schedule

1 2 5 A reference to this debenture (or any specified provision of it) or any other document shall be construed as a reference to this debenture, that provision or that document as in force for the time being and as amended or novated from time to time



1 2 6 A reference to a person shall include a reference to an individual, firm, corporation, unincorporated body of persons, or any state or any agency of a person

1 2 7 A reference to an amendment includes a supplement, variation, novation or re-enactment (and amended shall be construed accordingly)

1 2 8 A reference to assets includes present and future properties, undertakings, revenues, rights and benefits of every description

1 2 9 A reference to an authorisation includes an authorisation, consent, licence, approval, resolution, exemption, filing, registration and notarisation

1 2 10 A reference to a regulation includes any regulation, rule, official directive, request or guideline (whether or not having the force of law) of any governmental, inter-governmental or supranational body, agency, department or regulatory, self-regulatory or other authority or organisation

1 2 11 Clause, schedule and paragraph headings shall not affect the interpretation of this debenture

1 3 Clawback

1 3 1 If the Lender considers that an amount paid by the Borrower in respect of the Secured Liabilities is capable of being avoided or otherwise set aside on the liquidation or administration of the Borrower or otherwise, then that amount shall not be considered to have been irrevocably paid for the purposes of this debenture

1 4 Nature of security over real property

1 4 1 A reference in this debenture to a charge or mortgage of any freehold, leasehold or commonhold property includes

1 4 1 1 all buildings and fixtures (including trade and tenant's fixtures) which are situated on that property at any time,

1 4 1 2 the proceeds of the sale of any part of that property, and



1 4 1 3 the benefit of any covenants for title given, or entered into, by any predecessor in title of the Borrower in respect of that property, and any monies paid or payable in respect of those covenants

1 5 Law of Property (Miscellaneous Provisions) Act 1989

1 5 1 For the purposes of section 2 of the Law of Property (Miscellaneous Provisions) Act 1989, the terms of any loan agreement between the Lender and the Borrower from time to time shall be deemed to have been incorporated into this debenture

1 6 Third party rights

1 6 1 A third party has no right under the Contracts (Rights of Third Parties) Act 1999 to enforce, or to enjoy the benefit of, any term of this debenture

1 7 Perpetuity Period

1 7 1 The perpetuity period applicable to all trusts declared by this debenture shall be 80 years

1 8 Insolvency Act 1986

1 8 1 Paragraph 14 of Schedule B1 of the Insolvency Act 1986 (as inserted by section 248 of, and Schedule 16 to, the Enterprise Act 2002) applies to the floating charge created by this debenture

1 9 Schedules

1 9 1 The schedules form part of this debenture and shall have effect as if set out in full in the body of this debenture Any reference to this debenture includes the schedules

2 Covenant to Pay

2 1 The Borrower shall, on demand, pay to the Lender and discharge the Secured Liabilities when they become due



3 Grant of Security

Charging clause

3 1 As a continuing security for the payment and discharge of the Secured Liabilities, the Borrower with full title guarantee charges to the Lender, by way of fixed charge

3 1 1 all Properties acquired by the Borrower in the future,

3 1 2 all present and future interests of the Borrower not effectively mortgaged or charged under the preceding provisions of this clause 3 in, or over, freehold or leasehold property,

3 1 3 all present and future rights, licences, guarantees, rents, deposits, contracts, covenants and warranties relating to the Properties,

3 1 4 all licences, consents and authorisations (statutory or otherwise) held or required in connection with the Borrower's business or the use of any Charged Property, and all rights in connection with them,

3 1 5 all present and future goodwill and capital contributions for the time being of the Borrower,

3 1 6 all the Equipment,

3 1 7 all the Intellectual Property,

3 1 8 all the Book Debts,

3 1 9 all the work in progress

3 1 10 all the data and contact information relating to actual or potential claimants

3 1 11 the design of all systems, computerised and manual, and associated standard letters

3 1 12 all the Investments, and



3 1 13 all monies from time to time standing to the credit of its accounts with any bank, financial institution or other person (including each Designated Account)

3 2 Assigns to the Lender, by way of fixed mortgage, all its rights in any policies of insurances or assurance present or future (including, without limitation, any insurances relating to the Properties or the Equipment),

3 3 Charges to the Lender, by way of floating charge, all the undertaking, property, assets and rights of the Borrower at any time not effectively mortgaged, charged or assigned pursuant to clause 3 1 to clause 3 2 inclusive

3 4 Leasehold security restrictions

The charges created by clause 3 1 shall not apply to Excluded Property so long as any relevant consent or waiver of prohibition has not been obtained, but

3 4 1 for each Excluded Property, the Borrower undertakes to

3 4 1 1 apply for the relevant consent or waiver of prohibition or conditions within five Business Days of the date of this debenture and, to use its best endeavours to obtain that consent or waiver of prohibition as soon as possible,

3 4 1 2 keep the Lender informed of its progress in obtaining such consent or waiver, and

3 4 1 3 immediately on receipt of such consent or waiver, provide the Lender with a copy

3 4 2 immediately on receipt of the relevant waiver or consent, the relevant formerly Excluded Property shall stand charged to the Lender under clause 3 1 If required by the Lender at any time following receipt of that waiver or consent, the Borrower shall execute a valid fixed charge in such form as the Lender requires

3 5 Automatic conversion of floating charge

The floating charge created by clause 3 3 shall automatically and immediately (without notice) be converted into a fixed charge over the relevant Charged Property if



3 5 1 the Borrower

3 5 1 1 creates, or attempts to create, on all or any part of the Charged Property an Encumbrance without the prior written consent of the Lender or any trust in favour of another person, or

3 5 1 2 disposes, or attempts to dispose of, all or any part of the Charged Property (other than property that is only subject to the floating charge while it remains uncrystallised which property may be disposed of in the ordinary course of business), or

3 5 2 a receiver is appointed over all or any of the Charged Property that is subject to the floating charge, or

3 5 3 any person levies (or attempts to levy) any distress, attachment, execution or other process against all or any part of the Charged Property, or

3 5 4 the Lender receives notice of the appointment of, or a proposal or an intention to appoint, an administrator of the Borrower

3 6 Conversion of floating charge by notice


3 6 1 The Lender may, in its sole discretion, at any time and by written notice to the Borrower, convert the floating charge created under this debenture into a fixed charge as regards any part of the Charged Property specified by the Lender in that notice

3 7 Assets acquired after any floating charge crystallisation

3 7 1 Any asset acquired by the Borrower after any crystallisation of the floating charge created under this debenture which, but for such crystallisation, would be subject to a floating charge shall (unless the Lender confirms in writing to the contrary) be charged to the Lender by way of fixed charge

4 Liability of the Borrower

4 1 Liability not discharged



The Borrower's liability under this debenture in respect of any of the Secured Liabilities shall not be discharged, prejudiced or affected by

4 1 1 any security, guarantee, indemnity, remedy or other right held by, or available to, the Lender that is or becomes wholly or partially illegal, void or unenforceable on any ground, or

4 1 2 the Lender renewing, determining, varying or increasing any facility or other transaction in any manner or concurring in, accepting or varying any compromise, arrangement or settlement, or omitting to claim or enforce payment from any other person, or

4 1 3 any other act or omission, which but for this clause 4 1 might have discharged, or otherwise prejudiced or affected, the liability of the Borrower

4 2 Immediate recourse

4 2 1 The Borrower waives any right it may have to require the Lender to enforce any security or other right, or claim any payment from, or otherwise proceed against, any other person before enforcing this debenture against the Borrower

5 **Representations and Warranties**

5 1 The Borrower represents and warrants to the Lender in the terms set out in schedule 1. The representations and warranties set out in schedule 1 are made on the date of this debenture

6 **Covenants**


6 1 The Borrower covenants with the Lender in the terms set out in schedule 2

7 **Powers of the Lender**

7 1 The Lender shall have the powers set out in schedule 3.

8 **Enforcement**

8 1 Enforcement events



8 1 1 The security constituted by this debenture shall be immediately enforceable in any of the circumstances set out in paragraph 1 of schedule 4

8 2 Receiver's powers

8 2 1 A Receiver shall have, in addition to the powers conferred on receivers by statute, the further powers set out in schedule 5

9 **Costs and Indemnity**

9 1 Costs

The Borrower shall pay to, or reimburse, the Lender and any Receiver on demand, on a full indemnity basis, all Costs incurred by the Lender and any Receiver in relation to

9 1 1 this debenture or the Charged Property,

9 1 2 protecting, perfecting, preserving or enforcing (or attempting to do so) any of the Lender's rights under this debenture,

9 1 3 suing for, or recovering, any of the Secured Liabilities,

(including, without limitation, the Costs of any proceedings in relation to this debenture or the Secured Liabilities), together with interest on any amount due under clause 9 1 at the rate of 5 per cent over the base lending rate of Barclays Bank Plc from time to time

9 2 Indemnity

The Lender and any Receiver, and their respective employees and agents, shall be indemnified on a full indemnity basis out of the Charged Property in respect of all actions, liabilities and Costs incurred or suffered in or as a result of

9 2 1 the exercise, or purported exercise, of any of the powers, authorities or discretions vested in them under this debenture, or

9 2 2 any matter or thing done, or omitted to be done, in relation to the Charged Property under those powers



10 Release

- 10 1 Subject to clause 12 3, on the expiry of the Security Period (but not otherwise), the Lender shall, at the request and cost of the Borrower, take whatever action is necessary to release the Charged Property from the security constituted by this debenture

11 Assignment and Transfer

11 1 Assignment by Lender

- 11 1 1 At any time, without the consent of the Borrower, the Lender may assign or transfer the whole or any part of the Lender's rights and/or obligations under this debenture to any person

11 2 Assignment by Borrower

- 11 2 1 The Borrower may not assign any of its rights, or transfer any of its obligations, under this debenture or enter into any transaction which would result in any of these rights or obligations passing to another person

12 Further Provisions

12 1 Independent security

- 12 1 1 This debenture shall be in addition to, and independent of, every other security or guarantee which the Lender may hold for any of the Secured Liabilities at any time. No prior security held by the Lender over the whole or any part of the Charged Property shall merge in the security created by this debenture

12 2 Continuing security

- 12 2 1 This debenture shall remain in full force and effect as a continuing security for the Secured Liabilities, despite any settlement of account, or intermediate payment, or other matter or thing, unless and until the Lender discharges this debenture in writing

12 3 Discharge conditional



Any release, discharge or settlement between the Borrower and the Lender shall be deemed conditional on no payment or security received by the Lender in respect of the Secured Liabilities being avoided, or reduced or ordered to be refunded pursuant to any provision of any enactment relating to insolvency, bankruptcy, winding-up, administration, receivership or otherwise. Despite any such release, discharge or settlement

12.3.1 the Lender or its nominee may retain this debenture and the security created by or pursuant to it, including all certificates and documents relating to the whole or any part of the Charged Property, for such period as the Lender deems necessary to provide the Lender with security against any such avoidance or reduction or order for refund, and

12.3.2 the Lender may recover the value or amount of such security or payment from the Borrower subsequently as if such settlement, discharge or release had not occurred. The Borrower agrees with the Lender accordingly and charges the Charged Property, and the proceeds of any sale of it, with any liability under this clause 12.3.2

12.4 Certificates

12.4.1 A certificate or determination by the Lender as to any amount for the time being due to it from the Borrower shall (in the absence of any manifest error) be conclusive evidence of the amount due

12.5 Rights cumulative

12.5.1 The rights and powers of the Lender conferred by this debenture are cumulative, may be exercised as often as the Lender considers appropriate, and are in addition to its rights and powers under the general law

12.6 Waivers

12.6.1 Any waiver or variation of any right by the Lender (whether arising under this debenture or under the general law) shall only be effective if it is in writing and signed by the Lender and applies only in the circumstances for which it was given, and shall not prevent the Lender from subsequently relying on the relevant provision



12 7 Further exercise of rights

12 7 1 No act or course of conduct or negotiation by or on behalf of the Lender shall, in any way, preclude the Lender from exercising any right or power under this debenture or constitute a suspension or variation of any such right or power

12 8 Delay

12 8 1 No delay or failure to exercise any right or power under this debenture shall operate as a waiver

12 9 Single or partial exercise

12 9 1 No single or partial exercise of any right under this debenture shall prevent any other or further exercise of that or any other right

12 10 Consolidation

12 10 1 The restriction on the right of consolidation contained in section 93 of the Law of Property Act 1925 shall not apply to this debenture

12 11 Partial invalidity

12 11 1 The invalidity, unenforceability or illegality of any provision (or part of a provision) of this debenture under the laws of any jurisdiction shall not affect the validity, enforceability or legality of the other provisions

12 12 Counterparts

12 12 1 This debenture may be executed and delivered in any number of counterparts, each of which is an original and which together have the same effect as if each party had signed the same document

13 Notices

13 1 Service



13 1 1 Any notice or other communication given under this debenture shall be in writing and shall be served by delivering it personally or by sending it by pre-paid first-class post or air-mail or by fax to the address, and for the attention, of the relevant party as set out in schedule 6, or such other address or fax number as may be notified in writing from time to time by the relevant party to the other party

13 2 Receipt

Receipt of any notice given under clause 13 1, shall be deemed to be received

13 2 1 if delivered personally, at the time of delivery, or

13 2 2 in the case of pre-paid first-class post, 48 hours from the time of posting, or

13 2 3 in the case of air-mail, 72 hours from the time of posting,

13 2 4 in the case of a fax, when received in legible form

13 3 Deemed receipt

If deemed receipt under clause 13 2 occurs

13 3 1 before 9 00 am on a Business Day, the notice shall be deemed to have been received at 9 00 am on that day, or

13 3 2 after 5 00 pm on a Business Day, or on a day that is not a Business Day, the notice shall be deemed to have been received at 9 00 am on the next Business Day

13 4 Proof of service

In proving service of a notice, it shall be sufficient to prove that the envelope containing such notice was addressed to the address of the relevant party as set out in schedule 6 (or as otherwise notified by that party under clause 13 1) and delivered either

13 4 1 to that address, or



13 4 2 into the custody of the postal authorities as a pre-paid recorded delivery first-class or air-mail letter

13 5 E-mails invalid

13 5 1 Notice given under this debenture shall not be validly served if sent by e-mail

13 6 The Borrower shall treat any notice, instruction or consent it receives from the Senior Lender pursuant to this debenture as a notice, instruction or consent on behalf of the Lender

14 **Lender's Security**

14 1 Nothing in this debenture shall prohibit any action undertaken by the Borrower which is in accordance with the terms of any Permitted Security or require any action which would cause the Borrower to be in breach of any Permitted Security

14 2 If the benefit of this Debenture is transferred in accordance with clause 11 2, then the Lender will at the reasonable cost of the Borrower promptly execute and deliver any new Deed of Priorities required by the replacement Senior Lender which is in a substantially similar form to the terms of the Deed of Priorities

15 **Governing Law and Jurisdiction**

15 1 Governing law

15 1 1 This debenture and any dispute arising out of or in connection with it or its subject matter shall be governed by and construed in accordance with the law of England and Wales

15 2 Jurisdiction

15 2 1 The parties to this debenture irrevocably agree that, subject as provided below, the courts of England and Wales shall have exclusive jurisdiction over any claim or matter arising out of or in connection with this debenture



15.3 Other service

15.3.1 The Borrower irrevocably consents to any process in any legal action or proceedings arising out of or in connection with this debenture being served on it in accordance with the provisions of this debenture relating to service of notices. Nothing contained in this debenture shall affect the right to serve process in any other manner permitted by law.

5 1 1 all deeds and documents of title relating to the Charged Property which are in the possession or control of the Borrower (if these are not within the possession and/or control of the Borrower, the Borrower undertakes to obtain possession of all such deeds and documents of title),

5 1 2 all Insurance Policies and any other insurance policies relating to any of the Charged Property to which policies the Borrower is entitled to possession, and

6 1 2 in any other way dispose of, or agree to dispose of, surrender or create any legal or equitable estate or interest in the whole or any part of any Property

7 Registration Restrictions

7 1 The Borrower shall procure that no person shall be registered under the Land Registration Acts 1925 to 2002 as proprietor of any Property without the prior written consent of the Lender. The Borrower shall be liable for the Costs of the Lender in lodging cautions against the registration of the title to the whole or any part of any Property from time to time.

8 Development Restrictions



1 2 The Borrower shall not during the Security Period exercise any rights under sections 145 and 146 of the Companies Act 2006 to nominate any person in respect of any of the Investments

2 Additional Registration Obligations

2 1 The Borrower shall

2 1 1 procure all consents, waivers, approvals and permissions which are necessary, under the articles of association of any issuer that is not a public company or otherwise, for the transfer of the Investments to the Lender or its nominee, or to a purchaser on enforcement of this debenture, and

2 1 2 procure the amendment of the share transfer provisions of the articles of association of each issuer that is not a public company in such manner as the Lender may require in order to permit such a transfer



3 Dividends and Voting Rights Post Enforcement

3 1 After the security constituted by this debenture has become enforceable

3 1 1 all dividends and other distributions paid in respect of the Investments and received by the Borrower shall be held on trust for the Lender and immediately paid into a Designated Account or, if received by the Lender, shall be retained by the Lender, and



1 1 2 2 to be overloaded or used for any purpose for which it is not designed or reasonably suitable

2 Payment of Equipment Taxes

2 1 The Borrower shall promptly pay all taxes, fees, licence duties, registration charges, insurance premiums and other outgoings in respect of the Equipment and, on demand, produce evidence of payment to the Lender

3 Equipment Information

3 1 The Borrower shall

3 1 1 give the Lender such information concerning the location, condition, use and operation of Equipment as the Lender may require, and

3 1 2 permit any persons designated by the Lender to inspect and examine Equipment and the records relating to Equipment at all reasonable times

4 Equipment Insurance

4 1 The Borrower shall

4 1 1 at its own expense, procure that the Equipment is covered and kept covered by insurance of a kind satisfactory to the Lender with insurers approved by the



Lender (such approval not to be unreasonably withheld) for full comprehensive insurance cover, which shall include (but not be limited to) fire, theft and accident, for an amount which is not less than the aggregate cost of reinstating or replacing such Equipment,

4 1 2 if the Lender so requires, procure that the interest of the Lender is noted on all such insurance policies or, at the option of the Lender, that such insurance policies are issued in the joint names of the Lender and the Borrower, and

4 1 3 maintain insurance for third party liabilities in such amount, and on such terms, as is usual for users of equipment of the same type as the Equipment

5 **Notice of Charge**

5 1 The Borrower shall, if so requested by the Lender, place and maintain on each item of Equipment, in a conspicuous place, a clearly legible identification plate containing the following wording

Part 6 - Intellectual Property Covenants

1 Preservation of Rights

3 Power to Dispose of Chattels

- 3 1 At any time after the security constituted by this debenture has become enforceable, the Lender or any Receiver

3 1 1 may dispose of any chattels or produce found on any Property as agent for the Borrower, and

3 1 2 without prejudice to any obligation to account for the proceeds of any sale of such chattels or produce, shall be indemnified by the Borrower against any liability arising from such disposal

4 Prior Encumbrances

- 4 1 At any time after the security constituted by this debenture has become enforceable, or after any powers conferred by any Encumbrance having priority to this debenture shall have become exercisable, the Lender may

4 1 1 redeem such or any other prior Encumbrance, or procure its transfer to themselves, and



4 1 2 settle any account of the holder of any prior Encumbrance

The settlement of any such account shall be conclusive and binding on the Borrower. SCHEDULE 4

Enforcement

1 1 3 3 makes a general assignment for the benefit of, or a composition with, its creditors, or

1 1 4 the Borrower passes any resolution or takes any corporate action, or a petition is presented or proceedings are commenced, or any action is taken by any person for its winding-up, dissolution, administration or re-organisation or for the appointment of a receiver, administrative receiver, administrator, trustee or similar officer of it or of any or all of its revenues or assets, or

1 1 5 a distress, execution, attachment or other legal process is levied, or enforced on or sued against all or any part of the assets of the Borrower and remains undischarged for seven days, or



1 1 6 any event occurs in relation to the Borrower that is analogous to those set out in paragraph 1 1 3, paragraph 1 1 4 or paragraph 1 1 5 of this schedule 4, or

1 1 7 any representation or statement made or deemed to be made by the Borrower under this debenture is or proves to have been incorrect or misleading when made or deemed to be made, or

and in any such event (whether or not the event is continuing), without prejudice to any other rights of the Lender, the powers of sale under the Law of Property Act 1925 shall immediately be exercisable and the Lender may, in its absolute discretion, enforce all or any part of the security created by this debenture as it sees fit

2 Statutory Power of Sale

2 1 The statutory power of sale shall, as between the Lender and a purchaser from the Lender, arise on and be exercisable at any time after the execution of this debenture, but the Lender shall not exercise such power of sale until the security constituted by this debenture has become enforceable under paragraph 1 of this Schedule 4

3 Extension of Statutory Powers

3 1 The statutory powers of sale, leasing and accepting surrenders exercisable by the Lender under this debenture are extended so as to authorise the Lender, whether in its own name or in that of the Borrower, to grant a lease of the whole or any part of the freehold and leasehold property of the Borrower with whatever rights relating to other parts of it, containing whatever covenants on the part of the Borrower, generally on such terms and conditions (including the payment of money to a lessee or tenant on a surrender) and whether or not at a premium as the Lender thinks fit

4 Protection of Third Parties

4 1 No purchaser, mortgagee or other person dealing with the Lender or any Receiver shall be concerned

4 1 1 to enquire whether any of the Secured Liabilities have become due or payable, or remain unpaid or undischarged, or whether the power the Lender or a Receiver is purporting to exercise has become exercisable, or



4 1 2 to see to the application of any money paid to the Lender or any Receiver

5 No Liability as Mortgagee in Possession

5 1 Neither the Lender, nor any Receiver nor any Administrator shall be liable to account as mortgagee in possession in respect of all or any of the Charged Property, nor shall any of them be liable for any loss on realisation of, or for any neglect or default of any nature in connection with, all or any of the Charged Property for which a mortgagee in possession might be liable as such

6 Appointment of Receiver

6 1 At any time after the security constituted by this debenture becomes enforceable, or at the request of the Borrower, the Lender may, without further notice

6 1 1 appoint in writing, any one or more person or persons to be a receiver, or a receiver and manager, of all or any part of the Charged Property, and

6 1 2 (subject to section 45 of the Insolvency Act 1986) from time to time, remove any person appointed to be Receiver and may, in a similar manner, appoint another in his place

Where more than one person is appointed Receiver, they shall have power to act separately (unless the appointment by the Lender specifies to the contrary)

7 Power of Appointment Additional

7 1 The powers of sale and appointing a Receiver conferred by this debenture shall be in addition to all statutory and other powers of the Lender under the Insolvency Act 1986 and the Law of Property Act 1925 or otherwise, and shall be exercisable without the restrictions contained in Sections 103 and 109 of the Law of Property Act 1925 or otherwise

7 2 The power to appoint a Receiver (whether conferred by this debenture or by statute) shall be, and remain, exercisable by the Lender despite any prior appointment in respect of all or any part of the Charged Property



8 Agent of the Borrower

- 8 1 Any Receiver appointed by the Lender under this debenture shall be the agent of the Borrower and the Borrower shall be solely responsible for his acts and remuneration, as well as for any defaults committed by him

9 Powers of Receiver

- 9 1 Any Receiver appointed by the Lender under this debenture shall, in addition to the powers conferred on him by the Law of Property Act 1925 and the Insolvency Act 1986, have the power to do all such acts and things as an absolute owner could do in the management of such of the Charged Property over which the Receiver is appointed and, in particular, the powers set out in schedule 5

10 Order of Application of Proceeds

- 10 1 All monies received by the Lender or a Receiver under this debenture (other than insurance monies) shall be applied

10 1 1 first in paying all unpaid fees, costs and other liability incurred by or on behalf of the Lender (and any Receiver, attorney or agent appointed by it),

10 1 2 second in paying the remuneration of any Receiver (as agreed between the Receiver and the Lender),

10 1 3 third in or towards discharge of the Secured Liabilities in such order and manner as the Lender determines, and

10 1 4 finally in paying any surplus to the Borrower or any other person entitled to it

11 Section 109(8) of the Law Of Property Act 1925

- 11 1 Neither the Lender nor any Receiver shall be bound (whether by virtue of section 109(8) of the Law of Property Act 1925, which is varied accordingly, or otherwise) to pay or appropriate any receipt or payment first towards interest rather than principal or otherwise in any particular order between any of the Secured Liabilities



12 Suspense Account

- 12 1 All monies received by the Lender or a Receiver under this debenture may, at the discretion of the Lender or Receiver, be credited to any suspense or securities realised account and shall bear interest at such rate, if any, as may be agreed in writing between the Lender and the Borrower, and may be held in such account for so long as the Lender or Receiver thinks fit

13 Power of Attorney

- 13 1 By way of security, the Borrower irrevocably appoints the Lender and every Receiver separately to be the attorney of the Borrower and, in its name, on its behalf and as its act and deed, to execute any documents and do any acts and things which

13 1 1 the Borrower is required to execute and do under this debenture, including execute any document required by the Lender under paragraph 6 of Part 1 of schedule 2, and/or

13 1 2 any attorney may deem proper or desirable in exercising any of the powers, authorities and discretions conferred by this debenture or by law on the Lender or any Receiver

14 Ratification of Acts of Attorney

- 14 1 By this debenture, the Borrower ratifies and confirms, and agrees to ratify and confirm, anything which any of its attorneys may do in the proper and lawful exercise or purported exercise of all or any of the powers, authorities and discretions referred to in paragraph 13 of this schedule 4

15 Appointment of an Administrator

- 15 1 The Lender may, without notice to the Borrower, appoint any one or more persons to be an administrator of the Borrower pursuant to Paragraph 14 Schedule B1 of the Insolvency Act 1986 if this debenture becomes enforceable


- 15 2 Any appointment under this paragraph 15 shall

15 2 1 be in writing signed by the Lender, and



15.2.2 take effect, in accordance with paragraph 19 of Schedule B1 of the Insolvency Act 1986, when the requirements of paragraph 18 of that Schedule B1 are satisfied

15.3 The Lender may (subject to any necessary approval from the court) end the appointment of an Administrator by notice in writing in accordance with this paragraph 15 and appoint a replacement for any Administrator whose appointment ends for any reason under that paragraph



SCHEDULE 5

Further Powers of a Receiver

1 Power to Repair and Develop Properties

A Receiver may undertake or complete any works of repair, building or development on the Properties

2 Power to Surrender Leases

A Receiver may grant, or accept surrenders of, any leases or tenancies affecting the Properties on such terms and subject to such conditions as he thinks fit

3 Power to Employ Personnel and Advisors

A Receiver may provide services and employ, or engage, such managers, contractors and other personnel and professional advisors on such terms as he deems expedient

4 Power to Make VAT Elections

A Receiver may make such elections for value added tax purposes as he thinks fit

5 Power To Charge For Remuneration

A Receiver may charge and receive such sum by way of remuneration (in addition to all costs, charges and expenses incurred by him) as the Lender may prescribe or agree with him

6 Power to Realise Charged Property

A Receiver may collect and get in the Charged Property or any part of it in respect of which he is appointed and make such demands and take such proceedings as may seem expedient for that purpose, and to take possession of the Charged Property with like rights



7 **Power to Manage or Reconstruct The Borrower's Business**

A Receiver may carry on, manage, develop, reconstruct, amalgamate or diversify or concur in carrying on, managing, developing, reconstructing, amalgamating or diversifying the business of the Borrower

8 **Power To Dispose Of Charged Property**

A Receiver may grant options and licences over all or any part of the Charged Property, sell or concur in selling, assign or concur in assigning, lease or concur in leasing and accept or concur in accepting surrenders of leases of, all or any of the property of the Borrower in respect of which he is appointed in such manner and generally on such terms and conditions as he thinks fit (fixtures and plant and machinery may be severed and sold separately from the premises in which they are contained without the consent of the Borrower), and to carry any such sale, assignment, leasing or surrender into effect Any such sale may be for such consideration as the Receiver thinks fit and he may promote, or concur in promoting, a company to purchase the property to be sold

9 **Power To Sell Book Debts**

A Receiver may sell and assign all or any of the Book Debts in respect of which he is appointed in such manner, and generally on such terms and conditions, as he thinks fit

10 **Power to Make Settlements**

A Receiver may make any arrangement, settlement or compromise between the Borrower and any other person which he may think expedient

11 **Power to Improve the Equipment**

A Receiver may make substitutions of, or improvements to, the Equipment as he may think expedient

12 **Power to Appoint**

A Receiver may appoint managers, officers, servants, workmen and agents for the purposes of this schedule 5 at such salaries, for such periods and on such terms as he may determine



13 Power to Insure

A Receiver may, if he thinks fit, but without prejudice to the indemnity in clause 9, effect with any insurer any policy of insurance either in lieu or satisfaction of, or in addition to, such insurance

14 Powers under Law Of Property Act 1925

A Receiver may exercise all powers provided for in the Law of Property Act 1925 in the same way as if he had been duly appointed under that act, and exercise all powers provided for an administrative receiver in Schedule 1 of the Insolvency Act 1986

15 Power to Borrow

A Receiver may for any of the purposes authorised by this schedule 6 raise money by borrowing from the Lender (or from any other person) on the security of all or any of the Charged Property in respect of which he is appointed on such terms as he shall think fit (including, if the Lender consent, terms under which such security ranks in priority to this debenture)

16 Power to Redeem Prior Encumbrances

A Receiver may redeem any prior Encumbrance and settle and pass the accounts to which the Encumbrance relates Any accounts so settled and passed shall be conclusive and binding on the Borrower, and the moneys so paid shall be deemed to be an expense properly incurred by him

17 Incidental Powers

A Receiver may do all such other acts and things as he may consider incidental or conducive to any of the matters or powers in this schedule 5, or which he lawfully may or can do as agent for the Borrower

18 Scope of Powers

Any exercise of any of the powers given by this schedule 5 may be on behalf of the Borrower, the directors of the Borrower (in the case of the power contained in paragraph 12 of this schedule 5) or himself
