1. Introduction

- 1.1 Robert Welby was appointed Liquidator of the Company on 17 October 2017 and the Last Report was dated 2 November 2018. The Liquidator is now in a position to conclude the Liquidation and obtain his release as Liquidator.
- **1.2** Accordingly, this final account of the winding up from the date of the Liquidator's appointment is being delivered to members and to the Registrar of Companies pursuant to S94 of the Act.
- 1.3 Statutory information regarding the Liquidation and definitions used in this report are provided in Appendix I.

2. Administration of the Winding Up

- 2.1 Attached at Appendix II is the Liquidator's Final Receipts and Payments Account for the period since the Last Report and for the winding up as a whole. The contents are in the main self-explanatory.
- 2.2 As stated in the Last Report, the issues preventing closure were:
 - 2.2.1 pursuit of clearance from HMRC;
 - 2.2.2 distribution to members of any residual funds after providing for costs to close the Liquidation;
 - 2.2.3 circulation of the proposed final account; and
 - 2.2.4 submission of the necessary documents to bring the Liquidation to a close.
- 2.3 Since the Last Report, the requisite tax clearances have been obtained from HMRC in respect of corporation tax, VAT and PAYE. On receipt of the same, a final distribution of the remaining funds held in the liquidation estate was made to the sole member. A proposed final account was sent to shareholders on 10 October 2019. This report forms the final account of the administration of the liquidation.

Cash at Bank

2.4 The Company's bank account was closed and the closing balance of £125,754.83 was transferred to the Liquidation account.

Director's Loan Account

2.5 According to the Company's accounts, the sum of £34,418.00 was owed at the commencement of the Liquidation in relation to an overdrawn Director's Loan Account. £34,418.00 of the shareholders' distribution, as set out in **Section 4**, was retained in order to settle this debt in full.

Statutory and General Administration

- 2.6 The Liquidator has complied with his statutory and regulatory duties in the period since the Last Report, including the following:
 - 2.6.1 drafting and issuing the Last Report;
 - 2.6.2 maintaining case files, which must include records to show and explain the administration of this liquidation and any decisions made by the Liquidator that materially affect the administration;
 - 2.6.3 conducting periodic case and bond reviews to ensure that the liquidation is progressing efficiently, effectively and in line with the statutory requirements;
 - 2.6.4 maintaining and updating the estate cash book and bank account, including regular bank reconciliations and processing receipts and payments;

- 2.6.5 completing a closure review of all files and seeking clearance from HMRC and other parties to enable the Liquidator to bring the case to a close; and
- 2.6.6 issuing the Liquidator's proposed final account.

3. The Liquidator's Remuneration and Expenses

- 3.1 At the meeting of members held on 17 October 2017, it was resolved that the fee for assisting with the placing of the Company into Liquidation and for attending to matters relating to, and arising in, the Liquidation be agreed at £3,000 plus VAT and disbursements. This fee has been paid in full and the VAT has been reclaimed from HMRC.
- 3.2 The meeting of members also resolved that the Liquidator be authorised to draw his firm's disbursements as categorised in SIP9 as Category 2. Appendix III provides information on the bases on which these disbursements are calculated. The Liquidator is entitled under statute to discharge his Category 1 expenses from the estate.
- 3.3 Appendix II provides information on all expenses paid.

4. Dividends and Distributions

Creditors

- **4.1.** A notice to creditors requiring them to submit claims was published in the Gazette. In addition, several letters were sent to HMRC seeking confirmation that no tax liabilities remained.
- 4.2. No creditors' claims have been received.

Shareholders

4.3. The following distributions were made to the shareholder:

4.4. Included above is the sum of £34,418.00, which was not paid to shareholders, but instead was retained to settle the same amount owing in respect of the Director's Loan Account.

Direct Expenses (Category i Dishursements)

Category 1 Disbursements (as defined by Statement of Insolvency Practice 9), which can be specifically identified as relating to the administration of the case, have been charged to the estate at cost (plus VAT where applicable), with no uplift.
