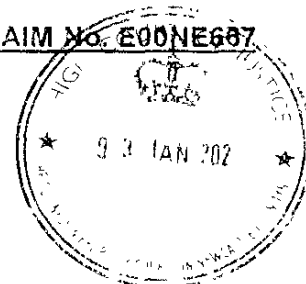

IT IS ORDERED THAT


- (1) the name of the above named Shalini Chauhan Limited be restored to the Register of Companies
