4. RELATED PARTY TRANSACTIONS

The Company is controlled by the Directors on behalf of its members.

The directors successful bid for, and received in December 2013, a grant of £9,785 from The Social Investment Business Ltd to undertake a pre-feasibility assessment towards a potential asset transfer of 'The Victoria Theatre' Halifax from Calderdale Council.

During the period December 2013 to March 2014 Spenser Wilson Ltd, Chartered Accountants, carried out an independent financial review of 'The Victoria Theatre' Halifax for a fee of £3,500. R. Hemblys is a director of Spenser Wilson Ltd and was appointed a director of this company on 19 September 2014.

During the same period John Shepherd Associates Ltd co-ordinated and undertook other non-financial analysis required under the terms of the grant at a fee of £5,685.
