During the year from November 2017 to October 2018, North Devon Moving Image CIC (NDMI) worked with people of all ages and abilities from the communities of north Devon. We also collaborated with national and regional organisations.

Through our local heritage and arts film making projects we have enabled project participants to develop their technical and social skills, connect with their heritage and natural environment and learn about the lives of others. The viewers of the films we produced have been able to learn about people, places, the environment and history of north Devon.

NDMI projects have also provided learning opportunities for children and adults and enabled vulnerable young people to have their voices heard.

We launched our very first short documentary film commission programme and we have successfully appointed and are mentoring seven new film makers to produce a collection of films about farmers and farming lives in north Devon.
