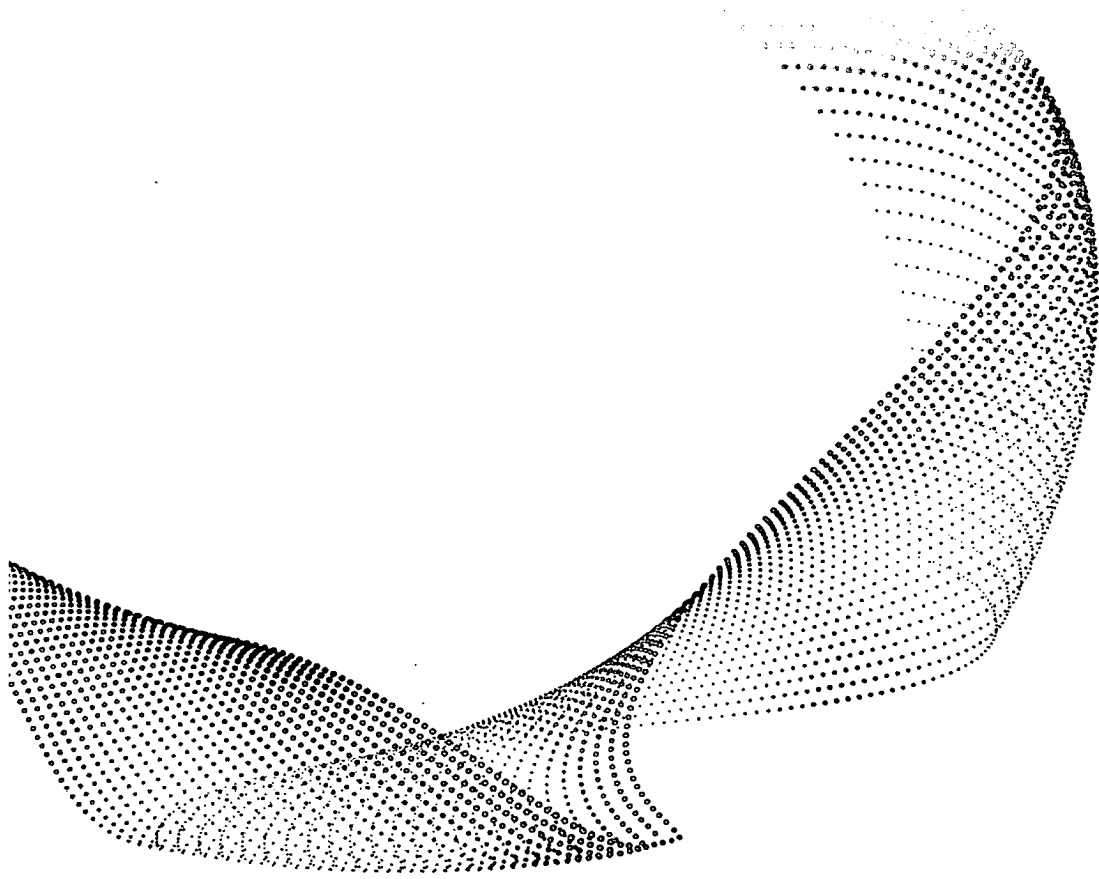

3. Introduction and Statutory information

This report provides an account of the liquidators' administration since the last progress report and a summary of the outcome of the liquidation of the Company. It should be read in conjunction with our previous reports. By way of reminder, we, and Clare Lloyd and Henry Shinnars, of Evelyn Partners LLP, 45 Gresham Street, London, EC2V 7BG, were appointed the joint liquidators of the Company on 25 August 2021. The Company's registered office is 45 Gresham Street, London, EC2V 7BG and its registered number is 08741601.

The liquidation commenced on 25 August 2021 with estimated asset values of £1.49 and anticipated liabilities of £nil, which subject to the costs of the liquidation did not give an expected surplus for the member and there was no return to the member in the liquidation.

4. Realisation of assets

No realisations were made in the liquidation and the joint liquidators did not open a liquidation bank account. However, to allow a comparison with the directors' DOS, we have, attached at Appendix I, our receipts and payments account for the period from 25 August 2022 to 31 May 2023. This account includes cumulative figures for the period from 25 August 2021 to 31 May 2023.

5. Liquidators' remuneration & expenses

5.1 Liquidators' Remuneration

The joint liquidators' fees will be agreed with a third party and, consequently, no fees will be drawn from the liquidation estate. For transparency, during the reporting period the joint liquidators have incurred time costs of £3,035 which represents 8 hours at an average hourly rate of £379.

During the liquidation, the joint liquidators have incurred time costs of £7,518 which represents 21 hours at an average hourly rate of £358.

5.2 Liquidators' Expenses

The joint liquidators have incurred expenses in respect of statutory advertising costs totalling £285. These costs have been settled by a third party.

6. Privacy and Data Protection

As part of our role as the joint liquidators, I would advise you that we may need to access and use data relating to individuals. In doing so, we must abide by data protection requirements. 

8. Conclusion

This final account concludes the liquidators' administration of the winding up of the Company. Once our final account is delivered to the members and the Registrar of Companies, we will be released as the joint liquidators.

Approximately three months after the final account is received by the Registrar of Companies, the Company will be dissolved. We are permitted to destroy, or otherwise dispose of, the Company's books, papers, and other records at any time after the expiration of a period of one year from the date of dissolution. Any reports and documents that have been posted onto the IPS Creditor Portal will be removed two months from the date of our release.

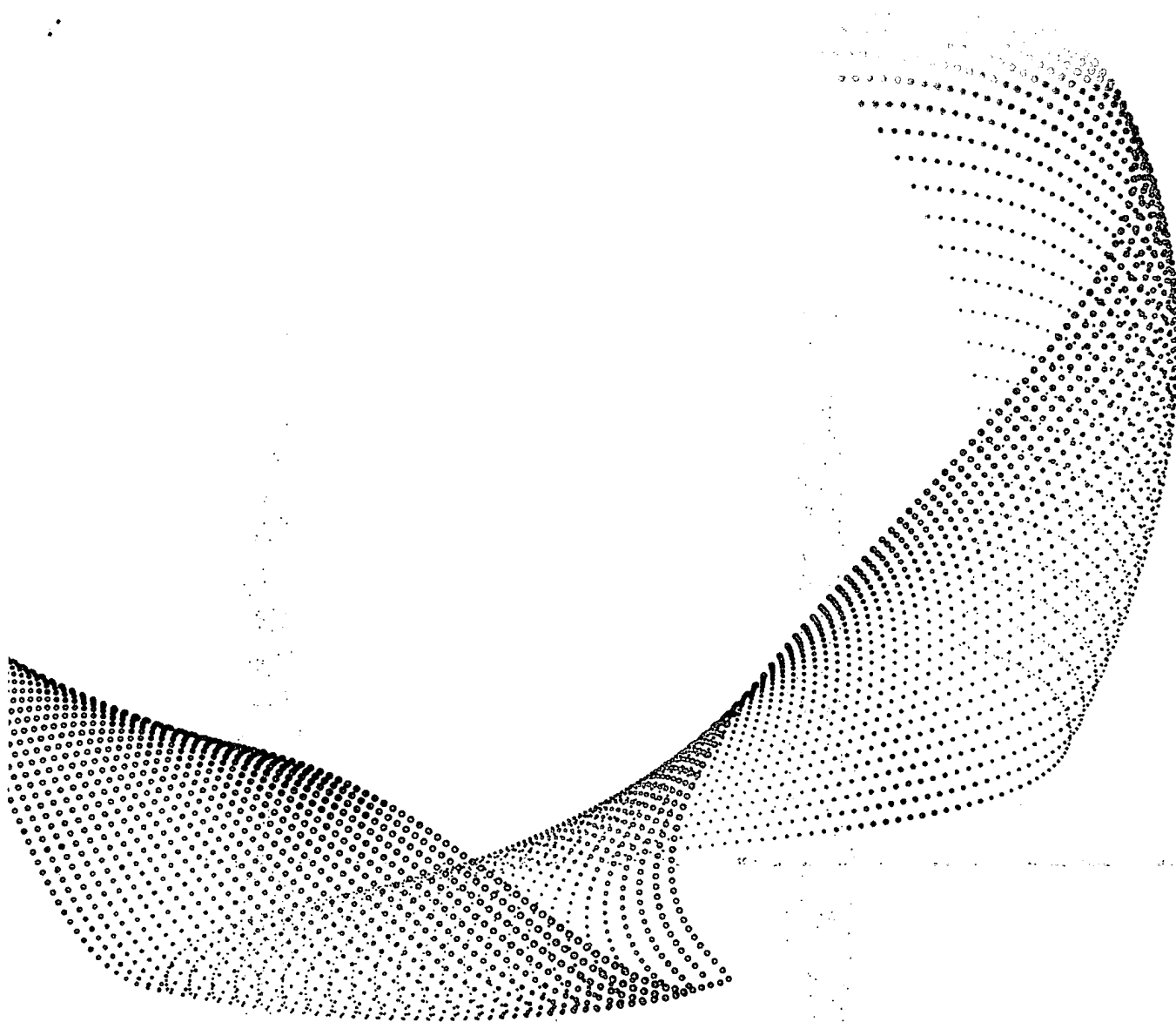
