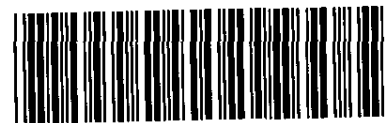

UPON THE APPLICATION by a Claim Form dated the 13<sup>th</sup> May 2022 of Legal & General Pensions Limited and European Investment Bank the First and Second Claimants and creditors of the above named The Hospital Company (Liverpool) Limited (hereinafter called "the Company"), and of Glynn Robert Thomas the Third Claimant and a director of the Company and The Hospital Company (Liverpool) Holdings Limited the Fourth Claimant and a member of the Company

AND UPON READING the evidence

AND IT APPEARING that there is no opposition on behalf of His Majesty to the relief sought by this Claim as appears from the Evidence of Service of the first witness statement of Reuben Vandercruyssen and the exhibit thereto

AND on leave being given to amend the Claim Form by adding Glynn Robert Thomas and The Hospital Company (Liverpool) Holdings Limited as co-Claimants and re service being dispensed with

AND the Third and Fourth Claimants undertaking to:

- (A) take no action regarding the realisation or disposal of the assets of the Company until a liquidator has been appointed.

- (B) within 21 days upon restoration of the name of the Company to the Register of Companies take all steps necessary for procuring that the Company be placed in voluntary liquidation.

AND UPON the solicitors for the Claimants and the Registrar of Companies (the Defendant) both consenting to this Order

IT IS ORDERED that:

- (1) the name of the above named The Hospital Company (Liverpool) Limited be restored to the Register of Companies
- (2) if at the date of registration of this Order with the Registrar of Companies the name of the Company is not available the Registrar of Companies shall pursuant to Section 1033(2)(a)(ii) and (b) of the Companies Act 2006 change the name of the Company to 08747138 Limited
- (3) an Office Copy of this Order be delivered to the Registrar of Companies and pursuant to the above mentioned Act the company is thereupon to be deemed to have continued in existence as if its name had not been struck off
- (4) the Registrar of Companies do advertise notice of this Order in her official name in the "London Gazette"

(5) the Claimants do jointly and severally pay to the Registrar of Companies her costs of the said Application in the agreed sum of £300.00

(6) the hearing on 8 November 2022 is vacated
