The parent of the smallest group to consolidate these financial statements is AA Intermediate Co Limited whose registered office is Fanum House, Basing View, Basingstoke, Hampshire, RG21 4EA. At 31 January 2021 the ultimate controlling party and the ultimate parent undertaking, which is also the parent of the largest group to consolidate these financial statements, was AA Limited (see note 6) whose registered office is at Fanum House, Basing View, Basingstoke, Hampshire, RG21 4EA.

5 ULTIMATE CONTROLLING PARTY

AA Limited is the ultimate controlling party and parent undertaking.

6 EVENTS AFTER THE REPORTING PERIOD

On 9 March 2021, the Company's ultimate controlling party and parent undertaking, AA Limited (previously AA plc), was acquired by Basing Bidco Limited, a company controlled by TowerBrook Capital Partners (U.K.) LLP and Warburg Pincus International LLC (together, 'the Consortium'). AA Limited's ordinary shares were de-listed from the London Stock Exchange on 10 March 2021. AA Limited was re-registered as a private company on 17 March 2021. A number of new holding companies were incorporated above Basing Bidco Limited and the ultimate parent undertaking of the Company became Basing Consortiumco Limited.
