INTERPRETATION

- 1 In these Articles -
 - (a) "the Academy" means the school referred to in Article 4(a) and established by the Academy Trust,
 - (b) "Academy Financial Year" means the academic year from 1st of September to 31st of August the following year,
 - (c) "the Academy Trust" means the company intended to be regulated by these Articles and referred to in Article 2,
 - (ca) "Address" has the meaning given in Article 129,
 - (d) "the Articles" means these articles of association of the Academy Trust,
 - (e) "Chief Inspector" means Her Majesty's Chief Inspector of Education, Children's Services and Skills or his or her successor,
 - (f) "Clear Days" in relation to the period of a notice means the period excluding the day when the notice is given or deemed to be given and the day on which it is to take effect,

- (fa) "Community Governors" means the Governors appointed pursuant to Article 46 who may be or represent parents, residents, employers or educational institutions from the local community,
- (g) "Clerk" means the clerk to the Governors or any other person appointed to perform the duties of the clerk to the Governors, including a joint, assistant or deputy clerk,
- (ga) "Co-opted Governor" has the meaning given in Article 59,
- (h) "Financial Expert" means an individual, company or firm who is authorised to give investment advice under the Financial Services and Markets Act 2000,
- (i) "Funding Agreement" means the agreement made under section 1 of the Academies Act 2010 between the Academy Trust and the Secretary of State to establish the Academy,
- (J) "the Governors" means the directors of the Academy Trust (and "Governor" means any one of those directors), subject to the definition of this term at Article 6 10(b) in relation to Articles 6 2-6 10. The Governors are charity trustees as defined by section 177 of the Charities Act 2011 as amended or re-enacted from time to time,
- (ja) "Governing Body" means the board of Governors of the Academy Trust,
- (k) "Local Authority Associated Persons" means any person associated with any local authority within the meaning given in section 69 of the Local Government and Housing Act 1989 as amended or re-enacted from time to time;
- (ka) "Maintained School" means the maintained school known as Sunnyside Primary School at Manor Farm Way, Coulby Newham Middlesbrough TS8 0RJ,

- (i) "Member" means a member of the Academy Trust and someone who as such is bound by the undertaking contained in Article 8,
- (m) "the Memorandum" means the memorandum of association of the Academy Trust,
- (n) "Office" means the registered office of the Academy Trust,
- (na) "Parent" has the meaning given to it in section 576 of the Education Act 1996,
- (o) "the Parent Governors" means the Governors appointed pursuant to Articles 53 to 58 inclusive,
- (p) "Principal" means the head teacher of the Academy,
- (q) "Principal Regulator" means the body or person appointed as the Principal Regulator under the Charities Act 2011 as amended or re-enacted from time to time,
- (r) "the Seal" means the common seal of the Academy Trust if it has one,
- (s) "Secretary of State" means the Secretary of State for Education or successor,
- (sa) "Site" means the land and buildings occupied by the Academy Trust at Manor Farm Way, Coulby Newham Middlesbrough TS8 0RJ.
- (t) "Staff Governor" means an employee of the Academy Trust other than the Principal who may be appointed as a Governor pursuant to Article 50A,
- (u) "Teacher" means a person employed under a contract of employment or a contract for services or otherwise engaged to provide his or her services as a teacher at the Academy,

- (ua) "Trust Governor" means a Governor nominated by the Umbrella Trust,
- (ub) "Umbrella Trust" means The Discovery Alliance Umbrella Trust, a charitable company limited by guarantee,
- (v) "the United Kingdom" means Great Britain and Northern Ireland,
- (w) words importing the masculine gender only shall include the feminine gender. Words importing the singular number shall include the plural number, and vice versa,
- (x) subject as aforesaid, words or expressions contained in these Articles shall, unless the context requires otherwise, bear the same meaning as in the Companies Act 2006, as appropriate,
- (y) any reference to a statute or statutory provision shall include any statute or statutory provision which replaces or supersedes such statute or statutory provision including any modification or amendment thereto
- The company's name is Sunnyside Academy (and in this document it is called "the Academy Trust")
- The Academy Trust's registered office is to be situated in England and Wales

OBJECTS AND POWERS

- The Academy Trust's objects ("the Objects") are specifically restricted to the following
 - (a) to advance for the public benefit education in the United Kingdom, in particular but without prejudice to the generality of the foregoing by establishing, maintaining, carrying on, managing and developing a school offering a broad and balanced curriculum ("the Academy"), and

- (b) to promote for the benefit of inhabitants of Middlesbrough and the surrounding areas the provision of facilities for sport, recreation or other leisure time occupation of individuals who have need of such facilities by reason of their youth, age, infirmity or disablement, poverty, financial hardship or social and economic circumstances or for the public at large in the interests of social welfare and with the object of improving conditions of life of the said inhabitants
- In furtherance of the Objects but not further or otherwise the Academy

 Trust may exercise the following powers -
 - (a) to draw, make, accept, endorse, discount, execute and issue promissory notes, bills, cheques and other instruments, and to operate bank accounts in the name of the Academy Trust,
 - (b) to raise funds and to invite and receive contributions provided that in raising funds the Academy Trust shall not undertake any substantial permanent trading activities and shall conform to any relevant statutory regulations,
 - (c) to acquire, alter, improve and (subject to such consents as may be required by law) to charge or otherwise dispose of property,
 - (d) subject to Article 6 below to employ such staff, as are necessary for the proper pursuit of the Objects and to make all reasonable and necessary provision for the payments of pensions and superannuation to staff and their dependants,
 - to establish or support, whether financially or otherwise, any charitable companies, trusts, associations or institutions formed for all or any of the Object,
 - (f) to co-operate with other charities, other independent and maintained schools, other educational institutions, voluntary bodies and statutory authorities operating in furtherance of

theObjects and to exchange information and advice with them,

- (g) to pay out of funds of the Academy Trust the costs, charges and expenses of and incidental to the formation and registration of the Academy Trust,
- (h) to establish, maintain, carry on, manage and develop the Academy at Manor Farm Way, Coulby Newham Middlesbrough TS8 0RJ,
- (i) to offer scholarships, exhibitions, prizes and awards to pupils and former pupils, and otherwise to encourage and assist pupils and former pupils,
- to provide educational facilities and services to students of all ages and the wider community for the public benefit,
- (k) to carry out research into the development and application of new techniques in education in particular in relation to its approach to curriculum development and delivery and to publish the results of such research, and to develop means of benefiting from application of the experience of industry, commerce, other schools or educational institutions and the voluntary sector to the education of pupils in academies,
- (I) subject to such consents as may be required by law and/or by any contract entered into by or on behalf of the Academy Trust to borrow and raise money for the furtherance of the Object in such manner and on such security as the Academy Trust may think fit,
- (m) to deposit or invest any funds of the Academy Trust not immediately required for the furtherance of its Objects (but to invest only after obtaining such advice from a Financial Expert as the Governors consider necessary and having regard to the suitability of investments and the need for diversification),

- (n) to delegate the management of investments to a Financial Expert, but only on terms that
 - (i) the investment policy is set down in writing for the Financial Expert by the Governors,
 - (II) every transaction is reported promptly to the Governors,
 - (iii) the performance of the investments is reviewed regularly with the Governors,
 - (iv) the Governors are entitled to cancel the delegation arrangement at any time,
 - (v) the investment policy and the delegation arrangement are reviewed at least once a year,
 - (vi) all payments due to the Financial Expert are on a scale or at a level which is agreed in advance and are notified promptly to the Governors on receipt, and
 - (vii) the Financial Expert must not do anything outside the powers of the Governors
- (o) to arrange for investments or other property of the Academy Trust to be held in the name of a nominee company acting under the control of the Governors or of a Financial Expert acting under their instructions, and to pay any reasonable fee required,
- (p) to provide indemnity insurance to Governors in accordance with, and subject to the conditions of section 232 to 235 of the Companies Act 2006, section 189 of the Charities Act 2011 or any other provision of law applicable to charitable companies and any such indemnity is limited accordingly,
- (q) to establish subsidiary companies to carry on any trade or business for the purpose of raising funds for the Academy Trust,

(r) to do all such other lawful things as are necessary for or are incidental to or conducive to the achievement of the Objects

APPLICATION OF INCOME AND PROPERTY

- The income and property of the Academy Trust shall be applied solely towards the promotion of the Objects
- None of the income or property of the Academy Trust may be paid or transferred directly or indirectly by way of dividend bonus or otherwise by way of profit to any Member of the Academy Trust Nonetheless a Member of the Academy Trust who is not also a Governor may
 - (a) benefit as a beneficiary of the Academy Trust,
 - (b) be paid reasonable and proper remuneration for any goods or services supplied to the Academy Trust,
 - (c) be paid rent for premises let by the Member of the Academy

 Trust if the amount of the rent and other terms of the letting are
 reasonable and proper, and
 - (d) be paid interest on money lent to the Academy Trust at a reasonable and proper rate, such rate not to exceed 2 per cent per annum below the base lending rate of a UK clearing bank selected by the Governors, or 0 5%, whichever is the higher
- A Governor may benefit from any indemnity insurance purchased at the Academy Trust's expense to cover the liability of the Governors which by virtue of any rule of law would otherwise attach to them in respect of any negligence, default or breach of trust or breach of duty of which they may be guilty in relation to the Academy Trust provided that any such insurance shall not extend to
 - (i) any claim arising from any act or omission which the Governors knew to be a breach of trust or breach of duty or which was committed by the Governors in reckless disregard to whether it

was a breach of trust or breach of duty or not, and

(ii) the costs of any unsuccessful defence to a criminal prosecution brought against the Governors in their capacity as directors of the Academy Trust

Further, this Article does not authorise a Governor to benefit from any indemnity insurance that would be rendered void by any provision of the Companies Act 2006, the Charities Act 2011 or any other provision of law

- A Company, which has shares listed on a recognised stock exchange and of which any one Governor holds no more than 1% of the issued capital of that company, may receive fees, remuneration or other benefit in money or money's worth from the Academy Trust
- A Governor may at the discretion of the Governors be reimbursed from the property of the Academy Trust for reasonable expenses properly incurred by him or her when acting on behalf of the Academy Trust, but excluding expenses in connection with foreign travel
- 6 6 No Governor may
 - (a) buy any goods or services from the Academy Trust,
 - (b) sell goods, services, or any interest in land to the Academy Trust,
 - (c) be employed by or receive any remuneration from the Academy Trust (other than the Principal or a Staff Governor whose employment and/or remuneration is subject to the procedure and conditions in Article 6 8),
 - (d) receive any other financial benefit from the Academy Trust, unless
 - (i) the payment is permitted by Article 6 7 and the Governors follow

the procedure and observe the conditions set out in Article 6 8, or

- (ii) the Governors obtain the prior written approval of the Charity Commission and fully comply with any procedures it prescribes
- 6 7 Subject to Article 6 8, a Governor may
 - (a) receive a benefit from the Academy Trust in the capacity of a beneficiary of the Academy Trust,
 - (b) be employed by the Academy Trust or enter into a contract for the supply of goods or services to the Academy Trust, other than for acting as a Governor,
 - receive interest on money lent to the Academy Trust at a reasonable and proper rate not exceeding 2% per annum below the base rate of a clearing bank to be selected by the Governors, or 0.5%, whichever is the higher, and
 - (d) receive rent for premises let by the Governor to the Academy
 Trust if the amount of the rent and the other terms of the lease
 are reasonable and proper
- The Academy Trust and its Governors may only rely upon the authority provided by Article 6.7 if each of the following conditions is satisfied
 - (a) the remuneration or other sums paid to the Governor do not exceed an amount that is reasonable in all the circumstances
 - (b) the Governor is absent from the part of any meeting at which there is discussion of
 - (i) his or her employment, remuneration, or any matter concerning the contract, payment or benefit, or
 - (ii) his or her performance in the employment, or his or her performance of the contract, or

- (iii) any proposal to enter into any other contract or arrangement with him or her or to confer any benefit upon him or her that would be permitted under Article 6.7, or
- (iv) any other matter relating to a payment or the conferring of any benefit permitted by Article 6 7
- (c) the Governor does not vote on any such matter and is not to be counted when calculating whether a quorum of Governors is present at the meeting
- (d) save in relation to employing or contracting with the Principal or a Staff Governor the other Governors are satisfied that it is in the interests of the Academy Trust to employ or to contract with that Governor rather than with someone who is not a Governor. In reaching that decision the Governors must balance the advantage of employing a Governor against the disadvantages of doing so (especially the loss of the Governor's services as a result of dealing with the Governor's conflict of interest)
- (e) the reason for their decision is recorded by the Governors in the minute book
- (f) a majority of the Governors then in office have received no such payments or benefit
- The provision in clause 6 6 (c) that no Governor may be employed by or receive any remuneration from the Academy Trust (other than the Principal or a Staff Governor) does not apply to an existing employee of the Academy Trust who is subsequently elected or appointed as a Governor save that this clause shall only allow such a Governor to receive remuneration or benefit from the Academy Trust in his or her capacity as an employee of the Academy Trust and provided that the procedure as set out in Articles 6 8(b)(i), (ii) and 6 8 (c) is followed

6 10 In Articles 6 2 - 6 10

- (a) "Academy Trust" shall include any company in which the Academy Trust
 - holds more than 50% of the shares, or
 - controls more than 50% of the voting rights attached to the shares, or
 - has the right to appoint one or more directors to the board of the company
- (b) "Governor" shall include any child, stepchild, parent, grandchild, grandparent, brother, sister, civil partner or spouse of the governor or any person living with the governor as his or her partner
- (c) the employment or remuneration of a Governor includes the engagement or remuneration of any firm or company in which the Governor is
 - (i) a partner,
 - (II) an employee,
 - (III) a consultant,
 - (iv) a director,
 - (v) a member, or
 - (vi) a shareholder, unless the shares of the company are listed on a recognised stock exchange and the Governor holds less than 1% of the issued capital

LIMITATION OF LIABILITY

7 The liability of the Members of the Academy Trust is limited

8 Every Member of the Academy Trust undertakes to contribute such amount as may be required (not exceeding £10) to the Academy Trust's assets if it should be wound up while he or she is a Member or within one year after he or she ceases to be a Member, for payment of the Academy Trust's debts and liabilities before he or she ceases to be a Member, and of the costs, charges and expenses of winding up, and for the adjustment of the rights of the contributories among themselves

RESIDUAL ASSETS

If the Academy Trust is wound up or dissolved and after all its debts and liabilities (including any under section 2 of the Academies Act 2010) have been satisfied there remains any property it shall not be paid to or distributed among the Members of the Academy Trust (except to any Member which is itself a charity chosen under the provisions hereinafter), but shall be given or transferred to some other charity or charities having objects similar to the Objects which prohibits the distribution of its or their income and property to an extent at least as great as is imposed on the Academy Trust by Article 6 above, chosen by the Members of the Academy Trust at or before the time of dissolution and if that cannot be done then to some other charitable object

10 Not used

11 No alteration or addition shall be made to or in the provisions of the Articles which would have the effect (a) that the Academy Trust would cease to be a company to which section 60 of the Companies Act 2006 applies, or (b) that the Academy Trust would cease to be a charity

MEMBERS

- 12 The Members of the Academy Trust shall comprise
 - (a) the signatories to the Memorandum,
 - (b) Not used

- (c) the Chair of the Governors, and
- (d) any other persons appointed under Article 16
- 13 Each of the persons entitled to appoint Members in Article 12 shall have the right from time to time by written notice delivered to the Office to remove any Member appointed by them and to appoint a replacement Member to fill a vacancy whether resulting from such removal or otherwise
- 14 If any of the persons entitled to appoint Members in Article 12
 - (a) in the case of an individual, die or become legally incapacitated or otherwise incapable by reason of illness or injury of managing and administering their own affairs,
 - (b) In the case of a corporate entity, cease to exist and are not replaced by a successor institution,
 - (c) becomes insolvent or makes any arrangement or composition with their creditors generally, or
 - (d) ceases to be a Member,

their right to appoint Members under these Articles shall vest in the remaining Members

- 15 Membership will terminate automatically if
 - (a) a Member (which is a corporate entity) ceases to exist and is not replaced by a successor institution,
 - (b) a Member (which is an individual) dies or becomes legally incapacitated or otherwise incapable by reason of illness or injury of managing and administering his own affairs, or
 - (c) a Member becomes insolvent or makes any arrangement or composition with that Member's creditors generally

- 15A The Members may agree unanimously in writing to remove any Member(s) who is a signatory to the Memorandum (save that the agreement of a signatory to the Memorandum who is to be removed shall not be required), provided that it is in the interests of the Academy Trust to remove such a Member(s)
- The Members may agree by passing a special resolution in writing to appoint such additional Members as they think fit and may agree by passing a special resolution in writing to remove any such additional Members, provided that such appointment or removal is in the interests of the Academy Trust
- 17 Every person nominated to be a Member of the Academy Trust shall either sign a written consent to become a Member or sign the register of Members on becoming a Member
- Any Member may resign provided that after such resignation the number of Members is not less than three. A Member shall cease to be one immediately on the receipt by the Academy Trust of a notice in writing signed by the person or persons entitled to remove him or her under Articles 13 or 16 provided that no such notice shall take effect when the number of Members is less than three unless it contains or is accompanied by the appointment of a replacement Member.

GENERAL MEETINGS

- 19 Not used
- The Governors may call general meetings and, on the requisition of Members pursuant to the provisions of the Companies Act 2006, shall forthwith proceed to convene a general meeting in accordance with that Act If there are not within the United Kingdom sufficient Governors to call a general meeting, any Governor or any Member of the Academy Trust may call a general meeting

NOTICE OF GENERAL MEETINGS

- 21 General meetings shall be called by at least fourteen Clear Days' notice but a general meeting may be called by shorter notice if it is so agreed by a majority in number of Members having a right to attend and vote and together representing not less than 90% of the total voting rights at that meeting
- 21A The notice shall specify the date, time and place of the meeting and the general nature of the business to be transacted and, in the case of an annual general meeting, shall specify the meeting as such. The notice shall also state that the Member is entitled to appoint a proxy. If a special resolution is to be proposed, the notice must include the proposed resolution and specify that it is proposed as a special resolution.
- 21B The notice shall be given to all the Members, to the Governors and auditors
- The accidental omission to give notice of a meeting to, or the nonreceipt of notice of a meeting by, any person entitled to receive notice shall not invalidate the proceedings at that meeting

PROCEEDINGS AT GENERAL MEETINGS

- No business shall be transacted at any meeting unless a quorum is present. A Member counts towards the quorum by being present either in person or by proxy. Two persons entitled to vote upon the business to be transacted, each being a Member or a proxy of a Member or a duly authorised representative of a Member organisation shall constitute a quorum.
- If a quorum is not present within half an hour from the time appointed for the meeting, or if during a meeting a quorum ceases to be present, the meeting shall stand adjourned to the same day in the next week at the same time and place or to such time and place as the Governors

may determine

- The Chair, if any, of the Governors or in his or her absence some other Governor nominated by the Governors shall preside as chair of the meeting, but if neither the Chair nor such other Governor (if any) be present within fifteen minutes after the time appointed for holding the meeting and willing to act, the Governors present shall elect one of their number to be chair of the meetingand, if there is only one Governor present and willing to act, he or she shall be the chair of the meeting
- If no Governor is willing to act as chair of the meeting, or if no Governor is present within fifteen minutes after the time appointed for holding the meeting, the Members present and entitled to vote shall choose one of their number to be chair of the meeting
- A Governor shall, notwithstanding that he or she is not a Member, be entitled to attend and speak at any general meeting
- The chair of the meeting may, with the consent of a majority of the Members at a meeting at which a quorum is present (and shall if so directed by the meeting), adjourn the meeting from time to time and from place to place, but no business shall be transacted at any adjourned meeting other than the business which might properly have been transacted at the meeting had the adjournment not taken place. When a meeting is adjourned for fourteen days or more, at least seven Clear Days' notice shall be given specifying the time, date and place of the adjourned meeting and the general nature of the business to be transacted. Otherwise it shall not be necessary to give any such notice.

VOTING PROCEDURE

A resolution put to the vote of the meeting shall be decided on a show of hands unless before, or on the declaration of the result of the show of hands a poll is duly demanded. Subject to the provisions of the

Companies Act 2006, a poll may be demanded -

- (a) by the chair of the meeting, or
- (b) by at least two Members having the right to vote at the meeting,or
- (c) by a Member or Members representing not less than one-tenth of the total voting rights of all the Members having the right to vote at the meeting
- 30 Unless a poll is duly demanded a declaration by the chair of the meeting that a resolution has been carried or carried unanimously, or by a particular majority, or lost, or not carried by a particular majority and an entry to that effect in the minutes of the meeting shall be conclusive evidence of the fact without proof of the number or proportion of the votes recorded in favour of or against such resolution
- 31 The demand for a poll may be withdrawn, before the poll is taken, but only with the consent of the chair of the meeting. The withdrawal of a demand for a poll shall not invalidate the result of a show of hands declared before the demand for the poll was made.
- A poll shall be taken as the chair of the meeting directs and he or she may appoint scrutineers (who need not be Members) and fix a time, date and place for declaring the results. The result of the poll shall be deemed to be the resolution of the meeting at which the poll was demanded
- A poll demanded on the election of the chair of the meeting or on a question of adjournment shall be taken immediately. A poll demanded on any other question shall be taken either immediately or at such time, date and place as the chair of the meeting directs not being more than thirty days after the poll is demanded. The demand for a poll shall not prevent continuance of a meeting for the transaction of any business other than the question on which the poll is demanded. If a poll is

demanded before the declaration of the result of a show of hands and the demand is duly withdrawn, the meeting shall continue as if the demand had not been made

- No notice need be given of a poll not taken immediately if the time, date and place at which it is to be taken are announced at the meeting at which it is demanded. In other cases at least seven Clear Days' notice shall be given specifying the time, date and place at which the poll is to be taken.
- 35. A resolution in writing agreed by such number of Members as required if it had been proposed at a general meeting shall be as effectual as if it had been passed at a general meeting duly convened and held provided that a copy of the proposed resolution has been sent to every Member. The resolution may consist of several instruments in the like form each agreed by one or more Members.

VOTES OF MEMBERS

- On the show of hands every Member present in person shall have one vote On a poll every Member present in person or by proxy shall have one vote
- 37 Not used
- 38 No Member shall be entitled to vote at any general meeting unless all moneys then payable by him or her to the Academy Trust have been paid
- No objections shall be raised to the qualification of any person to vote at any general meeting except at the meeting or adjourned meeting at which the vote objected to is tendered, and every vote not disallowed at the meeting shall be valid. Any objection made in due time shall be referred to the chair of the meeting whose decision shall be final and conclusive

PROXIES

An instrument appointing a proxy shall be in writing, signed by or on behalf of the appointer and shall be in the following form (or in a form as near thereto as circumstances allow or in any other form which is usual or which the Governors may approve) -

"I/We, , of , being a Member/Members of the above named Academy Trust, hereby appoint of , or in his or her absence, . of as my/our proxy to attend, speak and vote in my/our name[s] and on my/our behalf at the annual general meeting/ general meeting of the Academy Trust to be held on . 20[], and at any adjournment thereof

Where it is desired to afford Members an opportunity of instructing the proxy how he or she shall act the instrument appointing a proxy shall be in the following form (or in a form as near thereto as circumstances allow or in any other form which is usual or which the Governors may approve) -

and an instrument of proxy which is not deposited or delivered in a manner so permitted shall be invalid

A vote given or poll demanded by proxy or by the duly authorised representative of a corporation shall be valid notwithstanding the previous determination of the authority of the person voting or demanding a poll unless notice of the determination was received by the Academy Trust at the Office or at such other place at which the instrument of proxy was duly deposited before the commencement of the meeting or adjourned meeting at which the vote given or the poll

demanded or (or in the case of a poll taken otherwise than on the same day as the meeting or adjourned meeting) the time appointed for taking the poll

had not been given. The powers given by this Article shall not be limited by any special power given to the Governors by the Articles and a meeting of Governors at which a quorum is present may exercise all the powers exercisable by the Governors

- In addition to all powers hereby expressly conferred upon them and without detracting from the generality of their powers under the Articles the Governors shall have the following powers, namely
 - (a) to expend the funds of the Academy Trust in such manner as they shall consider most beneficial for the achievement of the Object and to invest in the name of the Academy Trust such part of the funds as they may see fit and to direct the sale or transposition of any such investments and to expend the proceeds of any such sale in furtherance of the Object, and

A Governor must absent himself or herself from any discussions of the Governors in which it is possible that a conflict

will arise between his or her duty to act solely in the interests of the Academy Trust and any duty or personal interest (including but not limited to any Personal Financial Interest)

99 For the purpose of Article 98, a Governor has a Personal Financial Interest in the employment or remuneration of, or the provision of any other benefit to, that Governor as permitted by and as defined by Articles 6 5-6 10

THE MINUTES

The minutes of the proceedings of a meeting of the Governors shall be drawn up and entered into a book kept for the purpose by the person acting as Clerk for the purposes of the meeting, and shall be signed (subject to the approval of the Governors) at the same or next subsequent meeting by the person acting as chair thereof

COMMITTEES

Subject to these Articles, the Governors may establish any committee Subject to these Articles, the constitution, membership and proceedings of any committee shall be determined by the Governors. The establishment, terms of reference, constitution and membership of any committee of the Governors shall be reviewed at least once in every twelve months. The membership of any committee of the Governors may include persons who are not Governors, provided that a majority of members of any such committee shall be Governors. The Governors may determine that some or all of the members of a committee who are not Governors shall be entitled to vote in any proceedings of the committee. No vote on any matter shall be taken at a meeting of a committee of the Governors unless the majority of members of the committee present are Governors.

DELEGATION

102 The Governors may delegate to any Governor, committee, the

Principal or any other holder of an executive office, such of their powers or functions as they consider desirable to be exercised by them. Any such delegation may be made subject to any conditions the Governors may impose and may be revoked or altered.

MEETINGS OF THE GOVERNORS

The Governors may from time to time appoint any person whether or not a Member of the Academy Trust to be a patron of the Academy Trust or to hold any honorary office and may determine for what period he or she is to hold such office

THE SEAL

The Seal, if any, shall only be used by the authority of the Governors or of a committee of Governors authorised by the Governors. The Governors may determine who shall sign any instrument to which the Seal is affixed and unless otherwise so determined it shall be signed by a Governor and by the Clerk or by a second Governor.

ACCOUNTS

126 Accounts shall be prepared in accordance with the relevant Statement of Recommended Practice as if the Academy Trust was a non-exempt charity and Parts 15 and 16 of the Companies Act 2006 and shall file these with the Secretary of State and the Principal Regulator by 31 December each Academy Financial Year

The Governors shall comply with their obligations under Part 24 of the Companies Act 2006 (or any statutory re-enactment or modification of that Act) with regard to the preparation of an annual return to the Registrar of Companies and in accordance with the Statement of Recommended Practice as if the Academy Trust was a non-exempt charity and to the Secretary of State and the Principal Regulator by 31 December each Academy Financial Year

NOTICES

Any notice to be given to or by any person pursuant to the Articles (other than a notice calling a meeting of the Governors) shall be in

INDEMNITY

other officer or auditor of the Academy Trust shall be indemnified out of the assets of the Academy Trust against any liability incurred by him or her in that capacity in defending any proceedings, whether civil or criminal, in which judgment is given in favour or in which he or she is acquitted or in connection with any application in which relief is granted to him or her by the court from liability for negligence, default, breach of duty or breach of trust in relation to the affairs of the Academy Trust

RULES

- The Governors may from time to time make such rules or bye laws as they may deem necessary or expedient or convenient for the proper conduct and management of the Academy Trust and for purposes of prescribing classes of and conditions of membership, and in particular but without prejudice to the generality of the foregoing, they may by such rules or bye laws regulate

 - (d) he procedure at general meetings and meetings of the Governors and committees of the Governors in so far as such procedure is not regulated by the Articles, and

- 139 If at the time of either his or her becoming a Member of the Academy Trust or his or her first appointment to office as a Governor any Member or Governor was not a Local Authority Associated Person but later becomes so during his or her membership or tenure as a Governor he or she shall be deemed to have immediately resigned his or her membership and/or resigned from his or her office as a Governor as the case may be
- Authority Associated Persons would (but for Articles 136 to 139 inclusive) represent 20% or more of the total number of Governors or Members (as the case may be) then a sufficient number of the Governors or Members (as the case may be) who are Local Authority Associated Persons shall be deemed to have resigned as Governors or Members (as the case may be) immediately before the occurrence of such an event to ensure that at all times the number of such Governors or Members (as the case may be) is never equal to or greater than 20% of the total number of Governors or Members (as the case may be) Governors or Members (as the case may be) who are Local Authority Associated Persons shall be deemed to have resigned in order of their appointment date the most recently appointed resigning first
- 141 The Members will each notify the Academy Trust and each other if at any time they believe that the Academy Trust or any of its subsidiaries has become subject to the influence of a local authority (as described in section 69 of the Local Government and Housing Act 1989)
