- 3 That the sum of £0.0195586 from the share premium account of the Company be capitalised and, disapplying Article 36(2)(b) of the Model Articles, as incorporated by Article 25 of the Company's Articles of Association, such that the capitalised amounts shall be applied in paying up in full 195,586 Ordinary D Shares of £0.0000001 each in the capital of the Company to be allotted as determined by the Directors to the Ordinary D Shareholders.
