DIRECTORS' REPORT

The Directors present their annual report and the audited financial statements of Advanced Medical Solutions (Europe) Limited (the "Company") for the year ended 31 December 2019. The Directors' Report has been prepared in accordance with the provisions relating to small companies under section 417(1) of the Companies Act 2006.

The accompanying financial statements have been prepared in accordance with Financial Reporting Standard 101-Reduced Disclosure Framework (FRS 101). The Company has taken advantage of the disclosure exemptions allowed under this standard. The Company has also taken advantage of the exemption from presenting a Strategic Report.

PRINCIPAL ACTIVITIES

The principal activity of the Company is as an investment company. The Company's functional currency is Euros.

RESULTS, OUTLOOK AND DIVIDENDS

The results for the year and the Company's financial position at the end of the year are shown in the attached financial statements. Net assets were €59,722,793 at 31 December 2019 (2018: €59,386,088) and the profit for the year ended 31 December 2019 was €1,903,868 (2018: €1,908,526).

The Directors anticipate the performance and results of the Company to continue at current levels in the future.

During the year the Company paid dividends of ϵ 1,567,163 (2018: ϵ 1,571,178).

GOING CONCERN

In carrying out their duties in respect of going concern, the Directors have carried out a review of the Company's financial position and cash flow forecasts for the next 12 months from signing of the financial statements. These have been based on a comprehensive review of revenue, expenditure and cash flows, taking into account specific business risks and the current economic environment.

The Directors consider the Company has sufficient financial resources and it is well placed to manage its business risks successfully. The Company is profitable and has significant net assets. Furthermore, the Company forms part of Advanced Medical Solutions Group PLC "the Group" which had cash and cash equivalents at the same year end of £64.8 million (2018: £76.4 million) and had minimal debt (2018: debt free). The Group agreed a five-year, £80 million, multi-currency, revolving credit facility in December 2018 with an accordion option under which it can request up to an additional £20 million on the same terms. The facility is provided jointly by the Group's existing bank HSBC, as well as The Royal Bank of Scotland PLC. It is unsecured on the assets of the Group and is currently undrawn.

While the current economic environment is uncertain, in particular in relation to COVID-19, the Group operates in a market whose demographics are favourable, underpinned by an increasing need for products to treat chronic and acute wounds. Consequently, market growth is predicted for the medium-term once the impact of COVID-19 subsides. The Group has a number of long-term contracts with customers across different geographic regions and also with substantial financial resources, ranging from government agencies through to global healthcare companies.

Having taken the above into consideration, the Directors have reached the conclusion that the Company is well placed to manage its business risks in the current economic environment. Accordingly, they continue to adopt the going concern basis in preparing the financial statements.

DIRECTORS' REPORT (CONTINUED)

PRINCIPAL RISKS AND UNCERTAINTIES

Interest rate risk and credit risk

The Company has interest-bearing assets. The interest-bearing assets earn interest at floating rates. Loans made by the Company are exposed to the credit risk of the counterparty. All counterparties are other companies within the Advanced Medical Solutions Group. The credit risk and all other risks are managed by the Group.

NOTES TO THE FINANCIAL STATEMENTS For the year ended 31 December 2019

1. GENERAL INFORMATION

Advanced Medical Solutions (Europe) Limited is a private company limited by shares, registered in England and Wales and incorporated in the United Kingdom under the Companies Act 2006. The address of the registered office is given on page 1. The Company is a wholly-owned subsidiary and is included within the consolidated financial statements of Advanced Medical Solutions Group plc. The registered address of the parent Company providing consolidated financial statements is Premier Park, 33 Road One, Winsford Industrial Estate, Winsford, Cheshire, CW7 3RT.

2. ACCOUNTING POLICIES

Basis of accounting

The Company meets the definition of a qualifying entity under FRS 100 'Application of Financial Reporting Requirements' issued by the Financial Reporting Council. Accordingly these financial statements were prepared in accordance with Financial Reporting Standard 101 'Reduced Disclosure Framework'.

As permitted by FRS 101, the Company has taken advantage of the disclosure exemptions available under that standard in relation to presentation of an opening statement of financial position at the date of transition, presentation of a cash flow statement, standards not yet effective, related party transactions and financial instruments.

Where relevant, equivalent disclosures have been given in the group accounts of Advanced Medical Solutions Group plc. The group accounts of Advanced Medical Solutions Group plc are available to the public and can be obtained as set out in note 12.

The financial statements have been prepared under the historical cost convention and are presented in Euros, which is the functional currency of the Company. The accounting policies set out below have been applied consistently to all periods presented in these financial statements.

Going concern

As shown in the statement of financial position the Company has net assets of 659,722,793 (2018: 659,386,088). The Company's forecasts and projections, taking account of reasonably possible changes in the trading performance of the entities within which the Company's credit risk resides within, show that the Company should be able to meet its liabilities as they fall due.

Taking the above into account, the Directors have formed a judgement that, at the time of approving the financial statements, and having considered the Company's forecasts and projections, there is a reasonable expectation that the Company has adequate resources to continue in operation for the foreseeable future, despite the impact of Covid-19. In light of the Covid-19 pandemic, sensitivity analysis has been prepared to stress test forecasts and the Directors are confident the business can withstand the challenges.

All Group sites are currently in operation and meeting commitments to maintain supply of its medical devices to healthcare partners and customers worldwide. While the current economic environment is uncertain, in particular in relation to Covid-19, the Company operates as part of a Group whose markets demographics are favourable, underpinned by an increasing need for products to treat chronic and acute wounds. Consequently, market growth is predicted for the medium term once the impact of Covid-19 subsides.

Thus they continue to adopt the going concern basis of accounting in preparing the annual financial statements.

Taxation

Current tax is provided at amounts expected to be paid (or recovered) using the tax rates that have been enacted or substantively enacted by the statement of financial position date.

2. ACCOUNTING POLICIES (continued)

Recognition and valuation of financial assets

Financial instruments

Financial assets and financial liabilities are recognised in the Company's Statement of financial position when the Company becomes a party to the contractual provisions of the instrument. Financial assets are derecognised when the contractual rights to the cash flows from the financial asset expire or are transferred. Financial liabilities are derecognised when the obligation specified in the contract is discharged, cancelled or expires.

Cash and cash equivalents

Cash and cash equivalents comprise cash at the bank and in hand and are subject to insignificant risk in change in value.

Trade and other receivables

Trade receivables are recognised and carried at the lower of their original invoiced value and recoverable amount. An impairment is made when it is likely that the balance will not be recovered in full. The recoverable amount is calculated as the present value of estimated future cash flows. Estimated future cash flows are not discounted due to the relatively short period of time between recognition of trade receivables and receipt of cash.

Critical accounting judgements and key sources of estimation uncertainty

Given the nature of the Company the Directors do not consider there to be any critical accounting judgements or key sources of estimation uncertainty.

3. DIRECTORS' EMOLUMENTS

No Director received any emoluments for their services to the Company (2018: Enil).

4. EMPLOYEE INFORMATION

The Company had no employees during the year or the previous year and as a result incurred no employee costs.

The Finance Act No.2 2015 included provisions to reduce the UK corporation tax rate to 19% with effect from the 1 April 2017. Legislation to reduce the main rate of UK corporation tax to 17% was passed by parliament in September 2016 to take effect from 1 April 2020. Subsequent to year-end, parliament reversed this tax rate reduction in March 2020 and therefore the Company will apply revised substantively enacted rates in future reporting periods. The impact of the rate change is not deemed to be significant to the Company. The Company does not have any deferred tax.

12. IMMEDIATE AND ULTIMATE PARENT UNDERTAKING

The Company's parent company and ultimate controlling party is Advanced Medical Solutions Group plc, a Company registered in England and Wales. Advanced Medical Solutions Group plc is the parent undertaking of the smallest and largest group to consolidate these financial statements. The Group financial statements of Advanced Medical Solutions Group plc are available to the public and can be obtained from the registered office, Premier Park, 33 Road One, Winsford Industrial Estate, Winsford, Cheshire, CW7 3RT.

13. SUBSEQUENT EVENTS

Since the balance sheet date, the Group has been impacted by the COVID-19 pandemic.

The Company, as part of the Group, holds an intercompany loan which is interest bearing and is serviced by the trade of certain Group entities and therefore, it is important to consider the events wider impact on the Group. Given its strong cash position, the Group confirms it is in robust financial condition to weather the global disruption caused by the pandemic.

The Group's annual revenues were impacted by approximately 3% to 5% for each month the widespread restrictions were in place. In the second half of 2020 and as we move into 2021, as global lockdowns are eased and a version of normality returns, we expect the sales impact of COVID-19 to gradually reduce.

In this period of uncertainty, the Group continues to carefully manage its operating costs, working capital and capital expenditure to ensure that it remains in the strongest possible financial and operational position to return to strong growth when the Group's end markets recover to a more normal basis.

In summary, the Company does not expect a material impact to its financial performance or position as a result of COVID-19.
