Pursuant to Chapter 2 of Part 13 of the Companies Act 2006, the directors of the Company propose that resolution 1 and resolution 3 below are passed as special resolutions and resolution 2 and resolution 4 below are passed as ordinary resolutions (each a Resolution and together the Resolutions):

### SPECIAL RESOLUTION

1. THAT the articles of association in the form attached to these Resolutions be approved and with immediate effect adopted as the new articles of association of the Company in substitution for, and to the exclusion of, the existing articles of association of the Company.

## ORDINARY RESOLUTION

2. THAT, conditional upon the passing of Resolution 1, the directors of the Company (Directors) be generally and unconditionally authorised to allot shares in the Company up to an aggregate nominal amount of £18.90 provided that this authority shall, unless renewed, varied or revoked by the Company, expire on 27 September 2022. This authority revokes and replaces all unexercised authorities previously granted to the Directors but without prejudice to any allotment of shares already made or offered or agreed to be made pursuant to warrants granted by the Company.

### SPECIAL RESOLUTION

3. THAT, conditional upon the passing of Resolutions 1 and 2, the Directors shall be authorised to exercise the authority granted pursuant to Resolution 2 as if the provisions of articles 12.2-12.4 of the Company's articles of association did not apply.

### ORDINARY RESOLUTION

4. THAT the sale of certain assets comprising the Company's data privacy business to Notitia Solutions Limited (being a company connected with Robert Houghton and

Alan Stewart, each a director of the Company) pursuant to an assignment and licence agreement for the sum of £80,000 be approved.
