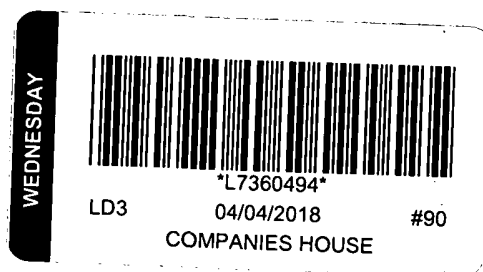

#### 1. ACCOUNTING POLICIES

##### 1.1 Basis of preparation of financial statements
