### INTERPRETATION

- 1 in these Articles
  - a "the Academy" means the school referred to in Article 4a and established by the Academy Trust,
  - b "Academy Financial Year" means the academic year from 1<sup>st</sup> of September to 31<sup>st</sup> of August the following year,
  - c "the Academy Trust" means the company intended to be regulated by these Articles and referred to in Article 2,
    - ca. "Address" has the meaning given in Article 129,
  - d "the Articles" means these articles of association of the Academy Trust;
  - e "Chief Inspector" means Her Majesty's Chief Inspector of Education, Children's Services and Skills or his or her successor,
  - f "Clear Days" in relation to the period of a notice means the period excluding the day when the notice is given or deemed to be given and the day on which it is to take effect,
  - f a"Community Governors" means the Governors appointed pursuant to Article 46 who may be or represent Parents, residents, employees or educational institutions from the local community,

- g "Clerk" means the clerk to the Governors or any other person appointed to perform the duties of the clerk to the Governors, including a joint, assistant or deputy clerk,
- g.a "Co-opted Governor" has the meaning given in Article 59,
- h "Financial Expert" means an individual, company or firm who is authorised to give investment advice under the Financial Services and Markets Act 2000,
- "Funding Agreement" means the agreement made under section 1 of the Academies Act 2010 between the Academy Trust and the Secretary of State to establish the Academy,
- "Governors" means the directors of the Academy Trust (and "Governor" means any one of those directors), subject to the definition of this term at Article 6 10(b) in relation to Articles 6 2-6 10. The Governors are charity trustees as defined by section 177 of the Charities Act 2011 as amended or re-enacted from time to time,
- Ja "Governing Body" means the board of Governors of the Academy Trust,
- k "Head" means the head teacher of the Academy,
- "Local Authority Associated Persons" means any person associated with any local authority within the meaning given in section 69 of the Local Government and Housing Act 1989,
- m "Member" means a member of the Academy Trust and someone who as such is bound by the undertaking contained in Article 8,
- n "the Memorandum" means the memorandum of association of the Academy Trust,
- "Office" means the registered office of the Academy Trust,
- o a "Parent" has the meaning given to it in section 576 of the Education Act 1996,
- p "the Parent Governors" means the Governors appointed pursuant to Articles 53 to 58 inclusive.

- p a "Predecessor School" means the maintained school known as Easterside Primary School at Erith Grove, Easterside, Middlesbrough, TS4 3RG,
- q "Principal Regulator" means the body or person appointed as the Principal Regulator under the Charities Act 2011,
- r "the Seal" means the common seal of the Academy Trust if it has one.
- s "Secretary of State" means the Secretary of State for Education or successor,
- s a "Site" means the land and buildings occupied by the Academy Trust at Erith Grove, Easterside, Middlesbrough, TS4 3RG,
- t "Staff Governor" means an employee of the Academy Trust other than the Head who may be appointed as a Governor pursuant to Article 50A.
- u "Teacher" means a person employed under a contract of employment or a contract for services or otherwise engaged to provide his or her services as a teacher at the Academy,
- u a "Trust Governor" means a Governor nominated by the Umbrella Trust.
- u b "Umbrella Trust" means The Discovery Alliance Umbrella Trust, a company limited by guarantee (company number 8809385),
- v "the United Kingdom" means Great Britain and Northern Ireland,
- w words importing the masculine gender only shall include the feminine gender. Words importing the singular number shall include the plural number, and vice versa,
- x subject as aforesaid, words or expressions contained in these Articles shall, unless the context requires otherwise, bear the same meaning as in the Companies Act 2006, as appropriate,
- y any reference to a statute or statutory provision shall include any

statute or statutory provision which replaces or supersedes such statute or statutory provision including any modification or amendment thereto

- The company's name is Easterside Academy (and in this document it is called "the Academy Trust")
- The Academy Trust's Office is to be situated in England and Wales

### **OBJECTS**

- The Academy Trust's objects ("the Objects") are specifically restricted to the following
  - (a) to advance for the public benefit education in the United Kingdom, in particular but without prejudice to the generality of the foregoing by establishing, maintaining, carrying on, managing and developing a school offering a broad and balanced curriculum ("the Academy"), and
  - (b) to promote for the benefit of inhabitants of Middlesbrough and the surrounding areas the provision of facilities for sport, recreation or other leisure time occupation of individuals who have need of such facilities by reason of their youth, age, infirmity or disablement, poverty, financial hardship or social and economic circumstances or for the public at large in the interests of social welfare and with the object of improving conditions of life of the said inhabitants
  - In furtherance of the Objects but not further or otherwise the Academy

    Trust may exercise the following powers -
    - (a) to draw, make, accept, endorse, discount, execute and issue promissory notes, bills, cheques and other instruments, and to operate bank accounts in the name of the Academy Trust,
    - (b) to raise funds and to invite and receive contributions provided that

in raising funds the Academy Trust shall not undertake any substantial permanent trading activities and shall conform to any relevant statutory regulations,

- (c) to acquire, alter, improve and (subject to such consents as may be required by law) to charge or otherwise dispose of property,
- (d) subject to Article 6 below to employ such staff, as are necessary for the proper pursuit of the Objects and to make all reasonable and necessary provision for the payments of pensions and superannuation to staff and their dependants,
- (e) to establish or support, whether financially or otherwise, any charitable companies, trusts, associations or institutions formed for all or any of the Objects,
- (f) to co-operate with other charities, other independent and maintained schools, other educational institutions, voluntary bodies and statutory authorities operating in furtherance of the Objects and to exchange information and advice with them,
- (g) to pay out of funds of the Academy Trust the costs, charges and expenses of and incidental to the formation and registration of the Academy Trust,
- (h) to establish, maintain, carry on, manage and develop the Academy at the Site,
- (i) to offer scholarships, exhibitions, prizes and awards to pupils and former pupils, and otherwise to encourage and assist pupils and former pupils,
- (j) to provide educational facilities and services to students of all ages and the wider community for the public benefit,
- (k) to carry out research into the development and application of new techniques in education in particular in relation to its approach to

curriculum development and delivery and to publish the results of such research, and to develop means of benefiting from application of the experience of industry, commerce, other schools or educational institutions and the voluntary sector to the education of pupils in the Academies,

- (I) subject to such consents as may be required by law and/or by any contract entered into by or on behalf of the Academy Trust to borrow and raise money for the furtherance of the Objects in such manner and on such security as the Academy Trust may think fit,
- (m) to deposit or invest any funds of the Academy Trust not immediately required for the furtherance of its Objects (but to invest only after obtaining such advice from a Financial Expert as the Governors consider necessary and having regard to the suitability of investments and the need for diversification),
- (n) to delegate the management of investments to a Financial Expert, but only on terms that
  - (i) the investment policy is set down in writing for the Financial Expert by the Governors,
  - (ii) every transaction is reported promptly to the Governors.
  - (III) the performance of the investments is reviewed regularly with the Governors,
  - (iv) the Governors are entitled to cancel the delegation arrangement at any time,
  - (v) the investment policy and the delegation arrangement are reviewed at least once a year,
  - (vi) all payments due to the Financial Expert are on a scale or at a level which is agreed in advance and are notified promptly to the Governors on receipt, and
  - (vii) the Financial Expert must not do anything outside

### the powers of the Governors

- (o) to arrange for investments or other property of the Academy Trust to be held in the name of a nominee company acting under the control of the Governors or of a Financial Expert acting under their instructions, and to pay any reasonable fee required,
- (p) to provide indemnity insurance to Governors in accordance with, and subject to the conditions of section 232 to 235 of the Companies Act 2006, section 189 of the Charities Act 2011 or any other provision of law applicable to charitable companies and any such indemnity is limited accordingly,
- (q) to establish subsidiary companies to carry on any trade or business for the purpose of raising funds for the Academy Trust,
- (r) to do all such other lawful things as are necessary for or are incidental to or conducive to the achievement of the Objects

### APPLICATION OF INCOME AND PROPERTY

- 6.1 The income and property of the Academy Trust shall be applied solely towards the promotion of the Objects
- None of the income or property of the Academy Trust may be paid or transferred directly or indirectly by way of dividend bonus or otherwise by way of profit to any Member of the Academy Trust Nonetheless a Member of the Academy Trust who is not also a Governor may
  - a) benefit as a beneficiary of the Academy Trust,
  - be paid reasonable and proper remuneration for any goods or services supplied to the Academy Trust,
  - c) be paid rent for premises let by the Member of the Academy
    Trust if the amount of the rent and other terms of the letting are
    reasonable and proper, and

- d) be paid interest on money lent to the Academy Trust at a reasonable and proper rate, such rate not to exceed 2 per cent per annum below the base lending rate of a UK clearing bank selected by the Governors, or 0.5%, whichever is the higher
- 6.3 A Governor may benefit from any indemnity insurance purchased at the Academy Trust's expense to cover the liability of the Governors which by virtue of any rule of law would otherwise attach to them in respect of any negligence, default or breach of trust or breach of duty of which they may be guilty in relation to the Academy Trust provided that any such insurance shall not extend to (i) any claim arising from any act or omission which the Governors knew to be a breach of trust or breach of duty or which was committed by the Governors in reckless disregard to whether it was a breach of trust or breach of duty or not, and (ii) the costs of any unsuccessful defence to a criminal prosecution brought against the Governors in their capacity as directors of the Academy Trust Further, this Article does not authorise a Governor to benefit from any indemnity insurance that would be rendered void by any provision of the Companies Act 2006, the Charities Act 2011 or any other provision of law
- 6 3A A Governor or other officer of the Academy Trust may receive an indemnity subject to, and in accordance with Article 133
- A Company, which has shares listed on a recognised stock exchange and of which any one Governor holds no more than 1% of the issued capital of that company, may receive fees, remuneration or other benefit in money or money's worth from the Academy Trust
- A Governor may at the discretion of the Governors be reimbursed from the property of the Academy Trust for reasonable expenses properly incurred by him or her when acting on behalf of the Academy Trust, but excluding expenses in connection with foreign travel

### 6 6 No Governor may

- (a) buy any goods or services from the Academy Trust,
- (b) sell goods, services, or any interest in land to the

Academy Trust,

- (c) be employed by or receive any remuneration from the Academy Trust (other than the Head or a Staff Governor whose employment and/or remuneration is subject to the procedure and conditions in Article 6 8),
- (d) receive any other financial benefit from the Academy Trust,

unless

- (i) the payment is permitted by Article 6.7 and the Governors follow the procedure and observe the conditions set out in Article 6.8, or
- (ii) the Governors obtain the prior written approval of the Charity Commission and fully comply with any procedures it prescribes

### 6.7 Subject to Article 6.8, a Governor may

- receive a benefit from the Academy Trust in the capacity of a beneficiary of the Academy Trust,
- b) be employed by the Academy Trust or enter into a contract for the supply of goods or services to the Academy Trust, other than for acting as a Governor,
- c) receive interest on money lent to the Academy Trust at a reasonable and proper rate not exceeding 2% per annum below the base rate of a clearing bank to be selected by the Governors, or 0.5%, whichever is the higher, and
- d) receive rent for premises let by the Governor to the Academy
  Trust if the amount of the rent and the other terms of the lease
  are reasonable and proper
- 6 8 The Academy Trust and its Governors may only rely upon the authority provided by Article 6 7 if each of the following conditions is satisfied
  - (a) the remuneration or other sums paid to the Governor do not exceed an

amount that is reasonable in all the circumstances

- (b) the Governor is absent from the part of any meeting at which there is discussion of
  - his or her employment, remuneration, or any matter concerning the contract, payment or benefit, or
  - ii) his or her performance in the employment, or his or her performance of the contract, or
  - any proposal to enter into any other contract or arrangement with him or her or to confer any benefit upon him or her that would be permitted under Article 6.7, or
  - (iv) any other matter relating to a payment or the conferring of any benefit permitted by Article 6.7
- (c) the Governor does not vote on any such matter and is not to be counted when calculating whether a quorum of Governors is present at the meeting
- (d) save in relation to employing or contracting with the Head or a Staff Governor the other Governors are satisfied that it is in the interests of the Academy Trust to employ or to contract with that Governor rather than with someone who is not a Governor. In reaching that decision the Governors must balance the advantage of employing a Governor against the disadvantages of doing so (especially the loss of the Governor's services as a result of dealing with the Governor's conflict of interest)
- (e) the reason for their decision is recorded by the Governors in the minute book
- (f) a majority of the Governors then in office have received no such payments or benefit
- 6 9 The provision in Clause 6 6 (c) that no Governor may be employed by

or receive any remuneration from the Academy Trust (other than the Head or a Staff Governor) does not apply to an existing employee of the Academy Trust who is subsequently elected or appointed as a Governor save that this clause shall only allow such a Governor to receive remuneration or benefit from the Academy Trust in his or her capacity as an employee of the Academy Trust and provided that the procedure as set out in Articles 6 8(b)(i), (ii) and 6 8 (c) is followed

#### 6 10 In Articles 6 2-6 10

- (a) "Academy Trust" shall include any company in which the Academy Trust
  - holds more than 50% of the shares, or
  - controls more than 50% of the voting rights attached to the shares, or
  - has the right to appoint one or more directors to the board of the company
- (b) "Governor" shall include any child, stepchild, parent, grandchild, grandparent, brother, sister, civil partner or spouse of the governor or any person living with the governor as his or her partner
- (c) the employment or remuneration of a Governor includes the engagement or remuneration of any firm or company in which the Governor is
  - (i) a partner,
  - (II) an employee,
  - (III) a consultant,
  - (iv) a director,
  - (v) a member, or
  - (vi) a shareholder, unless the shares of the company are listed on a recognised stock exchange and the Governor holds less than 1% of the issued capital

#### LIMITATION OF LIABILITY

- 7 The liability of the Members of the Academy Trust is limited
- 8 Every Member of the Academy Trust undertakes to contribute such amount as may be required (not exceeding £10) to the Academy Trust's assets if it should be wound up while he or she is a Member or within one year after he or she ceases to be a Member, for payment of the Academy Trust's debts and liabilities before he or she ceases to be a Member, and of the costs, charges and expenses of winding up, and for the adjustment of the rights of the contributories among themselves

#### **RESIDUAL ASSETS**

If the Academy Trust is wound up or dissolved and after all its debts and liabilities (including any under section 2 of the Academies Act 2010) have been satisfied there remains any property it shall not be paid to or distributed among the Members of the Academy Trust (except to any Member which is itself a charity chosen under the provisions hereinafter), but shall be given or transferred to some other charity or charities having objects similar to the Objects which prohibits the distribution of its or their income and property to an extent at least as great as is imposed on the Academy Trust by Article 6 above, chosen by the Members of the Academy Trust at or before the time of dissolution and if that cannot be done then to some other charitable object

No alteration or addition shall be made to or in the provisions of the Articles which would have the effect (a) that the Academy Trust would cease to be a company to which section 60 of the Companies Act 2006 applies, or (b) that the Academy Trust would cease to be a charity

### **MEMBERS**

- There shall be at least three Members of the Academy Trust The Members of the Academy Trust shall comprise
  - a the signatories to the Memorandum,

- b the chairman of the Governors, and
- c any person appointed under Article 16
- 13 Each of the persons entitled to appoint Members in Article 12 shall have the right from time to time by written notice delivered to the Office to remove any Member appointed by them and to appoint a replacement Member to fill a vacancy whether resulting from such removal or otherwise
- 14 If any of the persons entitled to appoint Members in Article 12
  - a) in the case of an individual, die or become legally incapacitated or otherwise incapable by reason of illness or injury of managing or administering their own affairs,

### NOTICE OF GENERAL MEETINGS

- General meetings shall be called by at least fourteen Clear Days' notice but a general meeting may be called by shorter notice if it is so agreed by a majority in number of Members having a right to attend and vote and together representing not less than 90% of the total voting rights at that meeting
- 21A The notice shall specify the date, time and place of the meeting and the general nature of the business to be transacted and, in the case of an annual general meeting, shall specify the meeting as such. The notice shall also state that the Member is entitled to appoint a proxy. If a special resolution is to be proposed, the notice must include the proposed resolution and specify that it is proposed as a special resolution.
- 21B The notice shall be given to all the Members, to the Governors and auditors

#### PROCEEDINGS AT GENERAL MEETINGS

- No business shall be transacted at any meeting unless a quorum is present. A Member counts towards the quorum by being present either in person or by proxy. Two persons entitled to vote upon the business to be transacted, each being a Member or a proxy of a Member or a duly authorised representative of a Member organisation shall constitute a quorum
- If a quorum is not present within half an hour from the time appointed for the meeting, or if during a meeting a quorum ceases to be present, the meeting shall stand adjourned to the same day in the next week at the same time and place or to such time and place as the Governors may determine
- The Chair, if any, of the Governors or in his or her absence some other Governor nominated by the Governors shall preside as chair of the meeting,

A resolution in writing agreed by such number of Members as required if it had been proposed at a general meeting shall be as effectual as if it had been passed at a general meeting duly convened and held provided that a copy of the proposed resolution has been sent to every Member. The resolution may consist of several instruments in the like form each agreed by one or more Members.

#### **VOTES OF MEMBERS**

The powers given by this Article shall not be limited by any special power given to the Governors by the Articles and a meeting of Governors at which a quorum is present may exercise all the powers exercisable by the Governors

A Governor must absent himself or herself from any discussions of the Governors in which it is possible that a conflict will arise between his duty to act solely in the interests of the Academy Trust and any duty or personal interest (including but not limited to any Personal Financial Interest

#### THE MINUTES

The minutes of the proceedings of a meeting of the Governors shall be drawn up and entered into a book kept for the purpose by the person acting as Clerk for the purposes of the meeting, and shall be signed (subject to the approval of the Governors) at the same or next subsequent meeting by the person acting as chair thereof

#### COMMITTEES

Subject to these Articles, the Governors may establish any committee Subject to these Articles, the constitution, membership and proceedings of any committee shall be determined by the Governors. The establishment, terms of reference, constitution and membership of any committee of the Governors shall be reviewed at least once in every twelve months. The membership of any committee of the Governors may include persons who are not Governors, provided that a majority of members of any such committee shall be Governors. The Governors may determine that some or all of the members of a committee who are not Governors shall be entitled to vote in any proceedings of the committee. No vote on any matter shall be taken at a meeting of a committee of the Governors unless the majority of members of the committee present are Governors.

#### **DELEGATION**

102 The Governors may delegate to any Governor, committee, the Head or any other holder of an executive office, such of their powers or functions as

they consider desirable to be exercised by them. Any such delegation may be made subject to any conditions the Governors may impose and may be revoked or altered

  - b) given by the Chair of the Governors or, in his or her absence or where there is a vacancy in the office of Chair, the Vice-Chair of the Governors, so far as such direction is not inconsistent with any direction given as mentioned in (a)
- 107 Any three Governors or the Chair may, by notice in writing given to the Clerk, requisition a meeting of the Governors, and it shall be the duty of the

Clerk to convene such a meeting as soon as is reasonably practicable

- 108 Each Governor shall be given at least seven Clear Days before the date of a meeting
  - a) notice in writing thereof, signed by the Clerk, and sent to each Governor at the address provided by each Governor from time to time, and
  - b) a copy of the agenda for the meeting,

provided that where the Chair or, in his or her absence or where there is a vacancy in the office of Chair, the Vice-Chair, so determines on the ground that there are matters demanding urgent consideration, it shall be sufficient if the written notice of a meeting, and the copy of the agenda thereof are given within such shorter period as he or she directs

- 109 The convening of a meeting and the proceedings conducted thereat shall not be invalidated by reason of any individual not having received written notice of the meeting or a copy of the agenda thereof
- 110 A resolution to rescind or vary a resolution carried at a previous meeting of the Governors shall not be proposed at a meeting of the Governors unless the consideration of the rescission or variation of the previous resolution is a specific item of business on the agenda for that meeting
- 111 A meeting of the Governors shall be terminated forthwith if -
  - (a) the Governors so resolve, or
  - (b) the number of Governors present ceases to constitute a quorum for a meeting of the Governors in accordance with Article 114, subject to Article 116
- 112 Where in accordance with Article 111 a meeting is not held or is

terminated before all the matters specified as items of business on the agenda for the meeting have been disposed of, a further meeting shall be convened by the Clerk as soon as is reasonably practicable, but in any event within seven days of the date on which the meeting was originally to be held or was so terminated

- 113 Where the Governors resolve in accordance with Article 111 to adjourn a meeting before all the items of business on the agenda have been disposed of, the Governors shall before doing so determine the time and date at which a further meeting is to be held for the purposes of completing the consideration of those items, and they shall direct the Clerk to convene a meeting accordingly
- 114 Subject to Article 116 the quorum for a meeting of the Governors, and any vote on any matter thereat, shall be any three Governors, or, where greater, any one third (rounded up to a whole number) of the total number of Governors holding office at the date of the meeting
- The Governors may act notwithstanding any vacancies in their number, but, if the numbers of Governors is less than the number fixed as the quorum, the continuing Governors may act only for the purpose of filling vacancies or of calling a general meeting
- 116 The quorum for the purposes of
  - a appointing a Parent Governor under Article 57,
  - b any vote on the removal of a Governor in accordance with Article 67,
  - c any vote on the removal of the Chair of the Governors in accordance with Article 91,

shall be any two-thirds (rounded up to a whole number) of the persons who are at the time Governors entitled to vote on those respective matters

117 Subject to these Articles, every question to be decided at a meeting of

the Governors shall be determined by a majority of the votes of the Governors present and voting on the question. Every Governor shall have one vote

- Subject to Articles 98 and 114-116, where there is an equal division of votes, the chair of the meeting shall have a casting vote in addition to any other vote he or she may have
- 119 The proceedings of the Governors shall not be invalidated by
  - a any vacancy among their number, or
  - b any defect in the election, appointment or nomination of any Governor
- A resolution in writing, signed by all the Governors entitled to receive notice of a meeting of Governors or of a committee of Governors, shall be valid and effective as if it had been passed at a meeting of Governors or (as the case may be) a committee of Governors duly convened and held. Such a resolution may consist of several documents in the same form, each signed by one or more of the Governors.
- 121 Subject to Article122, the Governors shall ensure that a copy of
  - a the agenda for every meeting of the Governors,
  - b the draft minutes of every such meeting, if they have been approved by the person acting as chair of that meeting,
  - c the signed minutes of every such meeting, and
  - d any report, document or other paper considered at any such meeting,

are, as soon as is reasonably practicable, made available at the Academy to persons wishing to inspect them

122 There may be excluded from any item required to be made available in pursuance of Article 121, any material relating to—

a a named Teacher or other person employed, or proposed to be employed, at the Academy,

b a named pupil at, or candidate for admission to, the Academy, and

c any matter which, by reason of its nature, the Governors are satisfied should remain confidential

123 Any Governor shall be able to participate in meetings of the Governors by telephone or video conference provided that

a he or she has given notice of his or her intention to do so detailing the telephone number on which he or she can be reached and/or appropriate details of the video conference suite from which he or she shall be taking part at the time of the meeting at least 48 hours before the meeting, and

b the Governors have access to the appropriate equipment if after all reasonable efforts it does not prove possible for the person to participate by telephone or video conference the meeting may still proceed with its business provided it is otherwise quorate

#### PATRONS AND HONORARY OFFICERS

The Governors may from time to time appoint any person whether or not a Member of the Academy Trust to be a patron of the Academy Trust or to hold any honorary office and may determine for what period he or she is to hold such office

#### THE SEAL

The Seal, if any, shall only be used by the authority of the Governors or of a committee of Governors authorised by the Governors. The Governors may determine who shall sign any instrument to which the Seal is affixed and unless otherwise so determined it shall be signed by a Governor and by the Clerk or by a second Governor.

#### **ACCOUNTS**

126 Accounts shall be prepared in accordance with the relevant Statement of Recommended Practice as if the Academy Trust was a non-exempt charity and Parts 15 and 16 of the Companies Act 2006 and shall file these with the Secretary of State and the Principal Regulator by 31 December each Academy Financial Year

### ANNUAL REPORT

127 The Governors shall prepare its Annual Report in accordance with the Statement of Recommended Practice as if the Academy Trust was a non-exempt charity and shall file these with the Secretary of State and the Principal Regulator by 31 December each Academy Financial Year

#### ANNUAL RETURN

The Governors shall comply with their obligations under Part 24 of the Companies Act 2006 (or any statutory re-enactment or modification of that Act) with regard to the preparation of an annual return to the Registrar of Companies and in accordance with the Statement of Recommended Practice as if the Academy Trust was a non-exempt charity and to the Secretary of State and the Principal Regulator by 31 December each Academy Financial Year

### **NOTICES**

- Any notice to be given to or by any person pursuant to the Articles (other than a notice calling a meeting of the Governors) shall be in writing or shall be given using electronic communications to an Address for the time being notified for that purpose to the person giving the notice. In these Articles, "Address" in relation to electronic communications, includes a number or address used for the purposes of such communications.
- 130 A notice may be given by the Academy Trust to a Member either personally or by sending it by post in a prepaid envelope addressed to the Member at his or her registered address or by leaving it at that address or by

giving it using electronic communications to an Address for the time being notified to the Academy Trust by the Member. A Member whose registered address is not within the United Kingdom and who gives to the Academy Trust an address within the United Kingdom at which notices may be given to him or her, or an Address to which notices may be sent using electronic communications, shall be entitled to have notices given to him or her at that address, but otherwise no such Member shall be entitled to receive any notice from the Academy Trust

- Academy Trust shall be deemed to have received notice of the meeting and, where necessary, of the purposes for which it was called
- 132 Proof that an envelope containing a notice was properly addressed, prepaid and posted shall be conclusive evidence that the notice was given Proof that a notice contained in an electronic communication was sent in accordance with guidance issued by the Institute of Chartered Secretaries and Administrators shall be conclusive evidence that the notice was given A notice shall be deemed to be given at the expiration of 48 hours after the envelope containing it was posted or, in the case of a notice contained in an electronic communication, at the expiration of 48 hours after the time it was sent

#### INDEMNITY

Subject to the provisions of the Companies Act 2006 every Governor or other officer or auditor of the Academy Trust shall be indemnified out of the assets of the Academy Trust against any liability incurred by him or her in that capacity in defending any proceedings, whether civil or criminal, in which judgment is given in favour or in which he or she is acquitted or in connection with any application in which relief is granted to him or her by the court from liability for negligence, default, breach of duty or breach of trust in relation to the affairs of the Academy Trust

#### RULES

- The Governors may from time to time make such rules or bye laws as they may deem necessary or expedient or convenient for the proper conduct and management of the Academy Trust and for purposes of prescribing classes of and conditions of membership, and in particular but without prejudice to the generality of the foregoing, they may by such rules or bye laws regulate
  - a the admission and classification of Members of the Academy Trust (including the admission of organisations to membership) and the rights and privileges of such Members, and the conditions of membership and the terms on which Members may resign or have their membership terminated and the entrance fees, subscriptions and other fees or payments to be made by Members,
  - b the conduct of Members of the Academy Trust in relation to one another, and to the Academy Trust's servants,
  - c the setting aside of the whole or any part or parts of the Academy Trust's premises at any particular time or times or for any particular purpose or purposes,
  - d the procedure at general meetings and meetings of the Governors and committees of the Governors in so far as such procedure is not regulated by the Articles, and
  - e generally, all such matters as are commonly the subject matter of company rules
- The Academy Trust in general meeting shall have power to alter, add or to repeal the rules or bye laws and the Governors shall adopt such means as they think sufficient to bring to the notice of Members of the Academy Trust all such rules or bye laws, which shall be binding on all Members of the Academy Trust Provided that no rule or bye law shall be inconsistent with, or shall affect or repeal anything contained in the Articles

#### AVOIDING INFLUENCED COMPANY STATUS

- 136 Notwithstanding the number of Members from time to time, the maximum aggregate number of votes exercisable by Local Authority Associated Persons shall never exceed 19 9% of the total number of votes exercisable by Members in general meeting and the votes of the other Members having a right to vote at the meeting will be increased on a pro-rata basis
- 137 No person who is a Local Authority Associated Person may be appointed as a Governor if, once the appointment had taken effect, the number of Governors who are Local Authority Associated Persons would represent 20% or more of the total number of Governors. Upon any resolution put to the Governors, the maximum aggregate number of votes exercisable by any Governors who are Local Authority Associated Persons shall represent a maximum of 19 9% of the total number of votes cast by the Governors on such a resolution and the votes of the other Governors having a right to vote at the meeting will be increased on a pro-rata basis
- No person who is a Local Authority Associated Person is eligible to be appointed to the office of Governor unless his or her appointment to such office is authorised by the local authority to which he or she is associated
- 139 If at the time of either his or her becoming a Member of the Academy Trust or his or her first appointment to office as a Governor any Member or Governor was not a Local Authority Associated Person but later becomes so during his or her membership or tenure as a Governor he or she shall be deemed to have immediately resigned his or her membership and/or resigned from his or her office as a Governor as the case may be
- 140 If at any time the number of Governors or Members who are also Local Authority Associated Persons would (but for Articles 136 to 139 inclusive) represent 20% or more of the total number of Governors or Members (as the case may be) then a sufficient number of the Governors or Members (as the case may be) who are Local Authority Associated Persons shall be deemed to have resigned as Governors or Members (as the case may be) immediately

before the occurrence of such an event to ensure that at all times the number of such Governors or Members (as the case may be) is never equal to or greater than 20% of the total number of Governors or Members (as the case may be) Governors or Members (as the case may be) who are Local Authority Associated Persons shall be deemed to have resigned in order of their appointment date the most recently appointed resigning first

141 The Members will each notify the Academy Trust and each other if at any time they believe that the Academy Trust or any of its subsidiaries has become subject to the influence of a local authority (as described in section 69 of the Local Government and Housing Act 1989)
