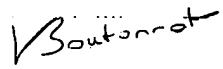
For the year ended 31 December 2020 the company was entitled to exemption under section 480 of the Companies Act 2006 relating to dormant companies.

1. General Information

Lightsource SPV 151 Limited is a private company limited by shares incorporated and domiciled in England in the United Kingdom (registered number 08925153). The registered office is 7th Floor 33 Holborn, London, England, EC1N 2HU.
