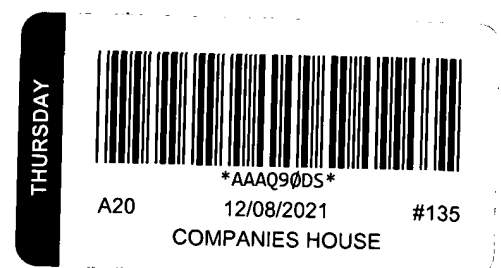

D Smith was appointed as director on 06 May 2020.

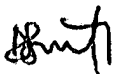
The company is limited by guarantee and therefore has no share capital.

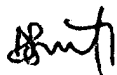

Notes to the Financial Statements for the Year Ended 30 November 2020

1. ACCOUNTING POLICIES

Basis of preparation

The company is incorporated in the United Kingdom under the Companies Act 2006. The company's financial statements have been prepared in accordance with Section 1A "Small Entities" of FRS 102 'Financial Reporting Standard applicable in the UK and Republic of Ireland' as issued by the Financial Reporting Council.

The preparation of financial statements in conformity with Section 1A "Small Entities" of FRS 102 requires the use of certain critical accounting estimates. It also requires management to exercise its judgement in the process of applying the company's accounting policies. During the period there were no areas involving a higher degree of judgement or complexity, or areas where assumptions and estimates are significant to the financial statements.

Going concern

The company has satisfactory financial resources to fulfil the requirements of the principal activity. As a consequence, the directors believe that the company is well placed to manage its business risks successfully despite the current uncertain economic outlook. After making enquiries, the directors have a reasonable expectation that the company has adequate resources to continue in existence for the foreseeable future. In doing so, the directors have considered the latest guidelines from the Financial Reporting Council regarding the preparation of financial statements on a going concern basis.

2. PROFIT AND LOSS ACCOUNT

The company had no employees or staff costs for the current financial year or the prior financial year.

None of the directors received any remuneration during the current financial year and the prior financial year. The remuneration of the directors is paid by other group undertakings for both the current financial year and the prior financial year and no part of their remuneration is specifically attributable to their services to this company.

The company did not trade during the year and there are no gains or losses to be recognised during the year.

3. LIMITED BY GUARANTEE

The liability of the members is limited. Every member promises if the company is dissolved while he or she is a member or within twelve months after he or she ceases to be a member, to contribute such sum (not exceeding £1) as may be demanded of him or her towards payments of the debts and liabilities of the company incurred before he or she ceases to be a member, and the costs charges and expenses of winding up, and the adjustment of the rights of the contributories among themselves.
