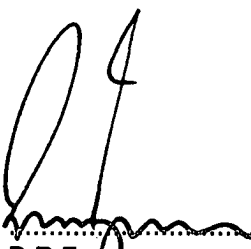

NOTES TO THE ABBREVIATED ACCOUNTS FOR THE YEAR ENDED 30 APRIL 2016

1. ACCOUNTING POLICIES

1.1 Basis of preparation of financial statements

The full financial statements, from which these abbreviated accounts have been extracted, have been prepared under the historical cost convention and in accordance with the Financial Reporting Standard for Smaller Entities (effective January 2015).

1.2 Going concern

As at 30th April 2016 the company had net liabilities of £207,553. The directors have prepared the financial statements on a going concern basis as the parent undertaking of the company has undertaken to provide financial support to the company as and when required, to ensure the company remains a going concern for at least 12 months from the date of approval of these financial statements.

1.3 Stocks

Stocks of properties are valued at the lower of cost and net realisable value. Cost includes all costs incurred in acquiring the properties.
