
RESPECTIVE RESPONSIBILITIES OF DIRECTORS AND AUDITOR



NOTES TO THE ABBREVIATED ACCOUNTS FOR THE 1 MONTH PERIOD ENDED 30 APRIL 2014

1. ACCOUNTING POLICIES

1.1 Basis of preparation of financial statements

The full financial statements, from which these abbreviated accounts have been extracted, have been prepared under the historical cost convention and in accordance with the Financial Reporting Standard for Smaller Entities (effective April 2008).

1.2 Going concern

As at 30th April 2014 the company had net liability of £1,100. The directors have prepared the financial statements on a going concern basis as the present undertaking of the company has undertaken to provide financial support to the company as and when required, to ensure the company remains a going concern for at least 12 months from the date of approval of these financial statements.

2. ULTIMATE PARENT UNDERTAKING AND CONTROLLING PARTY

The company's immediate parent undertaking is Knightsbridge Central (9) Limited. The company's ultimate parent undertaking and controlling party is Lancer Property Holdings Limited, a company incorporated in England and Wales.

The largest and smallest group of undertakings for which consolidated financial statements are prepared is that headed by Lancer Property Holdings Limited. These are publicly available from: Companies House, Crown Way, Cardiff, CF14 3UZ

The company has taken advantage of exemptions offered under Financial Reporting standard No 8 from disclosing related party transactions with group companies on the basis that 100% of the company's voting rights are controlled by Lancer Property Holdings Ltd.
