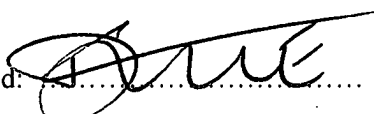
For the period from 01 May 2020 to 30 April 2021 the Company was entitled to exemption under section 480 of the Companies Act 2006.
