Structure, Governance and Management

The charity is a private company, limited by guarantee, as defined by the Companies Act 2006.

The company is governed by it's Memorandum and Articles of Association, amended by special resolution at Companies House May 2016.

Structure, Governance and Management continued

The charity's policies and direction are set by the Board of Trustees who meet regularly throughout the year. There is also regular communication by email and telephone, and with informal sub-group meetings.

The Trustees have a duty to identify and review risks to which the charity may be exposed, and to ensure appropriate controls are in place to provide reasonable assurance against fraud and error. Risks to which the charity is exposed have been identified and are regularly monitored.

The Trustees are responsible for complying with the guidance of the Charity Commission on public benefit when performing their duties and confirm that they have done this.

Overview

Sibes and Sled Dogs Husky Welfare (SASD) is a dog rescue dealing with the rescue, rehoming and research of Siberian Huskies, Alaskan Malamute and other associated breeds. The rescue was initially established in January 2012 by John Duxbury.

SASD gained Registered charity status on 10th May 2016.

Objectives

Sibes and Sled Dogs Husky Welfare was established as a charity with the following objects:

"To promote humane behaviour towards animals by rescuing, researching, rehabilitating and rehoming sled dog breeds which are in need of care and attention by reason of sickness, maltreatment, poor circumstances or ill usage and to educate the public in matters pertaining to animal welfare and prevention of cruelty and suffering".

Activities

We have dedicated kennels that we rent, providing emergency kennelling for up to 8 dogs, and rely heavily on a network of foster homes across the UK.

Land is rented from Pendle Borough Council for a nominal amount, this has enabled us to provide an off lead area, a running track and memorial area which is used for a variety of fund raising events from weekly walks to our annual fundraising Funday.

We have an annual "away camp" and organise other walks and events to raise awareness of the breed and the responsibilities of owning such dogs and also to raise the profile of the charity and take the opportunity to fundraise.

We also attend throughout the year various fundraising and awareness events including our attendance at fundays, galas, festivals, open days etc.

Our Trustees and Admin Team

Christine Duxbury: Director

Co-founder and widow of John Duxbury, currently works at Lancashire County Council as a driver for young people and adults with special needs to school/day centres. Support worker for adults with special needs and the elderly. Support with anything and everything, mainly land, events and merchandise but time permitting will support any area as will all of us.

Angela Hornby: Director

Social Work Manager for Children's services. Volunteer for events and fund raising, home checking, camp activity organiser, transporting and collection of dogs and support at land and off lead.

Cameron Firth: Trustee

Been involved with SASD since John started the rescue, help with the kennels, transport runs, support at events and land.

Sammie Widdup: Trustee

Works in retail locally, helps with merchandise, land, kennels and events.

Steve Moss: Trustee

Stay at Home Dad. 24 hour SASD emergency phone, hands on with dogs and events. Anything and everything that I can do to support the rescue and this wonderful dog breed.

lan Hornby: Admin

Factory Manager. Volunteer for events and fund raising, camp activity organiser, transporting and collection of dogs and support at land and off lead.

Jenny Montgomery: Admin

I am based in Scotland and have a background in Management Consultancy and customer service. I started as admin with SASD managing the chip changes and gradually started to focus on Scotlish operations, booking events, transport and home checks in Scotland and working on business development in Scotland.

David Gilder: Admin

Based in Hyde, Greater Manchester. I am a Radio Operator/Dispatcher for Greater Manchester Police. I became involved with SASD through a work friend initially, adopted Blue in 2014 and attended events and open days when able. In 2018 I took on the job of updating and redesigning the website and furthered my role in late 2019 by becoming a full Admin.

Sue Mullally: Event Co-ordinator

I am employed as a Customer Service Operative for Kutchenhaus a German kitchen company. Dealing with customer complaints and ordering parts to complete fittings. I worked for The Trafford Centre with the events team for 15 years. With SASD I book and co-ordinate events for us to fundraise and promote our Fostering and Adoption programme.

Tracey Craig: Admin

Fundraiser, homechecker, helper homecheck database. Currently a stay at home mum and carer for my grandchild. Formerly a house keeper/cleaner for several companies. I have been involved within animal rescue for 8 years. I joined SASD in 2014 as a homechecker but my aim was to become much more. My focus was and is to help as many of these poor dogs as I can. I help raise funds by doing online auctions and live camp auctions. I use any spare time to email companies for donations. I became Admin in 2019 and hope to continue to be a good asset to this wonderful rescue.

Amanda Peters: Admin

I currently work in the Adult Services Finance Team at Cheshire East Council. My team and I support approximately 400 elderly and vulnerable clients with their finances, as they are unable to do this themselves. I got involved with SASD in October 2016 when we went to the land with Loki, our first sled dog. In 2017 we fostered, then adopted, Xena from SASD to join Loki and our other sled dog Luna. The whole family gets involved in events, helping to raise funds for the rescue and to spread awareness of the breed as much as possible.

Emma Hall: Admin

Full Time Self Employed Private Carer, working in the care industry for 9 years. I have supported SASD for the last 8 years, assisting with home checks, live and online auctions and other fundraising.

Number of Trustees

The current trustees are happy to continue with their roles and charity is actively looking to appoint additional trustees.

Report of the Trustees for the year ended 31st May 2020

Fundraising and Support

Our main sources of income are fundraising activities, donations and voluntary adoption fees for dogs we rehome. We also have a number of merchandise items for sale through our website shop.

In the year we attended numerous events in and around East/West Lancashire to raise the awareness of the breed and the specific requirements of ownership. We fundraise in a number of ways and event attendance is primarily a fund raiser/awareness raising activity.

Events attended cover schools, petting sessions at local Care Homes and as many local open days and county fairs as possible. Our priorities here are two-fold, to spread awareness but also to raise funds by selling merchandise, tombola stall, raffle etc.

We have an active and informative website and a Facebook page with over 5,000 likes and followers.

Achievements and Performance

During the year we have supported owners to enable them to be more confident and more equipped to address the need of their dog, by offering support and guidance, by the way of telephone consultation, email enquiries through general enquiries by way of our facebook page and indeed in person.

47 dogs have been rescued this year, and we have assisted in helping approximately 100 dogs stay in their homes. Due to the loss of our kennels in late 2019 we struggled to bring in as many dogs as we would like due to the shortage of suitable foster homes.

As a rescue we work very closely with other sled dog rescues in order to ensure that any larger and more challenging rescue projects are tackled in a coordinated manner in the best interests of all dogs involved.

We as a rescue are very fortunate to work very closely with our local Pets At Home store which includes the rescue being registered with Vets4Pets.

This enables us to hold instore fundraising events which the rescue attends with some of our dogs and in turn they readily support us by attending and running/judging a fun dog show at our annual, in addition to supporting us with food donations to support our resident dogs in our kennels.

Our Euthanasia Policy

It is the policy of SASD to not euthanise any dog without the express recommendation from a Veterinary Surgeon. We work with dogs with all manner of issues, food guarding, aggression, separation anxiety etc and when we feel they are ready to be rehomed we spend time searching for the right home, making sure that the adopting home is fully aware of any previous issues and triggers.

Report of the Trustees for the year ended 31st May 2020

Financial Review

During the year the charity received income in excess of £46,000 (2019 £37,000).

This included a donation of £20,000 from Support Adoption For Pets as a contribution to the purchase of a new vehicle and associated equipment, to be used for the transporting of dogs.

COVID restrictions delayed matters but a fully fitted out vehicle was eventually purchased for £12,655 in July 2020.

The donor permitted the fund balance to be held as unrestricted funds to help the charity throughout the pandemic period.

Spending included a total of £14,157 on dog welfare, kennel expenditure and vets fees.

Get togethers for sled dog owners cost £2,713, this cost being offset by donations received from attendees.

A donation of £500 was paid to Loving Homes Dog Sanctuary who re-homed 4 of our dogs in the period.

Reserves Policy

The Trustees review the level of reserves on a regular basis to ensure that the appropriate levels are maintained to finance the day to day operations of the charity.

At present reserves are sufficient to manage our regular activities. Should a position be achieved where excess reserves are held then initially these would be held in a separate account and used for vets bills.

Going Concern

The trustees confirm that the financial statements have been prepared on a going concern basis.

Future Plans

First and foremost our aim is to support more dogs into rescue and into forever homes.

We aim to continue to raise awareness amongst more communities and individuals, including exploring ways of attracting corporate and small business sponsorship.

We will continue to attend appropriate events and fetes and use social media to interact with and gain new followers, volunteers and donors.

We also intend to further develop our off lead area and improve facilities available within it for the use of dogs living within reasonable travelling distance from our base.

Unfortunately, in common with many other organisations, our ability to attend events and hold activities has been affected badly by the COVID pandemic since April 2020.

Basis of preparation

These accounts have been prepared under the historical cost convention with items recognised at cost or transaction value unless otherwise stated in the relevant note(s) to these accounts.

The accounts have been prepared in accordance with:

the Statement of Recommended Practice: Accounting and Reporting by Charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) - Charities SORP (FRS 102) (effective January 2015) - the Financial Reporting Standard applicable in the United Kingdom and Republic of Ireland (FRS 102) and the Companies Act 2006.

Company Status

The company is a private company limited by guarantee and consequently does not have share capital.

Accounting policies

Recognition of income

These are included in the Statement of Financial Activities (SoFA) when:

the charity becomes entitled to the resources;

it is more likely than not that the trustees will receive the resources;

the monetary value can be measured with sufficient reliability.

Grants and donations

Grants and donations are only included in the SoFA when the general income recognition criteria are met.

During the year a grant of £20,000 was received from Support Adoption For Pets to purchase a new vehicleand associated equipment. This was purchased at a cost of £12,655 after the end of the accounting year, the delay in purchase being caused by COVID restrictions.

The balance of funds remaining has been permitted to be used for unrestricted purposes by the donor.

Volunteer help

The value of any voluntary help received is not included in the accounts but is described in the trustees' annual report.

Expenditure and liabilities

Liabilities are recognised where it is more likely than not that there is a legal or constructive obligation committing the charity to pay out resources and the amount of the obligation can be measured with reasonable certainty.

Taxation

The charity is a registered charity and is therefore exempt from taxation.

Assets

Tangible fixed assets for use by charity are capitalised if they can be used for more than one year and cost at least £50. They are valued at cost and depreciation is provided at an annual rate of 15% written down value.

Stocks

Goods or services provided as part of a charitable activity are measured at cost.

Fund Accounting

Unrestricted funds can be used in accordance with the charitable objectives at the discretion of the trustees.

Trustee's Remuneration, Benefits and Expenses

There were no trustees' remuneration or other benefits for the year ended 31st May 2020.

Trustee's were occasionally reimbursed for small basic meal costs whilst on long journeys to collect or deliver dogs.

Related Party Transactions

There have been no related party transactions in the reporting period.
