1 Statutory information

Presentation currency

Effective November 1, 2021, the Company adopted the US dollar as its functional currency. Prior to November 1, 2021, the functional currency of the Company was the Pound Sterling.

The change in the functional currency of the Company is due to the increased exposure to the US dollar as a result of the growth in international operations.

The Company's financial results have been reported in Pound Sterling. Profit and loss have been computed in US dollars and translated into Pound Sterling at the average exchange rate for the year £1:\$1.2369.
