

ORDER

UPON THE APPLICATION for a Block Transfer Order by Application Notice dated 17 May 2022

AND UPON reading the evidence filed in support of the Application

AND UPON Graham Stuart Wolloff consenting to be removed from office as the joint insolvency officeholder in respect of the cases referred to in the Application and annexed to this Order as Schedule B

AND UPON Joseph Gordon Maurice Sadler consenting to be removed from office as the joint insolvency officeholder in respect of the cases referred to in the Application and annexed to this Order as Schedule C

AND UPON THE COURT being satisfied that it is expedient to transfer all of the cases listed in Schedule A in which Graham Stuart Wolloff and Joseph Gordon Maurice Sadler (the "Outgoing Officeholders") hold office to the Second Respondent in one single order

IT IS ORDERED THAT:-

- 1. Each of the cases listed in Schedule D (attached to this application) be transferred to the High Court of Justice, Business and Property Courts of England and Wales, Insolvency and Companies List (ChD) for the purpose only of making this order and are immediately thereafter retransferred.
- 2. Graham Stuart Wolloff be removed from office in respect of each of the cases listed in Schedule B (attached to this order) from the date of this order and be replaced by Steven Illes.
- 3. Joseph Gordon Maurice Sadler be removed from office in respect of the cases listed in Schedule C (attached to this order) from the date of this order and be replaced by Steven Illes.
- 4. In respect of each of the matters listed in Schedule A (the "Block Transfer Cases"), the creditors shall be notified of this order either by letter or by advertisement published in the

London Gazette within 3 months of this order and the Applicants are required to advertise the transfer of the Block Transfer Cases in any event within 3 months.

5. Any creditor or, in the case of any members' voluntary liquidation, any member, in respect of any of the companies listed in Schedule A who has an objection to this order shall have 56 days from the date of this letter or advertisement to apply to the court to set aside or vary the terms of this order. The time period shall run from two business days after the letter is posted or from the date of advertisement, whichever is the later. Such application shall not affect the transfer of the Block Transfer Cases listed in Schedule A until further or other order by the court.

6. The replacement officeholder appointed further to paragraphs 2 to 3 of this order shall give notice of the terms of this order to the Secretary of State and the Registrar of Companies in respect of the liquidations and voluntary arrangements listed in Schedule A and any person who jointly holds office with the Outgoing Officeholders as soon as reasonably practicable.

7. Nothing in this order shall release the Outgoing Officeholders from any obligation to give and file notices in respect of their removal under this order concerning the Block Transfer Cases listed in Schedule A.

8. The Outgoing Officeholders shall have their release upon application to the Secretary of State.

9. There be No Order as to costs.
