Articles of Association

Objectives:

- To give relief and assistance to all persons whose disabilities were caused by the fact that during their mothers pregnancy she had taken a medication known as or used as an Anti-Convulsant to treat their condition, by means of the Pharmaceutical company who manufactured that compound.
- To support by means of paying such sums of money to the victims of Fetal Anti-Convulsant Syndrome for the care, welfare, treatment and/or education to help and support them with relief of their injuries where deposited by grants through Government funding and/or Pharmaceutical companies.
- With intentions to pay such sums of money to help or for the care, welfare, treatments and/or education of people affected submitted through Government and/or Pharmaceutical Company donations.
- 4. To become actively involved in campaigning for Government awareness and redress.

Powers

- 5. The Trust will be a not for profit organisation with any monies raised through fund raising events, donations or Grants being used solely towards the running of the Trust and to enable it to continue its work.
- 6. The main aim of the trust is to help financially support those who have been affected by Fetal Anti-Convulsant Syndrome and this will be this will be made possible by meetings to ensure co-operation with the drug companies involved and with Government Bodies.

Committee

- 7. The Trustees of IN-FACT shall be made from the 2 Co-Founders and one other until such times as the board, must become a selection of professionals needed to cover each topic experienced by the sufferers of Fetal Anti-Convulsant Syndrome.
- 8 The Committee will become, and will continue to be, the campaigners for IN-FACT.
- 9. Trustees shall meet together at least 3 times per calendar year and more frequently if necessary, by either telephone conference, webcam or in person.
- 10. Trustees may hold office for 5 years maximum and then must stand down, reapplying for their position if they wish.

Membership

- 11. Beneficiaries shall be persons within the UK and who were born and/or suffer from any congenital disability, whether physical and/or mental, with a diagnosis of a Fetal Anti-Convulsant Syndrome (Covering all compounds known as or used as an Anti-Convulsant).
- 12. Members will be added to the INFACT Database where their details will be held private & confidential allowing INFACT to contact them with an update on the work of the trust.
- 13. The database will allow INFACT to contact the families with information concerning any financial support available at the point of time.
- 14. Any person who is parent/carer for a child/person with Fetal Anti-Convulsant Syndrome can join the database and there will be no charge to do so.

Dissolution

- (15) The members of the charity may at any time before, and in expectation of, its dissolution resolve that any net assets of the charity after all its debts and liabilities have been paid, or provision has been made for them, shall on or before the dissolution of the charity be applied or transferred in any of the following ways:
 - (a) directly for the Objects, or
 - (b) by transfer to any charity or charities for purposes similar to the Objects; or
 - (c) to any charity or charities for use for particular purposes that fall within the Objects.
- (16) Subject to any such resolution of the members of the charity, the directors of the charity may at any time before and in expectation of its dissolution resolve that any net assets of the charity after all its debts and liabilities have been paid, or provision made for them, shall on or before dissolution of the charity be applied or transferred:
 - (a) directly for the Objects; or
 - (b) by transfer to any charity or charities for purposes similar to the Objects; or
 - (c) to any charity or charities for use for particular purposes that fall within the Objects.
