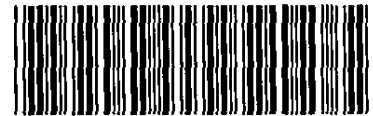

With respect to ICAP Securities Limited, ICAP Europe Limited, ICAP Energy Limited, ICAP Global Derivatives Limited, ICAP WCLK Limited and The Link Assets and Securities Company Limited, the Financial Services and Markets Act 2000 (the "FSMA") and the FRC handbook require PwC to notify the FCA without delay of our ceasing to hold office as auditors. The FSMA also requires PwC to notify the FCA of any matters connected with our ceasing to hold office that we think ought to be drawn to the FCA's attention or that there are no such matters The FCA handbook also requires the Companies to notify the FCA that we have ceased to hold office as auditor, together with reasons for this

If you have any concerns as to how the Companies and their directors should meet their obligations then we recommend that you seek legal advice
