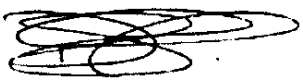

ORDER

BEFORE District Judge *Bever* sitting in chambers on *22 March 2018*

UPON the application of the Applicants dated *15* March 2018 for a block transfer order

AND UPON READING the papers on the court file recorded as having been read

IT IS ORDERED THAT:

1. Ryan Kevin Grant (the "**outgoing officeholder**") be removed from office in respect of each of the cases listed in the Schedule (the "**block transfer cases**") from the date of this order.

4. Daniel Imison (the **"first replacement officeholder"**) be appointed as joint replacement officeholder in respect of each of the block transfer cases listed in Part 1 of the Schedule from the date of this order.
3. Mark Nicholas Cropper (the **"second replacement officeholder"**) be appointed as joint replacement officeholder in respect of each of the block transfer cases listed in Part 2 of the Schedule from the date of this order.
4. Kevin James Coates (the **"third replacement officeholder"**) be appointed as joint replacement officeholder in respect of each of the block transfer cases listed in Part 3 of the Schedule from the date of this order.
5. The creditors in each of the block transfer cases shall be notified of this order by one composite advertisement published in the London Gazette within 21 days from the date of this order.
6. Any creditor, or, in the case of any members' voluntary liquidation, any member, in respect of any of the companies listed in the Schedule who has an objection to this order shall have 21 days from the date of the publication of the advertisement to apply to court to set aside or vary the terms of this order. Such application shall not affect the transfer of the block transfer cases listed in the Schedule unless otherwise ordered by the court.
7. The replacement officeholder shall give notice to the Secretary of State and the Registrar of Companies in respect of the liquidations and administrations listed in the Schedule of the terms of this order as soon as reasonably practicable.
8. The outgoing officeholder shall file a copy of this order with each of the courts listed in the Schedule.
9. Nothing in this order shall release the outgoing officeholder from any obligation to give and file notices in respect of his removal under this order in respect of the block transfer cases listed in Part 4 of the Schedule.
10. The outgoing officeholder shall receive his release as administrator, liquidator or supervisor 21 days after filing notice of his removal with the Registrar of Companies, save that such release may be subject to further order in the event of an application by any creditor or member under paragraph 6 of this order for the specific case subject to that application.
11. The costs of this application shall be paid as an expense and shall be apportioned equally between each of the block transfer cases (where sufficient funds are available) so that the estate of each block transfer case shall bear an equal proportion of the costs. If in any of the cases listed in the Schedule there are insufficient funds to bear that case's ostensible share of the costs, the replacement office holder may apportion that case's share of the cost among the other cases listed in the Schedule in his discretion.
