1. That the share capital of the Company be reduced by cancelling and extinguishing for no consideration the following shares:

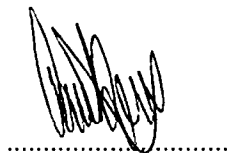

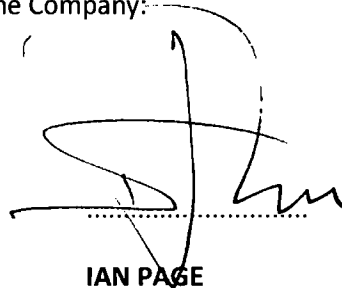
2.1 the Solvency Statement was made not more than 15 days before the date on which the special resolution approving the Capital Reduction was passed; and
